## **RESOLUTION**

WHEREAS, Columbus County Interagency Transportation, Incorporated

(CCIT) is in a facility that is prone to flooding, especially during hurricanes;

WHEREAS, CCIT keeps their vans in an unprotected parking lot where vandalism occurs at night and weekends causing extra expense for the repair of these vans;

WHEREAS, the North Carolina Department of Transportation, Public Services Division, has a total of five hundred thousand and 00/100 (\$500,000.00) dollars available for facility construction. This covers every county in the State for FY 2000-2001. CCIT has requested two hundred fifty thousand and 00/100 (\$250,000.00) dollars for a transportation facility. This represents half of the department's construction budget for the year;

WHEREAS, Columbus County is a disaster prone area from hurricanes. Funds for a disaster facility, costing five hundred thousand and 00/100 (\$500,000.00) dollars, has been requested from the Department of Transportation Division, Aviation Division. This facility would be built at the Columbus County Airport along with the transportation facility and would be available for disaster crews, providing offices, sleeping quarters and storage area for disaster related supplies.

WHEREAS, the outlook for these funds are not very likely in the near future. The Columbus County Commissioners request the aid of the local elected State legislative officials to help in the speedy procurement of the needed funds to aid Columbus County in obtaining these two (2) needed facilities.

NOW, THEREFORE, BE IT RESOLVED, we, the Columbus County Commissioners do hereby endorse the request for funding to the Columbus County Interagency Transportation to obtain facilities for the Columbus County Interagency Transportation and Columbus County Airport.
