COLUMBUS COUNTY FARMER'S MARKET - REQUEST AND APPROVAL FOR A PERMANENT SITE

Milton Parker, Agriculture Extension Agent, updated the Board on the growth of the Columbus County Farmer's Market and reported the Farmer's Market Site Selection Committee is requesting support from the Board in obtaining a permanent site on county-owned property located adjacent to Highway 701 By-pass, north of Highway 74-76.

There was a lengthy discussion regarding the site for the Farmer's Market with the Farmer's Market Committee and the Board and it was suggested that the Farmer's Market Site Selection Committee consider the county property on 701 Business behind the Farm Services and Social Services Building, as well as the 701 By-pass property.
