PUBLIC HEARING - FINANCING OF REVENUE BONDS FOR KROY BUILDING PRODUCTS

Chairman Norris called the Public Hearing to order regarding the intention of the Industrial Facilities and Pollution Control Financing Authority to submit to the Department of Commerce an application for approval of a project to issue qualified small industrial revenue bonds in the aggregate principal amount not exceeding seven million dollars (\$7,000,000) for the financing of Kroy Building Products, for the manufacturing of vinyl products. 1

Chairman Norris requested comments from anyone present who were for or against the authorizing of industrial revenue bonds for the financing of Kroy Building Products.

James E. Hill, Jr., County Attorney, representing the Industrial Facilities and Pollution Control Financing Authority, spoke on behalf of the Authority and stated the Kroy Building Products is the manufacturer of vinyl fencing and decking and will be located in the Owens-Corning Building in Fair Bluff, NC. Mr. Hill reported if Kroy Building Products defaults on the industrial revenue bonds, the County will not be held responsible. The County only has to approve the application.

COLUMBUS COUNTY LAW ENFORCEMENT CENTER

WHEREAS, the County has previously determined to undertake a project for renovations to the Columbus County Law Enforcement Center and the County Finance Director has now presented a proposal for the financing of such Project.

BE IT THEREFORE RESOLVED, as follows:

- The County hereby determines to finance the Project through Branch Banking and Trust Company ("BB&T"), in accordance with the proposal dated August 24, 2000. The amount financed shall not exceed two million five hundred thousand and 00/100 (\$2,500,000.00) dollars, the annual interest rate (in the absence of default or change in tax status) shall not exceed five and 89/100 (5.89%) percent, and the financing term shall not exceed fifteen (15) years from closing.
- 2. All financing contracts and all related documents for the closing of the financing (the "Financing Documents") shall be consistent with the foregoing terms. All officers and employees of the County are hereby authorized and directed to execute and deliver any Financing Documents, and to take all such further action as they may consider necessary or desirable, to carry out the financing of the Project as contemplated by the proposal and this resolution. The Financing Documents shall include a Financing Agreement and Deed of Trust and Escrow Agreement as BB&T may request.
- 3. The County Finance Director is hereby authorized and directed to hold executed

copies of the Financing Documents until the conditions for the delivery of the Financing Documents have been completed to such officer's satisfaction. The County Finance Director is authorized to approve changes to any Financing Documents previously signed by County officers or employees, provided that such changes shall not substantially alter the intent of such documents or certificates from the intent expressed in the forms executed by such officers. The Financing Documents shall be in such final forms as the County Finance Director shall approve, with the County Finance Director's release of any Financing Document for delivery constituting conclusive evidence of such officer's final approval of the Document's final form.

- 4. The County shall not take or omit to take any action, the taking or omissions of which will cause its interest payments on this financing to be includable in the gross income for federal income tax purposes of the registered owners of the interest payment obligations. The County hereby designated its obligations to make principal and interest payments under the Financing Documents as "qualified tax-exempt obligations" for the purpose of Interval Revenue Code Section 265(b)(3).
- 5. All prior actions of County officers in furtherance of the purposes of this resolution are hereby ratified, approved and confirmed. All other resolutions (or parts thereof) in conflict with this resolution are hereby repealed, to the extent of the conflict. This resolution shall take effect immediately.

After said proceedings had been considered and reviewed by the Board of Commissioners, Commissioner C.E. Wilson introduced the following resolution which was read:

BE IT RESOLVED by the Board of Commissioners for the County of Columbus: **Section 1.** The Board of Commissioners for the County of Columbus having received from the Columbus County Board of Elections a certified copy of the proceedings of said Board of Elections taken on October 6, 2000, evidencing said Board's determination of the result of the canvass of the returns of the special bond referendum held in the Columbus County Water and Sewer District III on October 3, 2000 upon the question of approving \$6,571,000 Water Bonds of said District, does hereby declare and certify the result of said referendum to be the result which is set forth in the following statement of the result of said referendum, which statement has been prepared by said Board of Commissioners:

At a special bond referendum held in the Columbus County Water and Sewer District III on October 3, 2000, 2992 voters were registered and qualified to vote.

At said referendum 431 votes were cast for the order adopted on August 7, 2000, authorizing not exceeding \$6,571,000 Water Bonds of the Columbus County Water and Sewer District III, in Columbus County, North Carolina, for the purpose of providing funds, with any other available funds, for constructing a water system of said District, within and without the corporate limits of said District, including the construction and installation of wells, water treatment facilities, an elevated water storage tank, water mains and lines and appurtenant facilities, and the acquisition of necessary land, rights of way and equipment, and authorizing the levy of taxes in an amount sufficient to pay the principal of and the interest on said bonds, and 36 votes were cast against said order, and a majority of the qualified voters of said District who voted thereon at said referendum voted in favor of said order.

Extract of minutes of a public hearing on the qualified small issue industrial revenue bond issue to finance a project for Kroy Building Products, Inc., subsequent approval of the issuance of not exceeding \$7,000,000 aggregate principal amount of qualified small issue industrial revenue bonds of The Columbus County Industrial Facilities and Pollution Control Financing Authority to finance the project and approval of the project and a resolution requesting the Secretary of the Department of Commerce to approve the project, notwithstanding that the operator will not pay an average weekly manufacturing wage paid in the County of Columbus.

The Board of Commissioners for the County of Columbus, North Carolina, met in regular session in the Courthouse Annex, 112 W. Smith Street, Whiteville, North Carolina, the regular place of meeting, at 7:30 p.m., on October 16, 2000.

Also Present: James E. Hill, Jr., County Attorney, Dempsey B. Herring, County Administrator, Ida L. Smith, Clerk to Board, Phyllis Owens, Economic Development Director, and Lee Hinnant and Deuce Niven, members of the press.

At 7:30 p.m., the Chairman of the Board of Commissioners for the County of Columbus, North Carolina (the "Board") announced that the Board would proceed to hold a public hearing and would hear anyone who wished to be heard on the proposed issuance by The Columbus County Industrial Facilities and Pollution Control Financing Authority (the "Authority") of not exceeding \$7,000,000 aggregate principal amount of its qualified small issue industrial revenue bonds to pay all or a portion of the cost of acquiring, renovating, improving and equipping an existing manufacturing facility located at 15159 and 15223 Andrew Jackson Highway 76 Southwest in Fair Fluff, Columbus County, North Carolina, for the manufacturing of vinyl products for, among others, fencing and railing (the "Project").

The Project is to be owned and operated by Kroy Building Products, Inc., a manufacturing corporation (the "Company") and is to be located wholly within the County of Columbus.

The Chairman stated that the Authority had adopted a resolution expressing its intention to issue qualified small issue industrial revenue bonds and authorizing the execution and delivery of a memorandum of agreement pertaining to the financing of the Project for the Company. The Chairman then submitted copies of the resolution and the memorandum of agreement to the Board.

The Clerk to the Board presented an affidavit showing publication in a newspaper of general circulation in the County of Columbus on a date at least 14 days prior hereto of notice of the public hearing. The Chairman directed that the affidavit of publication be attached to this extract of minutes as Exhibit A.

The Chairman requested that the Clerk to the Board inquire in and around the meeting room to determine whether there were any persons who wished to speak at the public hearing. The names and addresses of the persons who were present and who offered comments on the proposed issuance of the qualified small issue industrial revenue bonds to finance the Project are as follows.

A list of persons who offered comments or delivered written testimony, and a summary of such comments and testimony are appended as Exhibit B.

After the Board had heard all persons who had requested to be heard, Commissioner C.E. Wilson moved that the public hearing be closed. A motion was seconded by Commissioner Spruell R. Britt and was unanimously adopted.

The Chairman stated that under the Internal Revenue Code of 1986, as amended, the Board must approve the issuance of the Authority's qualified small issue industrial revenue bonds if the interest thereon is not to be includable in the gross income of the owners thereof for purposes of federal income taxation.

Commissioner Spruell R. Britt then introduced the following resolution, a copy of which was distributed to each Commissioner and the title of which was read:

RESOLUTION APPROVING THE ISSUANCE OF NOT EXCEEDING \$7,000,000 AGGREGATE PRINCIPAL AMOUNT OF QUALIFIED SMALL ISSUE INDUSTRIAL REVENUE BONDS OF THE COLUMBUS COUNTY INDUSTRIAL FACILITIES AND POLLUTION CONTROL FINANCING AUTHORITY TO FINANCE A PROJECT IN THE COUNTY OF COLUMBUS FOR KROY BUILDING PRODUCTS, INC. AND APPROVING THE PROJECT

WHEREAS, the Board of Commissioners for the County of Columbus (the "Board")

has created a political subdivision and body corporate and politic of the State of North Carolina known as "The Columbus County Industrial Facilities and Pollution Control Financing Authority" (the "Authority"); and

WHEREAS, the Authority is authorized under the Industrial and Pollution Control Facilities Financing Act, Chapter 159C of the General Statutes of North Carolina, as amended (the "Act"), to issue industrial revenue bonds for the purpose, among others, of paying all or any part of the cost of any industrial or pollution control project for industry; to acquire, construct, improve and equip any such project; and to make and execute financing agreements, security documents and other contracts and instruments necessary or convenient in the exercise of such powers; and

WHEREAS, the Authority has determined to issue not exceeding \$7,000,000 aggregate principal amount of its qualified small issue industrial revenue bonds to pay all or a portion of the cost of acquiring, renovating, improving and equipping an existing manufacturing facility located at 15159 and 15223 Andrew Jackson Highway 76 Southwest in Fair Bluff, Columbus County, North Carolina for the manufacturing of vinyl products for, among others, fencing and railing (the "Project"), which Project is to be owned and operated by Kroy Building Products, Inc., a manufacturing corporation (the "Company"); and

WHEREAS, the Authority intends to file an application for approval of the Project with the Secretary of the Department of Commerce (the "Department"), as required by the Act; and

WHEREAS, the Department has, by regulation, provided that no application for approval of a proposed project by the Department will be officially received until the governing body of the county from which the application is made has, by resolution after having held a public hearing, approved the issue of qualified small issue industrial revenue bonds and approved the proposed project and a certified copy of such resolution has been proved to the Department;

WHEREAS, the Project will be located wholly within the County of Columbus;

WHEREAS, the Board, pursuant to public notice duly given, has held a public hearing on the proposed qualified small issue industrial revenue bond issue and Project and has considered the comments of persons who requested to be heard; and

WHEREAS, the Board desires to approve the issuance of the qualified small issue industrial revenue bonds and the Project;

NOW THEREFORE, BE IT RESOLVED by the Board as follows:

1. The issuance of not exceeding \$7,000,000 aggregate principal amount of qualified small issue industrial revenue bonds of the Authority to finance the Project is hereby approved.

2. The Project is hereby approved.

3. The Clerk to the Board is hereby authorized and directed to provide a certified copy of this resolution to the Department.

4. This resolution shall take effect immediately upon its passage.

Commissioner Spruell R. Britt moved the passage of the foregoing resolution entitled "RESOLUTION APPROVING THE ISSUANCE OF NOT EXCEEDING \$7,000,000 AGGREGATE PRINCIPAL AMOUNT OF QUALIFIED SMALL ISSUE INDUSTRIAL REVENUE BONDS OF THE COLUMBUS COUNTY INDUSTRIAL FACILITIES AND POLLUTION CONTROL FINANCING AUTHORITY TO FINANCE A PROJECT IN THE COUNTY OF COLUMBUS FOR KROY BUILDING PRODUCTS, INC. AND APPROVING THE PROJECT," and Commissioner Amon E. McKenzie seconded the motion, and the resolution was passed by the following vote:

Ayes:Commissioners Norris, Britt, Gray, Jacobs, McKenzie and Wilson.Noes:None.

Thereupon, Phyllis M. Owens reported that the County had been advised that the average weekly manufacturing wage proposed to be paid by the Company as part of the Project in the County was lower than the average weekly manufacturing wage paid by all manufacturers in the County and that for such reason the proposed application to be submitted to the Department of Commerce by the Authority for approval of such Project may not be approved.

Phyllis M. Owens pointed out that G.S. § 159C-7 provides that where a proposed operator such as the Company will not pay an average weekly manufacturing wage above the average weekly manufacturing wage paid in the County or which is not less than ten percent (10%) above the average weekly manufacturing wage paid in the State of North Carolina, the Secretary of the Department of Commerce may nonetheless approve the proposed industrial project if he shall have received (i) a resolution of the governing body of the county requesting that the proposed industrial project be approved notwithstanding that the operator will not pay an average weekly manufacturing wage above the average weekly manufacturing wage paid in the county and (ii) a letter from an appropriate State official, selected by the Secretary, to the effect that unemployment in the county is "especially

severe."

Phyllis M. Owens reported that the unemployment rate for the County was approximately 9.93%, for the latest available six-month period. Thus, the employment rate for the County exceeded one hundred and ten (110%) of the unemployment rate for the State of North Carolina and the unemployment rate for the County was at least five percent (5%), such that under the regulations of the Department of Commerce, the Secretary can approve the Project since unemployment in the County is "especially severe."

The Clerk presented a letter from the Director of the Commerce Finance Center of the North Carolina Department of Commerce to the effect that the unemployment in the County is "especially severe." A copy of such letter is attached to this excerpt of minutes as Exhibit C.

The Company, in its Memorandum of Agreement with the Authority, dated September 13, 2000, has represented that the financing of the Project by the Authority will serve the purposes of Chapter 159C of the General Statutes of North Carolina, as amended, in that the Project will alleviate unemployment by creating employment for approximately 35 persons in the County and the surrounding area.

Phyllis M. Owens suggested that the Board of Commissioners for the County consider adopting the necessary resolution requesting the Secretary of the Department of Commerce to approve the Project for the Company, notwithstanding that the Company will not pay an average weekly manufacturing wage above the average weekly manufacturing wage paid in the County.

Commissioner Spruell R. Britt introduced the following resolution, a copy of which had been distributed to each Commissioner and the title of which was read:

RESOLUTION OF THE BOARD OF COMMISSIONERS FOR THE COUNTY OF COLUMBUS REQUESTING THE SECRETARY OF THE DEPARTMENT OF COMMERCE TO APPROVE A PROJECT FOR KROY BUILDING PRODUCTS, INC. NOTWITHSTANDING THAT KROY BUILDING PRODUCTS, INC. WILL NOT PAY AN AVERAGE WEEKLY MANUFACTURING WAGE ABOVE THE AVERAGE WEEKLY MANUFACTURING WAGE PAID IN THE COUNTY OF COLUMBUS

WHEREAS, The Columbus County Industrial Facilities and Pollution Control Financing Authority (the "Authority") has agreed to issue its qualified small issue industrial revenue bonds in an aggregate principal amount not exceeding \$7,000,000 to pay all or a portion of the cost of acquiring, renovating, improving and equipping an existing manufacturing facility located at 15159 and 15223 Andrew Jackson Highway 76 Southwest in Fair Bluff, Columbus County, North Carolina, for the manufacturing of vinyl products for, among others, fencing and railing (the "Project"), and in accordance with the provisions of G.S. § 159C- 7 will file shortly with the Secretary of the Department of Commerce an application for the approval of the Project; and

WHEREAS, subparagraph (l)a of § 159C-7 of the General Statutes of the State of North Carolina provides:

"The Secretary [of the Department of Commerce] shall not approve any proposed project unless he shall make all of the following, applicable findings:

(1) In the case of a proposed industrial project, (a) that the operator of the proposed project pays, or has agreed to pay thereafter, an average weekly manufacturing wage (i) which is above the average weekly manufacturing wage paid in the county, or (ii) which is not less than ten percent (10%) above the average weekly manufacturing wage paid in the State...",

and

WHEREAS, G.S. § 159C-7 also provides that

"In any case where the Secretary shall make all of the required findings respecting a proposed industrial project except that prescribed in subparagraph (1) a of this section, the Secretary may, in his discretion, approve the proposed project if he shall have received (i) a resolution of the governing body of the county requesting that the proposed project be approved notwithstanding that the operator will not pay an average weekly manufacturing wage above the average weekly manufacturing wage in the county and (ii) a letter from an appropriate State official, selected by the Secretary, to the effect that unemployment in the county is especially severe."

and

WHEREAS, Kroy Building Products, Inc. (the "Company") cannot represent that the Company expects to pay an average weekly manufacturing wage above the average weekly manufacturing wage paid in the County of Columbus (the "County"); and

WHEREAS, the Company has represented that the Project will create employment

for approximately 35 persons in the County and the surrounding area; and

WHEREAS, the Board of Commissioners for the County of Columbus (the "Board") has determined to request that the Secretary of the Department of Commerce approve the Project notwithstanding that the Company will not pay an average weekly manufacturing wage paid by the County;

NOW, THEREFORE, BE IT RESOLVED by the Board as follows:

1. Because unemployment in the County of Columbus is, in its opinion, especially severe, the Board does hereby request that the Secretary of the Department of Commerce approve the Project pursuant to G.S. § 159C-7, notwithstanding that the Company will not pay an average weekly wage above the average weekly manufacturing wage paid in the County of Columbus.

2. The Clerk to the Board is directed to file a certified copy of this resolution with the Department of Commerce.

3. This resolution shall take effect immediately upon its passage.

Commissioner Spruell R. Britt moved passage of the foregoing resolution entitled: "RESOLUTION OF THE BOARD OF COMMISSIONERS FOR THE COUNTY OF COLUMBUS REQUESTING THE SECRETARY OF THE DEPARTMENT OF COMMERCE TO APPROVE A PROJECT FOR KROY BUILDING PRODUCTS, INC. NOTWITHSTANDING THAT KROY BUILDING PRODUCTS, INC. WILL NOT PAY AN AVERAGE WEEKLY MANUFACTURING WAGE ABOVE THE AVERAGE WEEKLY MANUFACTURING WAGE PAID IN THE COUNTY OF COLUMBUS," Commissioner Amon E. McKenzie seconded the motion, and the resolution was passed by the following vote:
