# SOUTHEASTERN COMMUNITY COLLEGE - APPROVAL OF ADDITIONAL CURRENT EXPENSE

**ADMINISTRATOR'S COMMENTS** 

Dempsey B. Herring, County Administrator, advised the Board of the following items:

1. The 1999-2000 Audit Report revealed that we have a 14% fund balance. Although we are in good financial status, one emergency could deplete the

fund balance.

2. We have been using \$1,000,000.00 of fund balance for the past two (2) years

to balance the Solid Waste Budget.

3. In the future, we will have additional debt service due the renovation of the

Detention Center.

4. Medicaid increases annually approximately \$500,000.00.

5. Health insurance increases annually.

6. According to the 1999-2000 Audit Report, tax collections are 91.9% which

needs to be increased.
