## RIEGEL RIDGE LANDFILL (PROPOSED) - PRESENTATION BY JEFF LANE, FRIENDS OF THE GREEN SWAMP CHAIRMAN

Jeff Lane, Friends of the Green Swamp Chairman, addressed the Board regarding the proposed Riegel Ridge Landfill. There were approximately two hundred (200) persons in attendance.

Mr. Lane thanked the people for attending the meeting and stated the following concerns regarding the proposed Riegel Ridge Landfill:

1. Landfills are not environmentally friendly;

- 2. A landfill in Columbus County should be the last resort as this will harm property values and should be considered a necessary evil;
- 3. Garbage should not be the future of Columbus County;
- 4. The majority of the waste 90 to 95 percent would be generated outside Columbus County;
- 5. The three (3) people who are in the process of siting this landfill (Riegel Ridge partners) are speculators with no local ties and no local obligations;
- 6. There are no provisions to handle additional traffic on N.C. 211, which is already crowded with beach traffic in the summer months;
- 7. International Paper is not obligated to keep ditches and canals clean;
- 8. Dr. Stan Riggs of East Carolina University has done extensive studies regarding Lake Waccamaw and suggests that some ditches need to be blocked because the Green Swamp has lost much of its ability to act as a sponge for surface waters resulting in severe highs and lows of water levels in the Waccamaw River Basin; and
- 9. The Friends of the Green Swamp are requesting the opportunity for a public hearing before a final decision is made.

## RIGEL RIDGE LANDFILL (PROPOSED): - PRESENTATION BY CHARLES HICKMAN

Charles Hickman, a concerned citizen of Lake Waccamaw, addressed the Board regarding the proposed landfill and stated he has the following concerns:

- 1. The proposed landfill will attract the seagull population;
- 2. Congested traffic on NC 211;
- 3. There are alternatives to the construction of the Landfill;
- 4. The Board owes to their constituents to evaluate the information presented;
- 5. Consider that we have to live with the landfill forever;
- 6. Short term financial liability;
- 7. Requested the Board to consider holding a public hearing; and
- 8. Presented the Board with a list of questions he would like answered.

#### RIEGEL RIDGE LANDFILL (PROPOSED) - COMMENTS BY BILLY HOOKS

Billy Hooks, a Columbus County resident, made the following comments:

- 1. The Board appointed him, along with fourteen (14) other members, to serve on the Solid Waste Advisory Committee ten (10) years ago to search for alternatives for the solid waste problem in Columbus County;
- 2. After a trip to Richmond, Virginia to visit a regional landfill, several alternative methods were considered but were not practical;
- 3. Mr. Hooks reported it was a majority opinion of the fifteen (15) member committee that the regional landfill concept is the most effective and the most economical for Columbus County;
- 4. Mr. Hooks reported it is his concern if we say no to a landfill, then what is the alternative, we should not be dependent upon another county to accept our garbage as we will be at their mercy to pay any price for disposal and they don't have to accept our garbage, then what; and
- 5. He also reported the County has spent a decade wrestling with the issue and it is now time for a decision.
