RIEGEL RIDGE (PROPOSED REGIONAL LANDFILL) - HOST AGREEMENT ADDENDUM #1

A motion was made by Commissioner McKenzie, seconded by Commissioner Wilson and passed to approve Addendum #1 to the Riegel Ridge Franchise and Host Agreement as read and approved on Monday, April 16, 2001 and again today, May 7, 2001 and that the Chairman of the Board be authorized to execute this on behalf of the County of Columbus. This Addendum will be submitted as part of the Riegel Ridge Landfill application for permit to the State Regulatory Agencies for their review. The Addendum Number 1 is as follows:

ADDENDUM NUMBER 1

FRANCHISE AND HOST COMMUNITY AGREEMENT FOR SOLID WASTE COLLECTION AND DISPOSAL SERVICES RIEGEL RIDGE, L.L.C. AND COLUMBUS COUNTY, N.C.

North Carolina General Statutes Chapter 130A-294(7)(bl)(3) requires that the following be included in a Franchise for a Sanitary Landfill:

- 1. A statement of the population to be served including a description of the geographic area.
- 2. A description of the volume and characteristics of the waste stream.
- 3. A projection of the useful life of the landfill.

Each of the three (3) items listed above are referenced in general terms in the existing Franchise and Host Community Agreement for Solid Waste Collection and Disposal Services. The following is provided for further clarification and compliance with NCGS 130A-294(7)(b 1)(3):

- 1. Page one of the Franchise and Host Community Agreement, Article 1 -Definitions, the following definition shall be revised to read as follows:
 - "Acceptable Waste" Solid Waste which under the terms and conditions hereof, may be accepted, handled and disposed at the Facilities, consisting of Solid Waste (including Special Waste) which must have been initially generated within the Service Area, as defined within Section 3.06 herein, and not transported to the Service Area from outside of the Service Area and which does not include or constitute Excluded Waste.
- 2. Page one of the Agreement as amended in this Addendum No.1 includes a definition of Acceptable Waste. In addition, Section 4.01(b) and 4.01(c) references acceptable waste and special wastes. The proposed Riegel Ridge Landfill is provided for the disposal of standard municipal household waste, commercial waste and any other waste product considered acceptable by the North Carolina Division of Solid Waste Management. Special Wastes must receive approval of the North Carolina Division of Solid Waste Management and the Columbus County Board of Commissioners prior to disposal in the Facility. The waste volume for this Facility is estimated at 1,500 tons per day.

- 3. Section 3.06 of the Agreement lists 25 specific North Carolina Counties and 14 specific South Carolina Counties, which comprise the service area for this Franchise Agreement. The approximate population for this area is 3,445,000.
- 4. Section 3.04 of the Agreement defines the term of the Agreement at not less than twenty (20) years nor greater than the life of the Facility. Calculations included in the Site Study estimate the life of the proposed landfill to be 23.2 years. For the purpose of this Franchise and Host Community Agreement, the estimated life of the Riegel Ridge Landfill is twenty-five (25) years.
- 5. Section 3.06 of the Agreement lists the 39 Counties included in the service area. County Number 5 under the South Carolina list is hereby changed from Cheraw to Kershaw.

GOVERNING BODY - STATEMENT BY COMMISSIONER DAVID L. DUTTON, JR.

Commissioner David L. Dutton, Jr. made the following statement for the record.

Columbus County has lost over 2,200 jobs with Lowe's, Waccamaw Lumber and other businesses closing. Gas prices continue to rise. More than 60% of the County is drawing a check or on a fixed income. In the 2000-2001 budget year, the state withheld approximately

\$600,000 in inventory taxes and Medicaid increasing \$800,000, we have had to use \$1.4 million dollars from reserves to balance the existing budget.

In the new 2001-2002 Fiscal Year Budget which is mandated to be approved by June 30, 2001, mandates from the state have increased from 3.7 million to 5.1 million dollars which is a 1.4 million dollar increase. We also have an increase in medical insurance and worker's compensation and with the renovation and addition to the jail, we are now facing a 3.6 million dollar deficit.

If the legislators in Raleigh will not raise taxes, why should the Board of Commissioners raise taxes in Columbus County?

I am going on record that we should revisit all County Departmental Budgets and cut them until we make up the 3.6 million dollar deficit and not raise property taxes. We are paying 72.5 cents in property taxes, plus fire, rescue and trash and that is high enough for a economically depressed County. If Raleigh has any more programs that are free, we will accept them, but if they have any more new programs that cost the County local tax dollars, they can keep them.

GOVERNING BODY - CHAIRMAN TO APPOINT A FINANCE COMMITTEE

Commissioner Wilson reported that based on information regarding bids not being secured for Contracts that has cost the County several thousand dollars over the past three (3) years, Commission Wilson made a motion that the Chairman appoint a Finance Committee to review all current County Contracts, all future bids for any service of the County, recommend approval for awarding of contracts and approve the expenditures of all funds over \$250.00. This approval includes the purchasing for all maintenance projects and involves each department of the County Government.

The motion was seconded by Commissioner McKenzie and passed unanimously.

ADMINISTRATOR - RESIGNATION

Dempsey B. Herring, County Administrator, resigned his post from the position of County Administrator, due to his doctor's advice effective June 30, 2001. Mr. Herring reported he has had three (3) major surgeries within the past three (3) years and due to this he cannot give 100% to the position.

Mr. Herring admitted that he used county employees and county vehicles in December 2000 to pull two (2) privately purchased travel trailers from Kenly in Johnston County back to Whiteville. Mr. Herring reported that he will reimburse the County for all expenses for the two (2) County employees and the use of County vehicles who pulled the trailers back to Whiteville.

Mr. Herring was commended by several Commissioners, Department Heads and Associates for a job well done during his tenure of twenty-five (25) years of service with the County and particularly the time he has served as County Administrator.

Commissioner Dutton made a motion to accept Dempsey B. Herring, County Administrator's resignation and received no second.

James E. Hill, Jr., County Attorney, advised the Board they do not have to accept the resignation for it to be official.

Commissioner Dutton withdrew his motion.

ADJOURNMENT

At 9:00 A.M., a motion was made by Commissioner Jacobs, seconded by Commissioner Dutton and passed unanimously to adjourn the Board Meeting.
