# PRESENTATION of the JUNE 30, 2001 FINANCIAL STATEMENTS (AUDIT REPORT)

Mr. Alan Thompson, CPA with Thompson, Price, Scott, Adams and Company, P.A., presented to the Board the June 30, 2001 Financial Statements (Audit Report). He stated there were three (3) areas listed in the summarization of key items that needed close attention. These areas are as follows:

- 1. Fund Equity (Enterprise Fund);
- 2. Tax Collection Rate; and
- 3. Total Revenues (Solid Waste Enterprise Fund).

Mr. Thompson stated the federally-funded projects were having a great impact. In addition, he stated the solid waste and water needed to be monitored closely and need to be self supporting.

Commissioner Britt asked if Columbus County fell in the norm statewide. The reply was we were and some counties were in worse condition and some were in better condition. Commissioner Dutton inquired if we indeed did have ten (10%) percent in Contingency monies. The reply was we did and the State does require eight (8%) percent at all times in Contingency money. Commissioner Memory inquired about the tax collection rate being low. The reply Mr. Thompson gave was the tax collection rate needed to increase and this was a most crucial area that needed great attention. A motion was made by Commissioner Jacobs, seconded by Commissioner Norris and the motion so carried.

#### SURPLUS and DISPOSAL/RESALE of 911 FIXED ASSETS

John Moore, Emergency Services Director, requested the Board to declare the original 911 fixed assets purchased in 1994 as surplus with authorization to resale or dispose of. He informed the Board he had two (2) counties that were interested in purchasing the console only and the other equipment was obsolete and would need to be junked or destroyed. A motion was made by Commissioner Dutton and seconded by Commissioner Jacobs to do so and the motion so carried.

#### **EVERGREEN FIRE DEPARTMENT**

William Hall Williamson, a concerned citizen of the Evergreen Community, requested permission to address the Board regarding the concerns of the citizens of the Evergreen Community relative to the purchase of a fire truck by the Evergreen Fire Department. Chairman McKenzie informed Mr. Hall the Board would agree to meet with the concerned citizens of the Evergreen Community in a mutual place he could arrange and notify the board.

#### RFP BIDS

Charles Patton, Columbus County Interagency Transportation Director, informed the Board every five (5) years, or sooner, if desired, a new transportation provider RFP has to be for bid. This is a process that is required and in many ways controlled by the North Carolina Department of Transportation. A motion was made by Commissioner Britt this be let bid, seconded by Commissioner Norris and the motion so carried.

# AGREEMENT for NEW INTERAGENCY TRANSPORTATION BUILDING

Charles Patton, Columbus County Interagency Transportation Director, requested the Board to approve a Standard Form of Agreement Between Owner and Architect with Standard Form of Architect's Services. This agreement is between the Columbus County Interagency Transportation and Ballard Architects, AIA, Incorporated for the new Interagency Transportation metal building. A motion was made by Commissioner Norris and seconded by Commissioner Memory to approve this agreement, seconded by Commissioner Memory. The motion so carried.

## **ALTERNATIVE BILLING for OUT-OF-COUNTY MEDICAL TRANSPORTATION**

Charles Patten, Columbus County Interagency Transportation Director, requested an amended contract from Laidlaw Transit System be approved for an alternative way of billing for out-of-county transportation. This amended contract would allow billing by the hour at the charge of twenty-four and 00/100 (\$24.00) dollars per hour. He explained this system would save the County twenty (20%) percent on the Wilmington trips and thirty (30%) percent on the Chapel Hill trips. Commissioner Wilson made a motion to approve, seconded by Commissioner Memory and the motion so carried.
