SEXUAL ASSAULT AWARENESS MONTH PROCLAMATION 2002

Vicki Pait, Families First Director, requested the Board of Commissioners to approve the following Proclamation.

SEXUAL ASSAULT AWARENESS MONTH PROCLAMATION 2002

WHEREAS, sexual assault is a violent crime most often committed by an acquaintance, intimate partner or family member; and

WHEREAS, anyone can become a victim of sexual assault regardless of age, race or income level and research indicates that one out of every three women, one of every nine men, and one child out of every four is sexually assaulted; and

WHEREAS, the U.S. Department of Justice reports an increase in distribution and abuse, especially in Southern and Southwestern States, of the drug Rohypnol (roofies) which has been labeled the new "date rape" drug of choice; and

WHEREAS, statewide efforts are being made to educate medical, law enforcement, legal and judicial professionals and the general public concerning this epidemic of violence affecting our society.

NOW, THEREFORE, we, the Columbus County Board of Commissioners, do hereby proclaim that April, 2002, is **SEXUAL ASSAULT AWARENESS MONTH** in Columbus County and call upon all citizens to join in increasing awareness in our community; and to take notice of subtle phrases from friends, television or movies that make light of rape and question them openly so that we can work to stop this and all other forms of violence in our County.

WHEREAS, local governments have been receiving reimbursements from the State to replace local revenues lost in the late eighties when the General Assembly repealed certain local property taxes; and

Glen Ware, Freeman White Architects, is recommending that the Board of Commissioners waive the discrepancy of Bordeaux Construction wherein their bid for the Columbus County Nutrition/Detention Center was given only in numeric form. The bid documents require bids to be given in numeric and written form. Mr. Ware explained that the low bidder was Bordeaux Construction, but there was a protest due to the aforementioned technicality, of which the County Commissioners have the power to overrule if they choose to do o. There was discussion relating to proceeding with the original one hundred thirty-six (136) beds as planned or reject these bids and add the forty (40) beds for the U.S. Marshall Service for rebid. Mr. Freeman stated that the timing was critical in proceeding with the construction plans due to inclement weather which would greatly alter the construction plans. He stated the original layout of the building was planned for easy addition in the future. After discussion regarding whether this would allow for future growth and be advantageous for Columbus County, a motion was made by Commissioner Britt to waive the discrepancy, seconded by Commissioner Jacobs. Commissioner Jacobs went on record advising his action was taken due to the receipt of the Architect's advice. It was the general consensus of the Board it would more advantageous to Columbus County, due to the factors involved, to proceed with the one-hundred thirty-six (136) bed addition of which the twenty-five (25) beds to be utilized by the U.S. Marshall Service could be arranged also within this number. Additional beds could be added by change order if so desired by the Board. Commissioner Memory stated that he felt Graka Builders should be chosen based on Graka being a local concern and Bordeaux being located out of the county. Commissioner Memory felt that the money paid locally would benefit the local economy. Commissioner Memory further stated that he believed the County should construct the entire forty (40) bed addition to the original one hundred thirtysix (136) beds to ensure the jail does not run out of capacity prematurely.
