WHITEVILLE CITY BOARD OF EDUCATION RESOLUTION APPROVAL

Dr. Danny D. McPherson, Superintendent, requested approval of the following Resolution to transfer money from Capital Outlay to Current Expense.

RESOLUTION March 11, 2002

WHEREAS the Whiteville City Schools prepared and submitted its original 2001-2002 budget based on information provided by federal, state, and local agencies/entities; and

WHEREAS the final Whiteville City Schools' operating budget was planned with the appropriation as approved by the Columbus County Commissioners, effective July 1, 2001; and

WHEREAS neither the Board of Commissioners nor the Board of Education anticipated the severe cuts made by the state; and

WHEREAS the Board of Commissioners had to reduce the original appropriation to the Whiteville City Schools by 5% (\$79,042) to meet the reduction in funding by the State of North Carolina; and

WHEREAS expenditures and personnel contracts were issued based on the July 1, 2001 appropriations by the Board of Commissioners; and

WHEREAS the increased costs of electricity and fuel have depleted all excess funds; and

WHEREAS the Whiteville City Board of Education has already budgeted a portion of the required fund balance to meet its current 200 1-2002 budget; and

WHEREAS GS 11 5C-433 (d) states that "the board of education may amend the budget to transfer money to or from the capital outlay fund to or from any other fund, with the approval of the board of county commissioners, to meet emergencies unforeseen and unforeseeable at the time the budget resolution was adopted. When such an emergency arises, the board of education may adopt a resolution requesting approval from the board of commissioners for the transfer of a specified amount of money to or from the capital outlay fund to or from some other fund;" and

WHEREAS these financial and budgetary issues were "unforeseeable" to both the Columbus County Board of Commissioners and the Columbus County Board of Education;

NOW THEREFORE BE IT RESOLVED that the Whiteville City Board of Education respectfully requests permission to transfer \$79,042 from our capital outlay fund to our current expense fund for FY 2001-2002.

RESOLUTION CITING THE GREEN SWAMP AS A NATIONAL NATURAL LANDMARK APPROVAL

Jeff Lane, Chairman of Friends of the Green Swamp, stated in 1974 the Green Swamp had been declared a National Natural Landmark by the Park Service. In addition, it has been recognized by State and National Government. Annual Earthday will be here shortly and I am requesting approval and adoption of the following Resolution by the County Commissioners.

RESOLUTION CITING THE GREEN SWAMP AS A NATIONAL NATURAL LANDMARK BY THE COLUMBUS COUNTY COMMISSIONERS APRIL 1, 2002

WHEREAS the Green Swamp of southeastern North Carolina is the largest and most unique mosaic of wetland communities in the Carolinas, containing an assemblage of unusual community types and a great abundance of rare and endemic plant species such as pitcher plants and other carnivorous plant species; and

WHEREAS the United States has celebrated Earth Day for over three decades and will again this year on April 22, 2002,

THEREFORE, BE IT RESOLVED, that in acknowledgment of its unique properties and special geological and ecological features, the Columbus County Commissioners hereby recognize the Green Swamp of southeastern North Carolina on Earth Day 2002;

USE of COUNTY FUNDS for PERSONNEL for VOLUNTEER RESCUE UNITS

Kenneth Sasser, President of Columbus County Fire/Rescue Association, and Brady Watts, Chief of the Nakina Rescue and Fire Department, addressed the Board regarding the use of the County funds for personnel that were being given to the rescue departments.

Kenneth Sasser:

- 1. The rescue departments within Columbus County are receiving money for additional personnel and the fire departments are not.
- 2.At a meeting held on March 25, 2002, I was told that twenty-nine thousand and 00/100 (\$29,000.00) dollars are given to the rescue department within Columbus County which is being issued on a bi-yearly basis.
- 3.Due to the fire departments assisting the rescue departments on their calls, I feel the fire departments are due extra personnel and dollars also.
- 4.I do not think the daytime EMT's should be fighting fires and then leaving the scene of a fire and going to rescue someone.
- 5.I am requesting you be fair to the fire departments, as well as the rescue departments. I want three (3) additional people in the Hallsboro Fire Department.

Commissioner McKenzie stated that this matter would be taken under advisement.

Brady Watts:

- 1. We are paying one (1) person eight (8) hours per day.
- 2. We answer calls twenty-four (24) hours per day.
- 3. We are presently paying per call.
- 4. The system we have developed is working well.

Commissioner Dutton stated that this matter would be taken under advisement. Chairman McKenzie informed Mr. Sasser and Mr. Watts that a meeting with the fire and rescue chiefs would be set up this week for further discussion and a decision would be rendered by Friday.

GREEN ACRES COMMUNITY

Luther Williams, a resident of the Green Acres Community, addressed the Board with the following two (2) issues.

- 1. The Green Acres Community needs more frequent visits from the Sheriff's Department to make the residents feel safer and for more protection. We prefer you use unmarked patrol cars so as not to alert the criminals of your presence.
- 2. We need fire hydrants for this community. There are fifty plus (50+) houses in this community and not a single fire hydrant.

In response to the #1 issue, Sheriff Ferguson informed Mr. Williams he did not have the personnel or vehicles to patrol the area he requested more often that presently being patrolled, but they would patrol the area as often as possible.

In response to the #2 issue, Commissioner Norris informed Mr. Williams the water lines were only 4 (4") inch lines in that community and this size line could not accommodate fire hydrants.
