RESOLUTION APPROVAL FOR COLUMBUS COUNTY WATER and SEWER DISTRICT II

Billy Joe Farmer, County Administrator, requested the Board to approve the following Resolution which will give Columbus County Water and Sewer District II permission to act as administrator of the fund for the Rural Center Project.

RESOLUTION BY BOARD OF COMMISSIONERS OF THE COLUMBUS COUNTY WATER & SEWER DISTRICT II, NORTH CAROLINA

- WHEREAS, The 1998 Critical Needs Bond Act has authorized the making of loans and grants toaid eligible units of government in financing the cost of construction of wastewater
 treatment works, wastewater collection systems, and water supply systems and
- WHEREAS, The Columbus County Water and Sewer District II has need for an engineering study to evaluate regional sewer alternatives.
- WHEREAS, The Columbus County Water and Sewer District II has requested state grant

assistance for the sewer project through the North Carolina Rural Economic Development Center,

NOW THEREFORE BE IT RESOLVED, BY THE BOARD OF COMMISSIONERS OF THE COLUMBUS COUNTY WATER AND SEWER DISTRICT II:

That the local match for the Capacity Development Project will be provided by the participating entities as follows:

Town of Fair Bluff \$1,500.00 Town of Boardman \$1,500.00 Town of Cerro Gordo \$1,500.00

That the funds for the local match will be paid to the District and the District will act as administrator for the Rural Center project.

That the Columbus County Water and Sewer District II will adopt and place into effect on or before completion of the project a schedule of fees and charges which will provide adequate funds for proper operation, maintenance, and administration of the system. The fees shall meet the high-unit cost criteria of 1.5% of the median household income for water and sewer systems, or 0.75% for a water or sewer system alone.

That the Columbus County Water and Sewer District II will provide for efficient operation and maintenance of the project on completion of construction thereof.

That Billy Farmer, County Administrator, and successors so titled, is hereby authorized to execute and file an application on behalf of the Columbus County Water and Sewer District II with any potential funding agencies for a grant to aid in the construction of the project described above.

That Billy Farmer, County Administrator, and successors so titled, is hereby authorized and directed to furnish such information as the appropriate agency may request in connection with such application or the project; to make the assurances as contained above; and to execute such other documents as may be required in connection with the application.

That the Columbus County Water and Sewer District II has substantially complied or will substantially comply with all Federal, State, laws, rules, regulations, and ordinances applicable to the project and to Federal State grants and loans pertaining thereto.

Ty Marshall, Border Belt Association, requested the Board to submit a letter of recommendation stating the significance of the Border Belt Research Station, the useful purpose it served, the economic impact it would have on Columbus County and a request for it to remain open and active. Commissioner Norris made a motion to approve, seconded by Commissioner Dutton. The motion so carried.

REINSTATEMENT of NETTING in WACCAMAW RIVER

Commissioner Dutton informed the Board a ban had been placed on netting in Waccamaw River which has resulted in the over population of blackfish and catfish. This, in turn, has resulted in these larger fish feeding off of the smaller fish. Commissioner Dutton emphasized the great need for this ban to be lifted to eliminate this over population so the people who enjoy fishing these waters would have more of a variety.

James E. Hill, Jr., Columbus County Attorney, advised the only way the ban could be lifted was by a local bill being placed in the State Legislation. Commissioner Norris made a motion for a letter to be submitted to Senator R.C. Soles, Jr. for the introduction of local legislation to exempt Columbus County from current wildlife regulations, seconded by Commissioner Memory. The motion so carried.

RECESS REGULAR SESSION and ENTER into CLOSED SESSION

At 7:53 P.M., Commissioner Britt made a motion to recess Regular Session and enter into Closed Session, seconded by Commissioner Memory. The motion so carried.

NEW WATER RATE for COLUMBUS COUNTY WATER and SEWER DISTRICT II

Billy Joe Farmer, County Administrator, requested the Board to approve an increase in the water rates for Columbus County Water and Sewer District II. This increase is needed due to projected revenues being less than the expenditures that have been incurred. The increase is listed below:

Whereas, the Board of Commissioners for the County of Columbus, North Carolina, as the Governing Body of Columbus County is considering authorizing the expenditure of public funds through the various financial arrangements for the purchase of land and the expansion of the Columbus County Law Enforcement Center, Chadbourn Highway (Highway 130), Whiteville, NC. This project includes the purchase of land, right of way acquisitions, and the construction and installation of detention facilities.

NOW, THEREFORE, BE IT DETERMINED AND RESOLVED, by the Board of Commissioners of Columbus County, North Carolina as the Governing Board of Columbus County, which is the legal owner of the property, and the supervisor of this project as follows:

Section 1. Said Board hereby finds and determines in connection with the authorizing of the financing of this project that Columbus County intends to reimburse Columbus County from the proceeds of the financing arrangement for the Expenditures made on and after July 20, 2001, which date is no more that sixty (60) days prior to the date hereof. Columbus County reasonably expects on the date hereof that it will reimburse the Expenditures from the proceeds of the financing of the said project.

Section 2. Each Expenditure was or will be (a) of a type properly chargeable to a capital account under general federal income tax principles (determined in each case as of the date of the

Expenditures), (b) a cost of securing the financing of the project, regardless of the manner of financing, (c) a nonrecurring item that is not customarily payable from current revenue, (d) a grant to a party that is not related to or as agent of Columbus County so long as such grant does not impose any obligation or condition (directly or indirectly) to repay any amount to or for the benefit of Columbus County.

Section 3. The maximum principal amount of the indebtedness expected for the project is \$_____

Section 4. The said Columbus County will make a reimbursement allocation, which is a written allocation by Columbus County that evidences the said County's use of the proceeds of the financing to reimburse an Expenditure, no later than 19 months after the later of the date on which the Expenditures is paid or the Project is placed in service or abandoned, but in no event more than three (3) years after the date on which the Expenditure is paid. Columbus County recognizes the exceptions are available for certain "preliminary expenditures", cost of financing, cost of acquiring land, certain *de minmis* amounts, expenditures by "small issuers" (based on the year of issuance and not the year of expenditure) and expenditures for construction of the project of at least four (4) years.

Section 5. This Resolution shall take effect immediately upon passage.

Therefore, upon Motion of Commissioner <u>Memo</u>ry, seconded by Commissioner <u>Norris</u> the foregoing resolution was passed by the following vote.
