REGIONAL LOCAL MANAGEMENT for MENTAL HEALTH

Discussion was held concerning Columbus County participating in the LME for the Southeastern Regional Mental Health. Commissioner Wilson stated Billy Joe Farmer, Columbus County Administrator, and Steve Ramey, Area Director for Southeastern Regional Mental Health, Developmental Disabilities and Substance Abuse Services, should set down and discuss a few items relating to this. Commissioner Wilson stated their budget should be broken down by department to allow disclosure as to how the money is expended. Commissioner Britt made a motion for the following Resolution to be adopted, seconded by Commissioner Norris. The motion so carried.

RESOLUTION

The Board of County Commissioners of Columbus County, North Carolina, at its regular meeting held on July 1, 2002, adopted the following Resolution:

WHEREAS, the 1999 General Assembly, Regular Session 2000, established the Joint Legislative

Oversight Committee ("Committee") on Mental Health, Developmental Disabilities, and Substance Abuse Services; and

WHEREAS, said Committee reviewed the governance, structure, and financing of the current mental health system and reported its recommendations to the 2001 General Assembly for legislative action; and

WHEREAS, the 2001 General Assembly enacted Session Law 2001-437, House Bill 381 based upon these recommendations; and

WHEREAS, said Session Law 2001-437, House Bill 381, Section 1.4 (§ 122C-10I) provides that within the public system of mental health, developmental disabilities, and substance abuse services, there are area, county, and State facilities. An area authority or county program is the locus of coordination among public services for clients of its catchment area;" and

WHEREAS, it is further provided therein at Section 1.8 (§ 122C-1 15) that a "county shall provide mental health, developmental disabilities, and substance abuse services through an area authority or through a county program established pursuant to G.S. 122C-1 15.1;" and

WHEREAS, the several counties of Bladen, Columbus, Robeson, and Scotland, currently operate as a multi-county area authority collectively known as Southeastern Regional Mental Health, Developmental Disabilities, and Substance Abuse Services ("SRMHIDD/SAS"); and

WHEREAS, Columbus County has been a member of SRMH/DD/SAS since July 1, 1967 and desires to continue its affiliation with this multi-county area authority; and

WHEREAS, SRMH/DD/SAS has expressed a desire to expand its current catchment area to include at least one additional county in this multi-county area authority.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissions of Columbus County, North Carolina, that a Resolution be, and the same is hereby unanimously adopted, that Columbus County will continue its affiliation with SRMH/DD/SAS as a multi-county area authority.

AND BE IT FURTHER RESOLVED that Columbus County, as a member of SRMH'DD/SAS, will encourage expansion of the current four county catchment area to include at least one additional county within this multi-county area authority.

WITNESS:

WHEREAS, Columbus County is the owner of a certain sewer line which is located between the Columbus County Industrial Park located along North Carolina Highway 130, approximately one-half the distance between the City of Whiteville and the Town of Chadbourn; and

WHEREAS, all these industrial sewer lines (inside of and outside of industrial park and which are owned by the County of Columbus), including the lift stations were intended to be dedicated to the City of Whiteville, who shall thereafter be entirely and completely responsible for the obligations of ownership, maintenance and upkeep of the same; and

WHEREAS, the County of Columbus is desirous of the continuous development of the Industrial Park; and

WHEREAS, the City of Whiteville has agreed to allow all of the tenants (present and future of the said Industrial Park to tap on and use the non-hazardous waste sewage lines.

NOW, THEREFORE, the Grantor, the County of Columbus, for and in consideration of Ten (\$10.00) Dollars, and other good and valuable consideration to it in hand paid, does hereby grant, bargain, sell, and convey unto the City of Whiteville and the City of Whiteville does hereby accept a perpetual right and easement to the sewer lines and the lift stations located within and outside of the Columbus County Industrial Park and the maintenance thereof. These lines and lift stations which are located between the Columbus County Industrial Park and the city limits of Whiteville, North Carolina.

By acceptance of this Deed of Easement, the City of Whiteville also agrees to accept all future owners and tenants within in the Columbus County Industrial Park as users of the non-hazardous sewer disposal system in the City of Whiteville up to 100,000 gallons per day pending the results of the sewer capacity study. The allowance of future owners and tenants to tap onto the sewer system of the City of Whiteville is for the sole purpose of disposing of non-hazardous waste sewage within the City of Whiteville's sewage system.

TO HAVE AND TO HOLD the said right and ownership of the sewage lines and the pump station, to the said City of Whiteville, its successors and assigns in title; it being agreed that the rights and easement herein, granted are appurtenant to and runs with the land. The County of Columbus does not warrant or certify as to ownership of the real estate where the sewer line run, as the same is located on the highway right of ways and permission has previously been granted by the North Carolina Department of Transportation.

IN TESTIMONY WHEREOF, the parties of the first part, the County of Columbus, have caused this instrument to be executed in its name, by its Chairman of the County Board of Commissioners, attested by its Clerk, and the county seal to be affixed thereto, all by the authority of the Board of County Commissioners duly given; and the parties of the second part, the City of Whiteville, agrees to accept the same and has caused this instrument to be executed in its name, by its Mayor of the City of Whiteville, attested by its Clerk, and the city seal to be affixed thereto, all by the authority of the City of Whiteville duly given.
