7:00 P.M.: Public Hearing - Fire Districts' Boundaries and Six (6) Mile Extension: to receive public comments and input regarding the following two (2) items:

- 1. The update of all maps for the fire districts' boundaries located within Columbus County under the new GIS system; and
- 2. Extension of certain fire districts from five (5) miles to a six (6) mile response area for the following fourteen (14) departments: A.D.R., Bolton, Brunswick, Evergreen, Hallsboro, Klondyke/Chabourn, Lake Waccamaw, Nakina, North Whiteville, Old Dock/Cypress Creek, Roseland, St. James, White Marsh/Welches Creek and Williams Township.

### **PUBLIC HEARING CALLED TO ORDER:**

At 7:00 P.M., Chairman Memory called the Public Hearing to order and stated the purpose of the Public Hearing was to receive public comments and input regarding the update of all maps for the fire districts' boundaries located within Columbus County and the extension of fourteen (14) departments from five (5) miles to a six (6) mile response area. Chairman Memory requested Ronnie Hayes, Emergency Services Director, to explain.

### **RONNIE HAYES' PRESENTATION:**

Ronnie Hayes, Emergency Services Director, stated the following:

- 1. These districts have a 9S rating or better and some have 7S and 6S ratings;
- 2. By extending these districts, the citizens will have lower fire insurance premiums, for example, on a \$100,000 house, the savings on insurance premiums would be fifty to one hundred (\$50 \$100) dollars per year;
- 3. These districts are done by actual road miles and not air miles;
- 4. By agreeing to this extension, the said departments will have to give mutual aid; and
- 5. This process was started before I came on board. We have previously submitted maps to the State but they were not approved.

The following people spoke:

- 1. Monroe Enzor: This is a wonderful idea and should have took place a long time ago.
- 2. **Edwin Ezzell:** this has been a long process that's been going on for approximately three (3) years.
- 3. **Jerry Gore:** this is a good idea for the citizens of Columbus County which needed to be done a long time ago.

Commissioner Godwin asked Mr. Hayes if there would still be some areas where the citizens would not be covered if these extensions were approve. Mr. Hayes replied stating yes there were a few areas, but the areas that would not be covered were mostly swamp areas.

### **PUBLIC HEARING CLOSED:**

At 7:11 P.M., there being no further comments, Commissioner Wilson made a motion to close the Public Hearing, seconded by Vice Chairman Dutton. The motion so carried.

### 7:30 P.M.: Regular Session

### Agenda Items #1 and #2: MEETING CALLED to ORDER and INVOCATION:

At 7:30 P.M., Chairman Memory called the meeting to order. The invocation was delivered by Commissioner C.E. "Gene" Wilson. Everyone in attendance repeated the Lord's Prayer and pledged Allegiance to the Flag of the United States of America.

### Agenda Item #3: BOARD MINUTES APPROVAL:

Commissioner Norris made a motion to approve the August 2, 2004 Meeting with Columbus County Board of Education Minutes and the August 2, 2004 Regular Session Minutes, seconded by Commissioner McKenzie. The motion so carried.

### Agenda Item #4: PAY PLAN UPDATE:

Chris May, Executive Director of Cape Fear Council of Governments, presented the following update to the Board on the revised Columbus County Pay Plan.

- 1. I have completed the comparison now utilizing the figures from Robeson, Columbus, Bladen and Pender Counties;
- 2. I will have the completed plan by the last meeting in September, 2004; and
- 3. I will be at the next Department Head Meeting next week to start setting up appointments with the Department Heads for them to critique the employees' job descriptions.

Commissioner Godwin requested Mr. May to explain how this midpoint that he used actually worked. Mr. May replied stating you take the low figure and the high figure and divide by two (2) to get the midpoint.

Commissioner Godwin asked Mr. May if there would ever be an instance where two (2) people in the same department who performed the same duties where one employee would receive a greater increase than the other. Mr. May replied stating yes there may be. The salaries will be based on merritt, job skill and value to Columbus County, and in this instance, it would be the discretion of the Department Head.

Commissioner McKenzie asked Mr. May if the Board would receive this information before the last meeting in September, 2004. Mr. May replied stating the Board would receive a preliminary copy of the revised Columbus County Pay Plan by the middle of September, 2004. Mr. May stated there were three parts to this plan as follows:

- 1. Policy development;
- 2. Actual numbers for salaries; and
- 3. Job descriptions which tell what the employee actually does.

### Agenda Item #5: REFERENDUM PROPOSAL by ROBERT ADAMS:

Robert Adams, private citizen, requested Board approval of the following referendum for a county-wide water system.

### **Referendum Proposal**

Be it resolved that the citizens of Columbus County urge our County Commissioners consider and approve for voter approval on a county wide referendum of a water system. This proposal referendum should be worded so as the voters of Columbus County mandate this public water system is kept as a permanently voluntary water system.

Be it resolved that the citizens (s) of Columbus County urge our County Commissioners consider

and approve this referendum with a five (5) cent per hundred dollars on property tax spending cap. This cap never to be exceeded and the county water system be grown under this spending cap; that as water sales allow that said system is completed county wide; that said special five (5) cent property tax be zeroed out of existence.

If it pleases our Board of Commissioners of Columbus County, our citizens (s) urge you to approve this proposal and its intent in our November general election of 2004. We also request that it be published and posted in as many public places for voter information and inspection.

Be it also resolved that our County Commissioners consider excluding all municipalities within our county from said referendum and county water system and its usage and taxing process.

Be it also resolved that municipalities that wish to participate voluntarily should reach an agreement with the county before referendum in November election.

This proposal is made for your intense consideration.

Mr. Adams stated the following:

- 1. Columbus County is presently spending at least one (\$ .01) cent of property tax money for feasibility studies that are being done for water;
- 2. Columbus County is presently spending at least one (\$ .01) cent of property tax money, or more, for the mistakes that have been made in these water districts;
- 3. It stands to reason that you can operate one (1) water district cheaper than six (6);
- 4. There are other counties surrounding Columbus County that phased their water districts in and did not attempt to build them in a short period of time; and
- 5. Water districts should be built wisely and efficiently.

Commissioner Godwin asked Mr. Adams what were the advantages of his proposal. Mr. Adams replied stating if the water systems would merge and operate as one (1) system, it could be run more efficiently and much cheaper, and the biggest advantage would be the spending cap.

Chairman Memory asked James E. Hill, Jr., Columbus County Attorney, if the existing water systems could be merged legally. Mr. Hill replied stating he would need to refer to N.C.G.S. §162A relative to formation and do some research.

Commissioner Wilson stated he understood that U.S. D.A. would not allow the water systems to merge due to outstanding indebtedness.

Chairman Memory asked James E. Hill, Jr., Columbus County Attorney, if Columbus County could have a non-binding referendum. Mr. Hill replied stating no.

Commissioner Norris made a motion to table this item pending further discussion and discovery, seconded by Commissioner Godwin. The motion so carried.

Ronnie Hayes, Emergency Services Director, requested Board approval of the following. A Public Hearing was conducted on this matter at 7:00 P.M. previous to this meeting.

- B. The extension of fourteen (14) fire districts from five (5) miles to a six (6) mile response areas as follows: A.D.R., Bolton, Brunswick, Evergreen, Hallsboro, Klondyke/Chadbourn; Lake Waccamaw, Nakina, North Whiteville, Old Dock/Cypress Creek, Roseland, St. James, White Marsh/Welches Creek and Williams Township.

Vice Chairman Dutton made a motion to approve the updated fire district maps for all fire districts located within Columbus County and the extension of fourteen (14) fire districts from five (5) miles to a six (6) mile response area, as listed above, seconded by Commissioner Norris. The motion so carried.

This is based on calendar year and we were forced to go with being self insured;
- 3. We are working on team effort with a team concept and have been holding Team Management Meetings on a regular basis; and
- 4. We have been working on developing a Planning Department with a Planner.

Commissioner Jacobs asked Mr. Farmer if we were in the process of hiring a Planner. Mr. Farmer replied stating yes.

### Agenda Item #17: COMMENTS:

#### A. Public:

Chairman Memory stated that two (2) people had signed up to speak. It was made known by the audience that the first speaker, Ernie Gaskins, had left previous to this time. The second speaker, Benjamin Bill Ivey, Jr., will wait until after Closed Session to speak.

#### B. Board of Commissioners:

1. **Commissioner Norris:** I would like to recognize Ed Worley, Director of the Columbus County Aging Department, for the accomplishments he has done at the Aging Department during his tenure, and I would like for Mr. Worley to explain to us about the latest accomplishment he has been able to do.

**Ed Worley:** We have received thirty-eight (38) additional CAP slots, and by doing this, we will generate one million three hundred thirty thousand and 00/100 (\$1,330,000.00) dollars in revenue for Columbus County. These CAP slots are for senior citizens who we provide in-home services to for a period of seven to eight (7-8) hours a day. We have a waiting list of two hundred twenty-five (225) people.

- 2. **Commissioner Jacobs:** Ed Worley and myself have served on the Board of Commissioners. Mr. Worley resigned from this Board to become the Aging Director. I would like to commend him for the great job he is doing, and has done.
- 3. Commissioner Godwin: I would like to enter into record the following Resolution of Reconstruction of Williams Township School of which a copy was included in our Board envelope along with our Board Packet, and each County Commissioner was sent a Certified Copy through the U.S. Mail.

### Resolution August 9, 2004

WHEREAS, the auditorium and two-story classroom building at Williams Township School were destroyed by fire during the early morning of January 5, 2004; and

WHEREAS, the Columbus County Board of Education has moved with all possible haste to provide a safe and orderly learning environment for the students who were displaced by the fire and their teachers; and

WHEREAS, instructional services have been provided at the school site in mobile units which are rented at a monthly cost of approximately \$8,200 per month; and

WHEREAS, with the destruction of the auditorium there has been no on-campus facility for students and the community to use for programs and events; and

WHEREAS, the Board of Education did, in May, as provided by law, advise the Board of County Commissioners by letter of its need for an additional \$1.2 million for classrooms and \$4

million for an auditorium in its annual request to the Board of County Commissioners for funding; and

WHEREAS, the reconstruction of the Williams Township School is the utmost desire of the Williams Township Community, the students, teachers and school administration; and

WHEREAS, the cost of construction, less the insurance settlement, is \$5,650,366 in compliance with the wishes of the Williams Township Community; and

WHEREAS, the Board of Education lacks the financial resources to complete this project and pursuant to State Statute §115C-521(b) respectfully requests the Board of County Commissioners to exercise its duty under said statute and provide funds for the project.

We had very good cooperation from numerous agencies, businesses, fire and rescue departments, county employees, private citizens and many more. I would like for the people who helped and are here tonight to please stand and be recognized for your willingness to help. The people stood and were given a hand of applause.

Chairman Memory asked Mr. Hayes for a list of the names of everyone involved with helping this past weekend to enable the Board to send a letter of recognition.

Billy Joe Farmer, County Administrator, stated he would like to thank Mr. Hayes for putting together an Emergency Services Plan in which existed good cooperation from everyone involved, good harmony and good communication.

Chairman Memory stated that Ronnie Hayes, Emergency Services Director, has put together a good plan for everyone involved to utilize.

### GEORGE SOUTHERN - ALLEGED DISCRIMINATION:

George Southern, private citizen, stated he had been discriminated against by the Sheriff's Department. Mr. Southern stated the following:

- 1. My house was broken into by a man, along with four (4) children, and the man was not arrested or charged due to a payoff from one of the children's parents;
- 2. This incident happened on Saturday morning;
- 3. A lot of building repair material was taken and feces was left behind in several locations;
- 4. I, personally, caught this man and four (4) children breaking into my house;

- 5. I, also have an eye witness;
- 6. On June 14, 2004, this same type of crime was committed by two (2) black men who were immediately arrested and charged;
- 7. I have tried on several occasions to set up an appointment with Sheriff Batten and have not been able to do so; and
- 8. I strongly believe I am being discriminated against and I want the Board of County Commissioners to do something about this.

Sheriff Chris Batten stated the following:

- 1. I am aware of this incident and I assigned this to a Sergeant to handle due to the fact I cannot handle every case that comes through the Sheriff's Department; and
- 2. I am not aware of you not being contacted by the Sergeant, and I understood this incident had been handled by the District Attorney's office.

Chairman Memory informed Mr. Southern the Board of County Commissioners could not do anything about this situation due to the fact the Sheriff is an elected official and for him to work with Sheriff Batten in getting this matter resolved.

Sheriff Batten stated he would like for it to go on record that Mr. George Southern would be guaranteed a meeting with District Attorney Rex Gore and Sergeant Nobles regarding this matter.
