Agenda Items #1 and #2: MEETING CALLED to ORDER and INVOCATION:

At 7:30 P.M., Chairman Memory called the meeting to order. The invocation was delivered by Commissioner Godwin. Everyone in Attendance stood and pledged Allegiance to the Flag of the United States of America.

Agenda Item #3: BOARD MINUTES APPROVAL:

Commissioner Norris made a motion to approve the October 18, 2004 Regular Session Minutes, the October 18, 2004 Columbus County Water and Sewer District III Board Meeting and the October 25, 2004 Regular Session Minutes.

Agenda Item #4: WHITEVILLE ABC BOARD PRESENTATION:

Larry Moore, Chairman of the Whiteville ABC Board delivered the following presentation to the Board:

November 1, 2004

Dear County Commissioners:

Many individuals think of the local ABC Stores as merely the outlets that alcoholic beverages other than beer and wine are purchased for private consumption or by eating establishments and bars with proper permits for resale to their patrons. While this is partially true, very few individuals realize the amount of revenue that the local ABC Stores disburse to law enforcement and to the County General Fund. The Whiteville ABC Store also must make distributions to City Law Enforcement and the City of Whiteville General Fund.

The dollar amounts are based on the total profits of the individual stores. The percentages arc set by General Statutes. Tonight, the Board of Directors of the Whiteville ABC Store would like to present the Columbus County Board of Commissioners with two checks that total \$19,794.00. In addition to this amount, the Whiteville ABC Store has previously sent the County of Columbus \$1,462.28 from July 2004 through October 2004 to be used for alcohol and drug rehabilitation. You might want to check with Mr. Hill as he might be able to advise you as to whether or not this money might be used to help the Sheriff to offset some of his expenses in transporting alcoholics and drug addicts to Lumberton for evaluation. You will receive a check for drug and rehabilitation each month in amounts varying from approximately \$250.00 to \$350.00. We will also be sending a check each quarter to the County Manager for approximately \$2500.00 as an estimated payment on our General Fund distribution. If this amount proves to be too much or too little, because we will be paying estimated amounts quarterly, we will make the adjustment at the time of our annual audit to bring the amount in line with the actual amount of disbursements due to the County of Columbus.

I have enclosed a graph from The Fayetteville Observer and The Star-News both giving reports on distributions as required. You might find the differences in distributions throughout the region interesting.

The Board of the Whiteville ABC Store wishes you well in your endeavor to conduct the business of the County of Columbus. We can only hope that our contributions, albeit small, will be used to help the citizens of our county.

The Whiteville ABC Board consists of four (4) members, to wit: Oscar Edwards, John Hall, Larry Moore and Gary Bass who is presently in Afghanistan in active military service. Mr. Oscar Edwards is here with me tonight.

Commissioner Godwin stated he really appreciated what Mr. Moore was doing and asked if this amount of money was derived from the Whiteville store. Mr. Moore replied stating yes.

Mr. Moore stated the profit margin for the ABC Store was set by the State and the distribution to units of government were set by the State.

Agenda Item #5: PRIVATE CITIZEN PRESENTATION:

Ms. Alfreida L. Turner, private citizen, presented the following information to the Board for their consideration.

From: Alfreida Turner

I live on Causey Road in Fair Bluff. From the city limits sign to the South Carolina line is only about one mile. Most of this mile is farm land with maybe five houses. There were never any plans to put a water line on Causey Road. The Town of Fair Bluff will never run a water line past the city limits line on Causey Road. It would not be cost effective. I live in a little elbow with city limits and a cemetery on one end, the South Carolina line on the other end, the railroad on one side and the Lumber River on the other side. In order for the county to get water to me you would have to run a line through the Town of Fair Bluff which isn't feasible nor cost effective. I'm asking that you reconsider the District tax for those of us who live on Causey Road and take it off our tax bills. Please take all this into consideration and thank you very much for your time.

Commissioner Godwin stated there was not any way to undo the action the Board of Commissioners done this year relative to the District tax. We are, however, looking at different ways for next year due to situations like the one you presented.

Commissioner McKenzie stated he understands the situation and it was not my recommendation, but I am only one (1) out of seven (7). We have been informed that if seventy-five (75%) percent of the people hookup to the water system, then the taxes will go away, and you can believe my mission will be to encourage everyone to hookup.

Chairman Memory stated the 1997 Voting Ballot for water allowed this tax to be levied and if enough people will use the water, then the tax will disappear and we are doing everything we can to promote and entice people to use this water.

Agenda Item #6: TRANSPORTATION - COMMUNITY TRANSPORTATION GRANT FOR 2005-2006:

Charles Patton, Transportation Director, requested Board approval and authorization of signatures for the Community Transportation Grant for the year 2005-2006, inclusive of the

following documents:

- 2. Transportation Memorandum of Understanding;
- 3. DBE Good Faith Efforts Certification;
- 4. Title VI Program Report; and
- 5. Certificates and Assurances.

Commissioner McKenzie made a motion to approve and authorize signatures for the Community Transportation Grant for the year 2005-2006, inclusive of the above listed documents, seconded by Commissioner Norris. The motion so carried. The original documents will be kept on file in the Office of Columbus County Transportation, and a copy will be kept on file in the Office of the Clerk to the Board for review.

Agenda Item #7: SOCIAL SERVICES - WORK FIRST PLAN:

Mary B. Thompson, Social Work Program Manager, requested Board Approval of the 2005 Work First Plan.

Commissioner Godwin requested a brief synopsis of this program be presented. Mr. Algernon McKenzie stated the following:

- 1. This program is mandated by the State;
- 2. A county may choose to be a Standard or Elected County, meaning they can set their own policy or elect to use the State guidelines;;
- 3. This department must come up with a Plan of Action;
- 4. This is a biennial plan; and
- 5. One (1) important component of this program is TANF (Temporary Assistance for Needy Families).

. Commissioner McKenzie made a motion to approve the Work First Plan dated November 1, 2004, seconded by Vice Chairman Dutton. The motion so carried.

Agenda Item #8: COOPERATIVE EXTENSION - DEPARTMENTAL UPDATE:

Jackie Roseboro, Cooperative Extension Director, presented the following Departmental Update to the Board:

- 1. People tend to associate this department only with agriculture, but this department is highly diversified:
- 2. We are an educational agent and not a service agent;
- 3. We are an arm of NCAFT and North Carolina State University;
- 4. Through the programs we offer, we have generated more money from grants and contributions than the Columbus County Budget amount;
- 5. We are involved in community development such as the Farmer's Market which is open on Tuesdays, Thursdays and Saturdays, other programs are SARC, FCS, agriculture and 4-H;
- 6. We presently do not have as many 4-H groups as we once did, and this is due to the fact the 4-H groups are very time consuming, and there are not many people willing to donate the needed amount of free time that it entails;
- 7. I am handing out Program Surveys that I would like for you to fill out and return to the Clerk to the Board by November 14, 2004; and
- 8. I would like to extend an invitation to you to our Annual Dinner and Report on January 18, 2005, at 6:00 P.M., at Cooperative Extension.

Commissioner Godwin stated he was serving on a committee that is very active in lobbying issues in the General Assembly relative to Cooperative Extension.

Commissioner McKenzie stated he appreciated what Ms. Roseboro was doing and thanked her for a job well done.

Agenda Item #9: SOLID WASTE - APPROVAL of ADDITIONAL DAYS for CONVENIENCE CENTERS:

Chuck Stanley, Solid Waste Director, requested Board approval of two (2) additional days of operation, per site, per week, for the Columbus County Convenience and Recycling Centers and

approval of a Budget Amendment in the amount of twenty-five thousand and 00/100 (\$25,000.00) dollars for the expenditure of such.

- Mr. Stanley stated the following:
- 1. Columbus County will start handling white goods in lieu of having Waste Management pick up;
- 2. We can sell these white goods for a profit to be used at the centers;
- 3. These two (2) additional days will be effective as of December 1, 2004;
- 4. The China Grove Site will be up and running by December 1, 2004; and
- 5. The centers will be closed on Tuesdays and Sundays, and will be open on the other days of the week.

Vice Chairman Dutton made a motion to approve the two (2) additional days of operation, per site, per week, for the Columbus County Convenience and Recycling Centers and approval of a Budget Amendment in the amount of twenty-five thousand and 00/100 (\$25,000.00) dollars, seconded by Commissioner Wilson. The motion so carried.

Agenda Item #14: <u>COMMENTS</u>:

Chairman Memory opened the floor for comments from anyone who would like to render such. The following people spoke.

A. Public:

Mary Alice Thompson: stated the following:

- 1. The Flea Market in Chadbourn was forced to close down due to there being no sprinkler system;
- 2. Three (3) weeks ago the Planters Warehouse was cited for not having a sprinkler system;
- 3. We own this warehouse in the Chadbourn area and rent the space out;
- 4. We have been informed this sprinkler system must be installed by a State certified

- sprinkler company;
- 5. We have received an estimate for this needed sprinkler system from a State certified company for the price of seventy-five thousand and 00/100 (\$75,000.00) dollars to eighty thousand and 00/100 (\$80,000.00) for the inside and thirty thousand and 00/100 (\$30,000.00) dollars for the outside for the forty thousand (40,000) square foot building;
- 6. We have also obtained an estimate from a local contractor for the price of twenty-five thousand and 00/100 (\$25,000.00) dollars;
- 7. As is evident, the difference in these two (2) quotes is substantial and we simply cannot afford to pay the amount quoted from the State certified company;
- 8. The space in our warehouse is rented to a company that wishes to continue utilizing the space;
- 9. I am requesting direction from the Board as to what can be done or, whatever help you can render in getting this matter resolved; and
- 10. As you are aware, there are many vacant tobacco warehouses in Columbus County and I would like to know what are we going to do with them.

Chairman Memory stated Columbus County cannot circumvent the State Fire Code.

Commissioner Godwin suggested the Board send a letter to the appropriate parties in reference to the economic development this requirement will have on Columbus County and it is my understanding that if the warehouse is family owned and operated as a business, then this does not apply.

Commissioner McKenzie asked the question as to what we can do with all of these vacant tobacco warehouses.

OTHER:

Water Fluoridation in Columbus County:

Dr. Randolph Matthews made the following presentation to the Board relative to fluoridation of the water within Columbus County. Dr. Matthews stated he, along with Dr. Darryl J. Diefes, DDS and Dr. Sidney Gibson, DDS, were working on grants that would pay for the expense of this process, but the grants had not been completed.

Columbus Pediatrics & Adolescent

"Water Fluoridation has been recognized by the Centers for Disease Control and Prevention as one of the 10 great public health achievements of the 20th century."

Richard Mascola D.D.S. President ADA

Reasons to fluoridate the water

- 1. Efficacy:
- Fluoridated communities have noted up to a 75% reduction in cavities over 15 years.
- Although most effective in developing teeth, fluoridation decreases adult cavities 20.30%.
- Children in fluoridated areas have 60% fewer cavities than those in non-fluoridated areas.
- Thanks to water fluoridation, half of children (5-17 yrs) have never had a cavity in their permanent teeth.
- 2 Safety:
- Since 1950, the ADA has stated officially that water fluoridation is safe. This statement was and is supported by an overwhelming weight of credible scientific evidence.
- Throughout over 55 years of research, water fluoridation "one of the most widely studied public health measures in history" consistently indicate that fluoridation of community water supplies is safe.
- 2/3 of the US is on fluoridated water without increase of disease that can be linked to fluoride.
- Some communities (such as Charlotte) have had fluoridated water since the 1940's without an epidemic of fluorosis or other health problem.
- 3 Compliance: Ease in getting people to follow treatment guidelines:
- Children that live in non-fluoridated areas are supposed to take fluoride supplements daily from age 6 months until they reach 17 years old. It is very difficult for people to remember

- to take a daily medication for 16 years.
- Many children get their medical care elsewhere where the water is fluoridated (Lumberton and Wilmington). These physicians often are unaware that our community is not fluoridated and do not know to prescribe fluoride supplements.
- A prescription is required to obtain fluoride supplements. That in itself is a barrier to compliance. How many people remember to call for refills when the prescription runs out?
- Fluoride, added to the water supply, is tasteless. It affects neither water quality nor taste.
- 4 Nondiscriminatory:
- When water is fluoridated, the availability of fluoride is not limited to families that can afford to pay for the prescriptions, or to pay for physician visits to get the prescriptions.
- Large groups of people can benefit in a manner that does not discriminate against any group, regardless of age, race, gender, ethnicity, religion, educational status, socioeconomic level or any other demographic categorization.
- 5 Cost:
- Fluoride tablets cost \$12.50 for 100 tablets. Over \$45/child/year. (Times 16 years = total cost of over \$700/child).
- For communities of 20,000 or more, it costs 50 cents/yr/person to fluoridate.
- Every dollar invested in fluoridating water, saves \$38 in dental treatment costs.
- Funding programs exists that can pay for all or most of the cost of fluoridation.

Questions and Answers:

1 What about fluorosis?

Optimally fluoridated water with proper use of topical fluoride does not cause health risks. The only known risk associated with excessive fluoride usage is enamel (dental) fluorosis. Fluorosis is a mild cosmetic effect with no health consequences. Since the teeth are fully formed by six years, there is no risk of fluorosis beyond this age. 94% of all cases of fluorosis in the US is the mild type, characterized by barely noticeable white lacy markings across a tooth's surface. This type of fluorosis is not readily apparent to the affected individual nor to the casual observer. It should be noted that not all changes in tooth appearance is fluorosis. When the benefits of fewer cavities is weighed against the risk of mild fluorosis the balance favors the benefits of water fluoridation.

What about water district 2 which has .73 ppm of Fluoride in the water naturally?

The optimum fluoride concentration should be .7 - 1.2 ppm. Water district 2 would not need to have extra fluoridation. However most residents currently are not aware what district they belong to. They do not know whether to take fluoride supplements or not. I always urge people to call the water dept. to determine their district. I tell them to stop the supplement *if* in water district 2. Most do not go to the trouble. The best way to remove the confusion is to fluoridate the entire water supply so people will not wonder whether or not to supplement.

What about the wells in the area that have fluoride?

Most wells do not have adequate fluoride and supplementation is needed. However some wells have too much fluoride and cause a risk of fluorosis. Yet folks would rather not change to county/city water because there is not enough fluoride there. The best option to give them is the choice of changing to the optimum fluoride level in the city/county water supply. That can only occur if we fluoridate the water

Discussion was conducted relative to the reasons of fluoride being located in certain parts of Columbus County and the adequate levels and safety of fluoride. Due to the discrepancy in the fluoride levels in State published documents and Dr. Matthews' information, Leroy Sellers, Public Utilities Director, will conduct discovery on this matter and set up a meeting with Dr. Matthews, if needed.

CDBG Concentrated Needs Grant for 2005-2006 - Authorization to Apply:

Commissioner McKenzie stated this matter was tabled at the October 18, 2004 Board Meeting and needed to be addressed at this meeting.

Commissioner McKenzie made a motion to approve the authorization to apply for the 2005-

2006 Concentrated Needs CDBG Grant in the amount of seven hundred thousand and 00/100 (\$700,000.00) dollars with a local ten (10%) percent match of seventy thousand and 00/100 \$70,000.00) dollars, seconded by Commissioner Norris.

Discussion was conducted among the Board members relative to who would be administering the grant.

Billy Joe Farmer, County Manager, stated we could proceed with applying for this grant now and reach the decision regarding who would administer the grant, and if we wanted to even accept the grant, if approved, at a later date.

Further discussion was conducted among the Board relative to what the grant entailed as to the standpoint of Columbus County.

A straw poll vote was taken with the following results:
