Mr. Buck stated the following relative to the request made for the waiver of the permit fees and electrical inspection fees:

- 1. Columbus County Schools are trying to meet the State mandate by the specified time frame;
- 2. This concrete poles will enhance our Wide Access Network (WAN); and
- 3. There are twenty-three (23) locations that need these concrete poles erected.

Commissioner McKenzie asked Mr. Buck why he was requesting the waiver of the fees. Mr. Buck replied stating Columbus County Schools anticipated the electrical inspections, but did not anticipate the permit fees for these poles

Commissioner Godwin asked Mr. Buck what was the source of the funds they were using for this project. Mr. Buck replied stating eighty-three (83%) percent was State funds and seventeen (17%) percent was local school funds and the total project cost was two hundred eighty thousand and 00/100 (\$280,000.00) dollars.

Darren Currie, Assistant County Manager, asked Mr. Buck how tall were these poles. Mr. Buck replied stating the poles were one hundred to one hundred forty (100' - 140') feet in height.

After discussion was conducted among the Board members, it was the overall opinion of the Board that if this fee was waived, it could lead to many more requests of this nature being made, and eventually, the Inspections Department would not have enough revenue to operate efficiently.

Commissioner Wilson made a motion to deny the request for the waiver of the permit fees and electrical inspection fees for the concrete poles as requested by Columbus County Schools, seconded by Commissioner McKenzie. The motion so carried.

Agenda Item #6: PROCLAMATION - ADOPTION AWARENESS MONTH 2004:

Marva Scott, Director of Social Services, requested Board approval and adoption of the following Proclamation.

Commissioner Gene Wilson requested Board approval of the purchase of one (1) acre of land, which has been under option as of October 20, 2004, from Larry A. Hinson, at the price of ten thousand and 00/100 (\$10,000.00) dollars to be used as a convenience center in the Evergreen Community.

After discussion was conducted by the Board members, it was established this is a new site and does not replace any other site and the Grice site has been closed.

Doug Klier, private citizen, asked what the cost of this land was. Commissioner Wilson replied stating the cost was ten thousand and 00/100 (\$10,000.00) dollars.

Commissioner McKenzie made a motion to approve the purchase of one (1) acre of land to be used for a Convenience Center, from Larry A. Hinson, at the cost of ten thousand and 00/100 (\$10,000.00) dollars, seconded by Commissioner Godwin. The motion so carried.

Agenda Item #8: <u>RESOLUTION - RESOLUTION REQUESTING RELIEF and</u> <u>DIRECTION for TOBACCO WAREHOUSE CONVERSIONS</u>:

Commissioner Kipling Godwin requested Board approval and adoption of the following Resolution.

<u>RESOLUTION</u> REQUESTING RELIEF and DIRECTION for TOBACCO WAREHOUSE CONVERSIONS

WHEREAS, throughout the State of North Carolina and within Columbus County, there are numerous tobacco warehouses that are now vacant as a result of the changes in the tobacco industry including the Tobacco Quota Buyout Program; and

WHEREAS, the citizens within Columbus County who own these tobacco warehouses are attempting to salvage them by converting them to other uses and/or renting them to companies and businesses, thus, avoiding the impact of closing large usable facilities; and

WHEREAS, it is our understanding that under the current State Fire Code, these tobacco

warehouses, if utilized by anyone other than the owner, are required to install a sprinkler system by a State certified contractor; and

WHEREAS, due to the present condition of the economy, very few warehouse owners can afford to operate these large warehouses themselves, and if rented, the requirement of a sprinkler system installed by a State certified contractor will place an undue financial burden on the owners or force the warehouses to remain vacant; **and**

WHEREAS, the Columbus County economy has been largely based on tobacco and textiles, and, due to the relocation, downsizing and closing of many of those businesses, and the changes in the tobacco industry, we have suffered a tremendous economic loss; and

WHEREAS, our unemployment rate continues to be higher than the State and national averages as a result of the closing of our industries and many of our workforce have been forced to relocate seeking employment out of the county; and

WHEREAS, Columbus County is desirous of relief from the negative impact the current State Fire Code has placed on our citizens, and is seeking direction from you as to what avenue we could take to give our citizens relief from this burden.

NOW, THEREFORE, BE IT RESOLVED the Columbus County Board of Commissioners is seeking relief and direction from you relative to the utilization of the numerous vacant tobacco warehouses resulting from the changes in the tobacco industry including the Tobacco Quota Buyout Program.

Agenda Item #9: <u>WRIGHT CORPORATION WATER MAIN EXTENSION -</u> <u>AMENDMENT NUMBER TWO (2)</u>:

Natalie Carroll, Project Manager, requested Board approval of the following Amendment Number Two (2) to the Agreement for Professional Engineering Services For Columbus County, Wright Corporation Water Main Extension.

AMENDMENT NO. 2 TO THE AGREEMENT FOR PROFESSIONAL ENGINEERING SERVICES FOR COLUMBUS COUNTY WRIGHT CORPORATION WATER MAIN EXTENSION

This AMENDMENT NO 2 made this _____ day of _____,2004, to the agreement for professional engineering services dated July 7, 2003, by and between Columbus County (hereinafter called "OWNER") and McKIM & CREED, P.A., a professional corporation under the laws of the STATE OF NORTH CAROLINA, for itself and its successors and assigns (hereinafter called the "CONSULTANT").

WITNESSETH:

WHEREAS, the Owner has retained the Consultant to furnish professional engineering and construction administration services in connection with preparation of a water main extension along US Highway 74 as an amendment to the <u>Wright Corporation Water Main Extension Project</u>.

Specific tasks include:

• Design of approximately 2,500 linear feet of 6-inch diameter water main to include fire hydrants, water services, and appurtenances.

- Preparation of detailed plans and technical specifications for construction
- Preparation and submittal of application to all pertinent reviewing agencies
- Preparation itemized quantities for construction by selected contractor
- Construction Administration and Project Closeout Services
- Construction Observation

NOW, THEREFORE, the Owner and the Consultant agree as follows:

I. PROJECT UNDERSTANDING

Design 2,500 feet of 6-inch PVC water main. The new main will be installed within the existing rights-ofway of US Highway 74 beginning at the intersection of SR 1871 Edgecombe Road and running northwest along US Highway 74. This water main will provide potable water service to businesses and residents along this route.

Consultant will provide design, permitting and production of plans and specifications for construction. We will also provide Construction Administration and Construction Observation. Record drawings will be provided to the owner and certifications to NCDENR to allow public use of the new facilities.

II. SCOPE OF SERVICES

The Consultant agrees to provide professional services and assistance to the Owner as follows:

A. Design Services

1. Meet with NCDOT staff to review project scope and to obtain information relative to NCDOT rightsof-way.

2. Perform field reconnaissance of the water main routes to determine route feasibility, including potential construction conflicts. Coordinate preliminary design and route of the water main with NCDOT staff and Columbus County staff.

3. Prepare construction plans at a scale of 1 "=50 feet Horizontal with plan view only. Profile data is not required by NCDENR for permit approval and will not be included unless pertinent to construction of the project. Plans will be completed in either planimetric format or using aerial photography at the discretion of the Engineer.

4. Compile quantity take-off for project and prepare bid form with unit items and measurement of payment specifications.

5. Prepare contract technical specifications as required to supplement current specifications.

6. Submit 100% design documents to NCDOT, NCDENR Public Water Supply Branch, NCDENR Land Qualify, NCDENR Stormwater Management, and all other necessary review and permitting agencies as required. Note that actual permit fees will be paid by Columbus County.

7. Receive and respond to review comments from review and permitting agencies.

- B. Construction Stage
- 1. Coordinate with selected contractor for scheduling of installation of the proposed improvements.
- 2. Schedule and conduct progress meetings on a monthly basis. Prepare and distribute minutes.
- 3. Review and approve shop drawings from Contractor.
- 4. Provide field observation at approximately 20 hours per week for a 4-week construction period.

Prepare field reports on a weekly basis and provide to Columbus County. This report shall detail and provide chronology of events occurring or observed during the period that the field observer was present. This report will include quantity measurements for payment.

5. Endeavor to resolve problems in a timely manner as work proceeds and involve appropriate parties in resolving disputes and problems associated with the project.

6. Pay request review and recommendation for payment to Columbus County.

7. Change Order review and recommendation to Columbus.

8. Perform inspections of project at Substantial and Final Completion. Prepare punch-list and coordinate completion of punch-list items with Contractor.

9. Provide record drawings and certification of project completion. This shall include submittal of asbuilt drawings (mylar) and completion of closeout documentation for project. Electronic files of the final project as constructed will be provided for implementation in the County 013 system. Engineer's certification shall be as required by the NCDENR Public Water Supply Branch.

C. Additional Services

Additional professional services will be provided (within the qualifications of the Consultant and associate firms) upon request by the Owner or upon authorization by the Owner following recommendation of the Consultant. Additional services shall include, but not be limited to the following:

1. Provide Construction Administration or Construction Observation beyond what has been delineated in this Agreement.

2. Design Services and Bid/Award Services beyond what has been delineated in this Agreement.

3. Provide Environmental Assessments, Environmental Impact Statements or biological surveys for endangered species.

4. Redesign of facilities after approval of final plans.

III, PAYMENTS TO THE CONSULTANT

The Owner agrees to pay the Consultant as compensation for their services as follows for Amendment No. 2:

Α.	Design	\$4,500 (Lump Sum)
C.	Construction Administration/Observation	\$3,400 (Lump Sum)
	Total Fee	\$7,900 (lump sum)

D. Additional Services. The Owner, at his discretion, may contract with the Consultant to perform additional services for this project. Compensation shall be a negotiated fee commensurate with the services required.

Mr. Carroll stated with the present dollar amount limit of two hundred and 00/100 (\$200.00) dollars, there was very little paperwork being eliminated, and if the amount was increased to five hundred and 00/100 (\$500.00) dollars, this would speed the process up and eliminate a lot of paperwork being done.

Commissioner Godwin made a motion to approve the dollar amount limit of two hundred and 00/100 (\$200.00) dollars for the requirement of a purchase order to be done, to the dollar amount limit of five hundred and 00/100 (\$500.00) dollars, seconded by Commissioner Jacobs. The motion so carried.

Agenda Item #13: <u>ADMINISTRATION - APPROVAL of the FOLLOWING ITEMS</u>:

Billy Joe Farmer, County Manager, requested Board approval of the following three (3) items.

A. <u>Receipt of the Pay Plan, as Presented, for Approval and Adoption;</u>

Chris May, Cape Fear Council of Governments, stated the following relative to the new Pay Plan which he was retained by Columbus County to prepare:

- 1. This study has taken one (1) year to complete from start to finish;
- 2. I initially started with the Institute of Government and discovered the information was not inclusive of all the details that was needed to complete this study;

- 3. I then visited different counties to obtain the needed information;
- 4. Columbus County has approximately seven hundred (700) employees, including part-time employees;
- 5. I used the salary comparisons from Bladen, Robeson and Pender Counties;
- 6. These figures represent a regional average;
- 7. Hopefully, each employee will be starting at an average amount;
- 8. The job descriptoin describes what each employee does;
- 9. This study is a thorough study;
- 10. I discovered in the Health Department and in the Department of Social Services, there were exceptions where certain positions and classifications are mandated and cannot be changed;
- 11. In Cooperative Extension, the salaries are subsidized and had to be handled in a different manner;
- 12. Each step is a two and one-half $(2 \frac{1}{2})$ percent increase;
- 13. Each grade is a five (5%) percent increase; and
- 14. I am presenting to you three (3) options of which I will recommend the middle option which is the Hold Harmless Option which will entail the amount of sixty-seven and 00/100 (\$67,000.00) dollars to implement.

A copy of this Pay Plan was distributed to the County Commissioners previous to the Board Meeting. The Clerk to the Board did not receive a copy of this said document for reference. A copy of this Pay Plan is expected to be kept on file in the Administration Office, or in the office of Chris May, Cape Fear Council of Governments, for inspection.

In-depth discussion was conducted among the Board members relative to the best option to select, and whether to make it retroactive back to July 1, 2004.

Commissioner McKenzie made a motion to approve and adopt the Pay Plan, as presented, utilizing the Option B: Hold Harmless Option, to be made retroactive back to July 1, 2004, to be implemented immediately and to be included in the November, 2004 paychecks. This motion was seconded by Commissioner Norris. The motion so carried.

Yvonne Norris, Social Services employee, asked if the employees would be receiving this information on paper. Darren Currie, Assistant County Manager, stated he would send a slip to each Department Head to be shared with their employees.

Doug Klier: How many people have signed up for county water since the special fee has been

offered? Leroy Sellers, Public Utilities Director, replied stating approximately seventy (70) and the deadline is January 03, 2005. Mr. Klier stated there is not enough people that knows about this and whatever means you are using to let them know is not working. You need to try another method to distribute this information to the general public.
