#### 7:15 P.M.: PUBLIC HEARING - Application for Scattered Site 2005 Community **Development Block Grant:**

Chairman Memory called the Public Hearing to order and stated the purpose of the Public Hearing is to receive views and opinions from the citizens of Columbus County with regard to community development and housing needs. Chairman Memory requested Floyd Adams, The Adams Company, Incorporated, to present an overview of what this application entailed.

Floyd Adams, The Adams Company, Incorporated, stated the following:

- In 2005, Columbus County is in line for a Community Development Block Grant in the 1. amount of four hundred thousand and 00/100 (\$400,000.00) dollars;
- 2. This grant is for very low income families and severe housing conditions;
- 3. An Advisory Committee has been established relative to this grant;
- 4. This is a three to four (3-4) months process;
- 5. Out of the last Community Development Block Grant for four hundred thousand and 00/100 (\$400,000.00) dollars, we were able to do only seven (7) houses;
- 6. The handicapped and the elderly citizens will be a priority in this grant; and
- 7. The conditions for eligibility have changed.

Commissioner McKenzie asked Mr. Adams if he could start on the old list of applicants from the previous grant at the point of where he left off. Mr. Adams replied stating no he could not, and that was one of the conditions that changed, and everyone interested would have to reapply or apply for the first time.

Commissioner Godwin suggested that whoever had the old list of people who had applied for the previous grant, but were not awarded, needed to be sent a letter informing them they needed to reapply for this grant. Commissioner Godwin asked Mr. Adams if he would apply the same standards as were recommended for the previous grant to this grant. Mr. Adams replied stating yes.

Commissioner Norris asked Mr. Adams how many houses did he anticipate doing with this grant money. Mr. Adams stating it would depend on the conditions involved, but the number would probably be six or seven (6 or 7) at the most.

Commissioner Jacobs asked if there was any particular area that would be chosen. Mr. Adams replied stating no, the locations could be anyway within Columbus County.

Commissioner Godwin asked if it was true that towns and cities cannot apply for this type grant anymore. Mr. Adams replied stating yes it was true.

#### **Article VI. Leaves of Absence:**

#### **Section 9: Vacation Leave - Previous Credits**

Vacation leave credits accumulated by each employee as of the adoption of this Personnel **Administration Policy** 

shall be retained as of the effective date of the policy. Annual leave hours accumulated in another state or a local agency may not be transferred to Columbus County.

#### **Section 17: Previous Leave Credits**

Sick leave credits accumulated by each County employee shall be retained as of the effective date of this policy. Sick leave accumulated with other government employers may be transferred to Columbus county, subject to the following conditions:

- Employee must be an active enrollee in a state or local government retirement system under the umbrella of the North Carolina State Treasury Department.
- 2. Upon employment, Columbus County will apply the transferred sick leave, up to the maximum amount of sick leave in which the employee would earn in a year under the Columbus County Personnel Policy, to the employee's account.
- 3. Each year thereafter, 10 days of the employee's sick leave transfer balance will be applied to the employee's county sick leave account until all transferred sick leave has been applied.
- 4. It is the responsibility of the employee to furnish to the Personnel Department a statement of accumulated sick leave from the previous employer.
- 5. In the event of termination of employment, all transferred sick leave not applied to the employee's account will be lost.

#### **PUBLIC FACILITIES AGREEMENT**

THIS AGREEMENT (the "Agreement") is entered into as of the 6th day of December 2004 by and between Wright Corporation, a corporation authorized to transact business within the State of North Carolina (hereinafter referred to as the "Corporation") and Columbus County, North Carolina (hereinafter referred to as the "Applicant"). This Agreement will not become effective until all conditions placed upon the Applicant's funding approval are satisfied and funds are released by the Department of Commerce (hereinafter "DOC") pursuant to a Industrial Development Fund grant (hereinafter "IDF") with the Applicant.

#### WITNESSETH

WHEREAS, the Applicant anticipates receiving an Industrial Development Fund grant from the Department of Commerce in the amount of \$500,000 to be used to finance the economic development project to be undertaken by the Applicant and the Corporation (the "Project").

NOW, THEREFORE, in consideration of the promised and the mutual covenants and promises set forth herein, the Corporation and the Applicant hereby agree as follows:

#### I. AGREED ACTIONS

- A. The Corporation shall execute its responsibilities as identified in Corporation's narrative exhibits and the employment profiles contained in the Applicant's IDF application to DOC. Those exhibits and commitments are incorporated herein by reference, as if set out in full. The Corporation agrees to build and operate the Project in a timely manner. Briefly, those documents describe the construction of (or expansion of) a 0.125 million gallon per day (MGD) wastewater treatment plant facility (the "Facility") on a 2.37 acre site located in/adjacent to the Riegelwood area in Columbus County, North Carolina (the "County"). The Corporation currently has continuing operations in the County which employ 84 people and they commit to employ four (4) additional people by January 30, 2007 and maintain that employment level until the grant is closed by DOC. The Corporation agrees that if it fails to create and maintain \_\_\_\_\_? \_\_\_\_ jobs prior to January 30, 2007, it will reimburse DOC \$5,000 for each job not created. The Corporation's liability under this Agreement shall not exceed the dollar amount of the grant made by the Department of Commerce. If unforeseen calamity, an Act of God or financial disaster is the cause of action under this section of the Agreement, the Corporation and the Applicant may appeal to DOC for an extraordinary modification of this responsibility. Such modification shall be at the discretion of the Secretary of the Department of Commerce.
- B. Each party shall keep and maintain books, records, and other documents relating directly to the receipt and disbursement of grant funds and fulfillment of this Agreement.
- C. Each party agrees that any duly authorized representative of the Applicant, DOC, the United States Department of Housing and Urban Development, and the Comptroller General of the United States shall, at all reasonable times, have access to and the right to inspect, copy, audit, and examine all of the books, records, and other documents relating to the grant and the fulfillment of the Agreement for a period of three (3) years following the completion of all close-out procedures respecting the IDF funds, and the final settlement and conclusion of all issues arising out of the IDF funds.
- D. Not withstanding anything herein to the contrary, the parties hereto acknowledge the due execution of the IDF Grant Agreement between the Applicant and DOC and agree that any conflict between the provisions, requirements, duties, or obligations of this Agreement and the IDF Grant Agreement shall be resolved in favor of the IDF Grant Agreement.

#### II. ENFORCEMENT

- A. If at the end of the approved project period the Corporation has failed to retain the full number of job positions presented in Agreed Actions Section I of this Agreement, or to incur the full level of private investment committed to in its grant application, as provided above, then the Corporation will pay to the Applicant an amount calculated in the manner set out in Section I-A of this Agreement.
- B. This Agreement constitutes a legally enforceable contract and shall be governed and construed in accordance with the laws of the State of North Carolina.

This Agreement made and entered into this 1<sup>st</sup> day of November 2004, by and between the Town of <u>Chadbourn</u>, a municipal corporation having charter granted by the State of North Carolina, hereafter referred to as "Municipality", and Columbus County, a body politic and a subdivision of the State of North Carolina, hereafter referred to as "County";

WHEREAS, the Municipality is desirous of having the County inspect and have enforcement authority within said Municipality's corporate limits and extraterritorial jurisdiction.

WHEREAS, the County, in accordance with and under the auspices of N.C. General Statute 160A-461, will enter into an Interlocal Agreement for the purpose of conducting building inspections; and

WHEREAS, under 160A-360, a Municipality and County may, by agreement, cede its territory to the other for the purpose of enforcement of select ordinances and regulations.

NOW, THEREFORE, in consideration of the premises and the mutual covenants and agreements of the parties, the parties hereto agree as follows:

- 1. Term. The term of this annual Agreement is from November 1, 2004 through June 30, 2005 and shall automatically renew each year unless terminated as provided herein.
- 2. Responsibilities.
  - A Municipality. The Municipality agrees to:
    - a. provide any pre-permit reviews of any applicable Municipal ordinances or regulations;
    - b. provide certification (where necessary) that said plans are in accordance with Municipal regulations, plans, and other documentation needed for review under applicable zoning codes;
    - c. adopt the County's current building code fee schedule;
    - d. adopt the current County's Fire Prevention and Protection Ordinance and applicable fee schedule;
    - e. collect any applicable zoning permit fees and issue zoning permits in accordance with the town's zoning ordinance;
    - f. not hold County responsible for enforcement of any other Municipal ordinance or regulations unless specifically contracted for.
  - B. County. The County agrees to:
    - a. provide all applicable inspections in regards to buildings, plumbing, HVAC, and electrical in accordance with the North Carolina Building Codes;
    - b. issue all permits under this ordinance;
    - c. perform site inspections as necessary;
    - d. collect and deposit into the county's bank account all fees associated with building inspections.
    - e. provide the Town a copy of all Certificate of Occupancies.
- 3. Termination. This agreement may be terminated by thirty (30) days written notice and upon mutual agreement by and between the County and Municipality.
- 4. Entire Agreement. This Agreement is the only agreement between the parties and contains all the terms agreed upon.

- 10. The month of October is Fire Prevention Month and our office participated in several programs for children during this month, and assisted several county fire and rescue departments with their programs;
- 11. We work diligently with the County fire and rescue departments, local insurance companies and serve on various committees which assist with all aspects of fire prevent and safety in the County;
- 12. We recently updated the County Fire Protection and Prevention Ordinance to comply with the State Code; and
- 13. We would like to thank the County Commissioners for their support and advice throughout last year.

On behalf of John Ward, Chairman of the Board of Trustees for the Nakina Fire and Rescue Department, David L. Dutton, Jr. requested the Board to establish a date, place and time for a Public Hearing to be conducted relative to the new Substation in the Pireway area..

Commissioner Dutton made a motion to establish Tuesday, December 28, 2004, at 7:00 P.M., at Olyphic Missionary Baptist Church, in the Fellowship Hall, located at 19062 Seven Creeks Highway (Highway 905), Tabor City, North Carolina 28463 as the date for the Public Hearing for the new Substation in the Pireway area. This motion was seconded by Commissioner Norris. The motion so carried.

### Agenda Item#13: TAX - ADOPTION of the SCHEDULES, STANDARDS and RULES for the 2005 OCTENNIAL REVALUATION:

James E. Hill, Jr., Columbus County Attorney, orally read the contents of N.C.G.S. §105-283: Uniform appraisal standards, and N.C.G.S. §105-317: Appraisal of real property; adoption of schedules, standards and rules, to the audience for their information and stated the following:

- 1. There are many other General Statutes pertaining to this topic, but these are the main ones;
- 2. North Carolina law states a revaluation must take place every eight (8) years and some counties are electing to do this more frequent; and
- 3. The Schedules, Standards and Rules must be adopted by the Board by January 01, 2005.

Chairman Jacobs request Richard Gore, Columbus County Tax Administrator, to give an overview of the revaluation for the benefit of the audience. Mr. Gore stated the following:

- 1. The revaluation was conducted in-house this time, and all previous times it has been contracted out;
- 2. We have to keep up with sales of real property daily;
- 3. This revaluation was better than any performed previously due to the advanced equipment we had at our disposal;
- 4. After the notices are mailed out, if anyone should detect a discrepancy, they can contact the Tax Office and we will be glad to check into this; and
- 5. This was a very efficient way to conduct the revaluation

Commissioner Godwin asked Mr. Gore if the tobacco quota had been taken into consideration. Mr. Gore replied stating no, the tobacco buyout occurred in the last two (2) years. Commissioner Godwin asked is the appraisal at par value. Mr. Gore replied stating yes.

Commissioner Memory asked Mr. Gore what areas did the thirty-five (35%) percent to forty (40%) percent increase occur. Mr. Gore replied stating this percentage is an average with some properties not increasing this much, and some properties may have increased more. This appraisal is an accurate picture of the value for all the property within Columbus County based on the fair market value.

A question arose from the audience relative to mobile homes. Mr. Gore replied stating that single-wide mobile homes are valued annually and treated like automobiles. Double-wide mobile homes, depending on the type of setup, could be considered as real property and are priced in a separate category.

Commissioner Prevatte stated that forty (40%) percent was quoted at the Public Hearing and that is does not take seventy-five (75%) percent and forty (40%) percent to make one hundred (100%) percent.

James H. Edwards, Inland Associates, Incorporated, assisted Richard Gore in the revaluation process. He stated the following:

- 1. The new construction that has occurred since 1997 is not on the books; and
- 2. There is no final tally yet.

Commissioner Memory asked Mr. Edwards if inflation was taken into consideration in the revaluation process. Mr. Edwards replied stating a 20.4 CPI was taken into consideration.

Commissioner Prevatte asked if the revaluation amount and the County tax rate set could be set at a neutral amount where the citizens' property taxes would not increase. Mr. Edwards replied stating we live in a capitalistic society and people want a profit when their property is sold.

Commissioner McKenzie asked if Columbus County has to change the tax rate. James E. Hill, Jr., Columbus County Attorney, replied stating the tax rate is not up, at this time, for consideration. That discussion will occur during the next Budget Process. Legally, the Board of Commissioners must adopt the Schedule of Values by January 1, 2005.

#### Agenda Item #26: <u>COMMENTS</u>:

Chairman Jacobs opened the floor up for comments. The following people spoke.

#### A. Public:

- 1. **Mike Barnes:** What concerns me the most is I live in a mobile home that is constantly depreciating, yet my property taxes are not decreasing. I would like to know why.
- 2. **Sammy Hinson:** stated the following:
  - A. As a citizen, I am concerned about the revaluation and tax rate for the citizens of Columbus County;
  - B. The following three (3) things should be taken into consideration;
    - i. Low wealth county;
    - ii. High tax rate keeps industry away; and
    - iii. No jobs are available in Columbus County;
  - C. A large portion of our elderly citizens depended on their tobacco quota for rental income and now, that is gone; and
  - D The County Government should eliminate needless spending.
- 3. **Ricky Dean Gore:** stated the following:
  - A. I am a farmer myself;
  - B. If there is no tobacco allotment on a farm, then there is no land value;
  - C. I am really concerned about our elderly citizens who live on fixed incomes;
  - D. I really appreciate what the County Commissioners do for our citizens; and
  - E. Please keep these things in mind when you make your decisions.

- 4. Ervin Wadus Stocks: stated the following:
  - A. I would like to know why Lake Waccamaw property is valued per foot for road frontage;
  - B. Property in Waccamaw Shores is valued higher than other property in the area;
  - C. I think this is very unfair; and
  - D. Consideration should be given that all road frontage per foot property in Lake Waccamaw be valued the same.

Richard Gore, Tax Administrator, stated that land prices are determined by market sales.

Commissioner McKenzie asked if anyone in the audience had any recommendations for the Board to consider. A lot of people have stated their dislike for the process, but no one has offered any solutions.

A question arose from the audience relative to what determines true value of real property. James E. Hill, Jr., Columbus County Attorney, replied stating true value of real property is determined by equivalent sales in Columbus County for the last two (2) years.

Robert Adams, private citizen, stated that anyone who had concerns or would like to have input should attend the Budget Work Sessions that will be held by the Board of Commissioners in the early Spring of 2005.

Commissioner Memory made a motion to approve and adopt the Schedules, Standards and Rules for the 2005 Octennial Revaluation, seconded by Commissioner Norris.

A role call was taken with the following results:
