Public Hearing:

NCDOT Rural Operating Assistance Program (ROAP) - the purpose of this Public Hearing is to afford the citizens the opportunity for input into the proposed application for funding and operation of the ROAP Program.

PUBLIC HEARING OPENED:

At 7:15 P.M., Commissioner Dutton made a motion to open the NCDOT Rural Operating Assistance Program (ROAP) Public Hearing, seconded by Commissioner Norris. The motion so carried.

Chairman Jacobs requested Charles Patton, Transportation Director, to give a brief overview of this program. Mr. Patton stated the following:

- 1. This is a yearly program;
- 2. This money is one hundred (100%) percent grant money;
- 3. This program is made up of three (3) parts as follows:
 - A. Elderly and Disabled Transportation Assistance Program (EDTAP) provides operating assistance for the transportation of elderly and disabled citizens;
 - B. Work First/Employment Program is intended to provide operating assistance for transitional Work First and general public employment transportation needs; and
 - C. Rural General Public (RGP) funds are intended to provide transportation service to individuals who are not human service agency clients; **and**
- 4 The amount allocated for EDTAP is \$54,147, Work First \$11,503 and Rural General Public \$51,021, which totals \$116,671 for the period July 1, 2005 through June 30, 2006.

Commissioner Memory asked Mr. Patton if the increase in fuel costs would bite into the grant funds. Mr. Patton replied stating for every five (\$.05) cents increase in fuel cost, the grant amount increased one-half (\$.005) cent, but the rapid increase in fuel costs will greatly affect this grant and what we will be able to do with it.

Commissioner McKenzie asked Mr. Patton if he had filled out an application requesting additional dollars. Mr. Patton replied stating he had applied but they usually did not grant additional dollars.

There were no oral or written comments from the public.

APPENDIX A CERTIFIED STATEMENT FY 2005-2006 RURAL OPERATING ASSISTANCE PROGRAM

WHEREAS, Article 2B of Chapter 136 of the North Carolina General Statutes and the Governor of North Carolina have designated the North Carolina Department of Transportation as the agency responsible for administering all federal and/or state programs related to public transportation, and grants the department authority to do all things required in applicable federal and/or state legislation to properly administer the public transportation programs within the State of North Carolina;

WHEREAS, G.S. 136-44.27 established the Elderly and Disabled Transportation Assistance Program;

WHEREAS, funds will be used for transportation related expenditures as specified in the FY 2005 - 2006 Rural Operating Assistance Program (ROAP) application;

WHEREAS, ROAP funds will be used to provide eligible services during the period July 1, 2005 through June 30, 2006;

WHEREAS, any interest earned on ROAP funds will be expended for eligible program uses as specified in the ROAP application; and

WHEREAS, the County will include ROAP funds received and expended in its annual independent audit on the schedule of federal and state financial assistance. Funds passed through to other agencies will be identified as such.

That is certify that the undersigned is duly elected, qualified and acting chairperson of the Board of County Commissioners of the County of Columbus, North Carolina, and that the following statements are true and accurate:

Elderly and Disabled Transportation Assistance Program

- 1. The funds received from G.S. 136-44.27 will be used to provide additional transportation services for the elderly and disabled, exceeding the quantity of trips provided prior to receipt of the funds.
- 2. The funds will not be used to supplant or replace existing federal, state or local funds designated to provide elderly and disabled transportation services in the county.

- 2. The funds are limited to use by the designated local entity(s) specified in the ROAP

application, or any revisions or amendments thereto.

Rural General Public Program

- 1. The funds will be used in a manner consistent with the Rural General Public Transportation Project Description.
- 2. The funds will be used to provide non-human service trips.

- 1. The proposed contract is necessary or expedient because a fire destroyed numerous classrooms at Williams Township School in Fiscal Year 2003/2004 and must be reconstructed. The inmate population in the Columbus County Jail is over state limits, thereby resulting in the State Inspector's Office formally requiring construction of additional housing units to meet the State Code.
- 2. The proposed contract is preferable to a bond issue for the same purpose because local financing is available at the percentage rate of three and 53/100 (3.53%) percent. Debt Service funding is preferable since the General Fund balance and current budget will not prudently support construction in the amount of approximately fifty (50%) percent of yearly ad valorem tax revenues.
- 3. The sums to fall under the contract are adequate and not excessive for the proposed purpose because we have the engineer's evaluation and costs are reasonable for the stated purpose.
- 4. Columbus County's debt management procedures and polices are in compliance with all laws, etc., as per the annual audits.
- 5. The increase in taxes necessary to meet the sums to fall due under the proposed contract will be three and one-half (\$.035) cents per one hundred (\$100) dollars valuation and is not deemed to be excessive.
- 6. The Board of Commissioners of Columbus County is not in default in any of its debt service obligations.
- 7. The attorney for the Board of Commissioners of Columbus County has rendered an opinion that the proposed Project is authorized by law and is a purpose for which public funds may be expended pursuant to the Constitution and laws of North Carolina.

NOW, THEREFORE, BE IT FURTHER RESOLVED that the Finance Officer is hereby authorized to act on behalf of the Board of Commissioner of Columbus County in filing an application with the North Carolina Local Government Commission for approval of the Project and the proposed financing contract and other actions not inconsistent with this resolution.

This resolution is effective upon its adoption this 4th day of April, 2005.

Commissioner McKenzie: there is an area on State Road #1534, Red Store Road, which is off of Peacock Road, in the Mount Olive and Cedar Grove Community, that is experiencing severe erosion. A canal was dug thirty (30) years ago in this area. The erosion is now within ten to fifteen (10' - 15') feet of a cemetery. The family members of the interred in this cemetery are afraid their loved ones could easily be flushed out of their burial spot by the erosion if it is not corrected. Commissioner Norris stated this situation could be a Watershed issue and needed to be looked into.

Commissioner Prevatte stated there were two (2) other places where severe erosion exists that needs to be looked at.

Dear Mr. Coffey:

As you know, Columbus County, NC (the "County") entered into the above agreement with RIEGEL Ridge, L.L.C. ("RIEGEL Ridge") dated October 4, 1999, as amended on May 7 and September 17, 2001 (the "Agreement"), addressing the proposed RIEGEL Ridge Landfill (the "Landfill"). The County approved the Agreement (including its amendments) pursuant to proper notice, procedure and vote as provided by the County's ordinance.

Consistent with the Agreement and the County's communications with you over the years, we have understood that the former owners of RIEGEL Ridge were working with Waste Management of Carolinas, Inc. ("Waste Management") on the development of the Landfill, including the possible sale of RIEGEL Ridge or some other arrangement by which the parties would permit, construct and operate the Landfill. The County's knowledge of Waste Management's involvement in the Landfill development project is evidenced by the County's letter of January 8, 2002 to you. The County approved the permission granted in the January 8th letter pursuant to proper notice, procedure and vote as provided by the County's ordinance. That letter granted the County's permission to RIEGEL Ridge to assign the Agreement "in whole or in part" to Waste Management pursuant to the County's reference to the Agreement. The County's grant of that permission remains in place, and it provides RIEGEL Ridge with permission to assign its interests in the Agreement to Waste Management in whatever form and to whatever degree is necessary or appropriate. Further, as you may know, Waste Management has advised the County that Waste Management of Carolinas, Inc. has acquired all of the membership interests of RIEGEL Ridge, LLC.

The County has long anticipated and welcomed Waste Management's involvement in this project, and the County looks forward to whatever support Waste Management may provide RIEGEL Ridge toward the prompt development of the Landfill. The County has been working on this project since 1994, and the County has had numerous public hearings on, and approvals of, this project. As you know, the County has also visited with DENR and voiced our support of the project. It has been almost six years since our first approval of the Agreement and, therefore, we would greatly appreciate and urge your Department's thorough review and prompt grant of all necessary approvals for the construction and operation of the Landfill.
