### Agenda Item #5: SOCIAL SERVICES - PRESENTATION of NEW SOCIAL WORKER POSITION:

Melinda Lane and Marva Scott, Social Services Director, delivered the following presentation to the Board relative to the new Social Worker Position.

- 1. This is a new position and is funded by the State;
- 2. The State has changed to a new system which is Children Services based;
- 3. We will be working with families more in ways to help them improve;
- 4. We are one of the last few counties to change over to this new system;
- 5. This is regarded as being a new approach to the old ways of doing things;
- 6. The goal of this new system is ten (10) cases to one (1) Social Worker, and at present, we have eighteen (18) cases to one (1) Social Worker;
- 7. Columbus County has been awarded one (1) position;

- 8. We are trying to get more agencies involved in this program;
- 9. We will receive approximately forty-six thousand, five hundred eleven, and 00/10 (\$46,511.00) dollars for this position; and
- 10. We will hear more about this program after the first of next year.

Commissioner McKenzie asked, when does this new system start. Ms. Lane replied stating the first of next year, and we had to do a Plan of Implementation this year.

Marva Scott stated they would bring a person on board in October, 2005 to allow for preparation and the necessary education required.

Commissioner Memory made a motion to approve the new Social Worker position, seconded by Commissioner Dutton. The motion so carried.

Vice Chairman asked Mr. Horne which of the fees were new. Mr. Horne replied stating they had created a new structure. Previously, the fee was in one (1) lump sum, and now we have broken the fees down into parts to eliminate refunds and make for better bookkeeping.

Commissioner McKenzie stated the Board needed to wait until a later date to consider these new fees.

Commissioner Memory asked Mr. Horne if the department was self supporting. Mr. Horne replied stating no.

Vice Chairman Godwin stated the new fees will ultimately save the taxpayers of Columbus County money by having the ones using this service to pay, which will make this a user fee, thus preventing the cost of this service being passed on to all the taxpayers of the County.

Vice Chairman Godwin made a motion to approve the Proposed New Fee Schedule for Environmental Health, to be effective as of January 01, 2006, seconded by Commissioner Memory.

Mark Cartret, Tarheel Monitoring, LLC, delivered the following presentation to the Board on Electronic Monitoring and Case Management Services.

- 1. My family has been involved in Pre-Trial Release Programs for the past thirteen (13) years;
- 2. I have been involved in this for the last five (5) years:
- 3. We utilize a company named Metro-Trak, and I have Mr. Davis R. Schwartz with me tonight to make a presentation relative to the savings for Columbus County in using the company's monitoring devices in lieu of incarceration; and
- 4. Here is Mr. Schwartz to deliver this information.

Mr. Davis R. Schwartz stated the following:

- 1. The end user will be Columbus County;
- 2. Metro-Trak is a national company;
- 3. We operate in sixteen (16) states;
- 4. We have many new devices that are available in addition to the ankle bracelets that will provide more information faster; and
- 5. The savings that would be realized by Columbus County is great and will also prevent the overcrowding of the new jail.

Commissioner Memory asked Mr. Schwartz if this company had liability insurance. Mr. Schwartz replied stating yes in the amount of \$2 million.

In-depth discussion was conducted relative to the appropriate people that needed to be involved in this presentation, and it was discovered the judges, District Attorney and the Sheriff had not been presented this information as of yet.

Commissioner Memory made a motion to take this presentation as information for the appropriate people to handle, seconded by Vice Chairman Godwin. The motion so carried.
