### 2. **Management Letter:**

November 30, 2006

To The Board of County Commissioners Columbus County, North Carolina

Dear Commissioners,

In planning and performing our audit of the general purpose financial statements of Columbus County for the year ended June 30, 2006, we considered the internal control structure in order to determine the extent and nature of our auditing procedures for the purpose of expressing an opinion on the financial statements, and not to provide assurance on the internal control system. However, we noted certain matters we considered important enough for your attention. No opinion is being expressed regarding internal control. Had our procedure been designed to express such an opinion other matters might have been noted.

We noted the following items that should enhance your internal control structure and reporting.

- 1. The Board should make adequate time for the Finance Officer/Deputy Finance Officer to perform random checks of the internal control system in the various departments. This would act as a deterrent since no one knows when their office would be checked. It would also enhance reporting and communication between the county's departments that handle cash.
- 2. Although the Tax Department is eventually getting over 99% of all taxes for any given year, the tax collection for the current year is below the state average. The current year's collection percentage is 1 percentage point higher than last fiscal year. The collection rate for non-motor vehicles is in line with the state average.
- 3. The increasing size (growth) of the water districts and the finances related to them need careful attention going forward. The debt repayment and the operational effectiveness of the internal control in regards to the water districts will need constant attention until the growth stabilizes. Their ability to cash flow is crucial for long-term financial stability of the districts.
- 4. The county's General Fund fund balance declined by \$211,489 during the current year. The County should review all budget items to avoid a further reduction during the current fiscal year.
- 5. The county should update its fixed asset list during the year as assets are added rather than wait until year end.
- 6. All county departments that handle cash should be monitored at least once a year as part of the county's Finance Department's role.
- 7. A physical count of inventory should be taken as of 6/30/06 for all inventory accounts.
- 8. Travel expenses for employees' spouses who accompany them on trips to seminars and workshops should be closely monitored. Spousal expenses on such trips should be kept separate to ensure proper accounting. If spousal expenses are charged to the county's credit care, these expenses should be timely reimbursed by the employee.
- 9. It is recommended that payroll (941's) be reconciled to the General ledger at least on a quarterly basis, if not monthly. There has been a problem with reconciling at year end for the last couple of years. (This has been discussed with Leo...Auditor will provide reconciliation worksheet for client.)
- 10. Lease agreements and capital purchases should be closely monitored. (Especially capital leases occurring near year end.) Instances were noted during current year audit where capital leases had been executed near year end but were not included in fixed assets.
- 11. It is recommended that Water receivables be reconciled to the General Ledger monthly.
- 12. It is recommended that Accounts Payable/Prior Years Payable accounts be reconciled to the General Ledger monthly. The prior years payable report should agree with the General Ledger.
- 13. All back accounts should be reconciled monthly to the General Ledger.
- 14. Sales tax refund reports should be completed timely.
- 15. All department accounts should be monitored to ensure they stay within the constraints of the

approved budget.

Our firm is available to meet with you at any time to discuss any item in the Audit Report. Our firm continues to be impressed with the quality of work performed by the Administrative staff of the County.

This report is intended for the information of management and the Governing Board. However, this is also a matter of public record, and its distribution is not limited.

Questions relative to the required eight (8%) percent Fund Balance that is recommended by the Local Government Commission were presented to Mr. Thompson. Mr. Thompson replied stating that Columbus County needed to be in the twenty-five (25%) percent range to be safe, and there has been significant progress made from 2004 - 2005 to 2005 - 2006, but we need to continue to work on this.

Commissioner Memory made a motion to accept the Columbus County Financial Statements, June 30, 2006, as presented, seconded by Commissioner Norris. The motion unanimously carried.

#### **Agenda Item #6:** WATER - DEPARTMENTAL UPDATE:

Leroy Sellers, Public Utilities Director, delivered the following Departmental Update to the Board:

- 1. As of December 31, 2006, we had three thousand four hundred sixty-three (3,463) active customers, with new lines being planned in Districts IV and V, which will be an additional five hundred to six hundred (500-600) new customers;
- 2. The Public Utilities Office is responsible for approximately five hundred (500) miles of water lines with seven (7) employees to oversee everyday operations and testing;
- 3. In the past year, the Public Utilities Office has completed one thousand seven hundred ninety-two (1,792) work orders. In addition, we performed approximately seven hundred (700) locates for the Department of Transportation and the telephone company;
- 4. We oversee the operation of the P.O.T.W. at Acme Delco, and do grab samples of the water being released into Livingston Creek;
- 5. The following new projects are in process:
  - a. Fifty-four (54) miles of water lines in District V;
  - b. Sixteen (16) miles of water lines in District IV;
  - c. Water lines to be installed on Carl Stephens Road in District I;
  - d. Water main extension in Timber Cove; and
  - e. Two thousand (2,000') feet of water lines at the Columbus County Airport which will be started tomorrow.

# RESOLUTION REQUESTING SECTION 205 STUDY for LIVINGSTON CREEK

Be it resolved that the Columbus County Board of Commissioners requests the U.S. Army Corps of Engineers to conduct investigations and studies to determine the feasibility of developing a flood control project at Livingston Creek under the authority provided by Section 205 of the 1948 Flood Control Act, as amended.

The Feasibility Study phase is federally funded up to \$100,000.00. Study costs in excess of \$100,000.00 are shared 50 percent Federal and 50 percent by the project sponsor. The project sponsor will be required to sign a feasibility cost sharing agreement when study costs exceed \$100,000.00.

It is understood that, if it is found feasible and advisable to implement a flood control project at Livingston Creek, the Columbus County Board of Commissioners would be required before construction commences to enter into a contractual agreement that it will provide such local cooperation as may be prescribed by the Secretary of the Army. As the non-Federal project sponsor, the Columbus County Board of Commissioners would contribute 35 percent to 50 percent of project implementation costs.

The Clerk to Board of the Columbus County Board of Commissioners shall be, and is hereby directed to transmit three copies of this resolution to the District Engineer, U.S. Army Corps of Engineers, Wilmington District, Post Office Box 1890, Wilmington, North Carolina 28402-1890.

#### 1. **Jim Nance (private citizen):** stated the following:

- a. There is a two thousand (2, 000) acre area bordering the Lumber River that is being maintained by the North Carolina State Parks and Recreation Department;
- b. Anyone can purchase a thirty-five and 00/100 (\$35.00) dollars permit and ride horses in this area;
- c. This area has no posted trails for the horse rides for everyone to see, and has no bathroom facilities;
- d. I have been denied the opportunity to purchase a permit for my personal use to camp in this area;
- e. Last weekend, a trail ride, in the said area, started on Thursday evening and ran through Monday morning, with extremely loud noises that sounded like steel being unloaded; **and**
- f. I would like to find out why these people are allowed to ride horses in this area, and I can't even purchase a permit to camp in the same area.

After discussion was conducted among the Board members, it was the general consensus of the Board for Jim Varner, County Manager, and June B. Hall, Clerk to the Board, to prepare a letter to the North Carolina State Parks and Recreation to discover what the rules and regulations are that govern this area.

# 2. **Robert Adams (private citizen):** stated the following:

- a. I am speaking on behalf of the Columbus County Aging Advisory Council;
- b. I have been informed by Ed Worley, Aging Director, that the North Carolina Department of Transportation has informed him they cannot place green signs at five (5) of the seven (7) Senior Citizens' Centers that are located in Columbus County, due to their locations;
- c. I am requesting the Board of County Commissioners to pass a Resolution requesting the State to change their policy on these signs to be placed at the

Senior Centers; and

d. This will aid our senior citizens in locating these centers.

After discussion was conducted relative to this matter, it was the general consensus of the Board for Jim Varner, County Manager, and June B. Hall, Clerk to the Board, to send a letter to the North Carolina Department of Transportation to inquire about the details surrounding this matter.

#### B. **Department Heads:**

I have prepared, for the Board, the options that are available for the Riegelwood Tornado Permit Fees in the rebuilding process. They are as follows:

#### **OPTIONS:**

- A) Charge for permits if:

  - 2. The homeowner pays someone else to do the work or part of the work.
- B) Do not charge for permits if: (Permits will still be required)
  - 1. The owner is doing all the work themselves; **or**
  - 2. The owner has help from the volunteer group.
- C) No charge for any permits. (Permits will still be required)
  (Approximate amount of fees not collected will be between \$5,000 \$6,000)

I need to know what the pleasure of the Board is on this matter.
