Milton McLean, Beaver Eradicator, Edward Davis, Soil and Water Director, Donna Register, District Conservationist, and a representative from Environmental Health delivered the following update on the drainage and beaver problem in the Buckhead and Ricefield area, as requested by Commissioner Sammie Jacobs.

Edward Davis, Soil and Water Director, stated the following:

- 1. I received a call about a drainage problem in the Ricefield area;
- 2. I went and checked the situation out; **and**
- 3. I will ask Milton McLean, Beaver Eradicator, to discuss this matter in depth.

Milton McLean stated the following:

- 1. This problem has been going on for twenty to twenty-five (20-25) years;
- 2. There is a major problem in the area;
- 3. I surveyed two and one-half (2 <sup>1</sup>/<sub>2</sub>) miles, and found nine (9) large beaver dams;
- 4. There were places that had four and one-half to five  $(4 \frac{1}{2} 5')$  of water standing which should be draining off the area;
- 5. There are approximately one thousand (1,000) acres affected by this drainage problem;
- 6. I have caught nine (9) large beavers in this area so far;
- 7. My plans are to blow the dams next week;
- 8. Beavers are very hard to control;
- 9. Beavers multiply very rapidly; and
- 10. This flooding problem should improve after these blockages are removed.

Commissioner Jacobs stated the following:

1. We have several citizens in attendance tonight that are from the area that is being affected

and they are from my area;

- 2. It is good to see this number of citizens in attendance;
- 3. The Board has previously donated forty-nine thousand and 00/100 (\$49,000.00) dollars to this Beaver Program, and I am going to ask the Board to donate an additional forty-nine thousand and 00/100 (\$49,000.00) dollars to this program in the upcoming Budget Process.

Chairman Prevatte requested that Mr. Davis and Mr. McLean keep the Board updated on the progress that is being made with this drainage problem.

Mr. Freemen, a private citizen, stated that a maintenance program needed to be put into place in order to prevent a repeat of this happening.

#### COLUMBUS COUNTY WATER and SEWER DISTRICT IV Restriction on Future Water Service and Site Selection to Protect Farmland RESOLUTION

**WHEREAS**, Columbus County is constantly changing with an area of some nine hundred fifty four (954) square miles, with a population of approximately fifty-four thousand (54,000) persons who desire to live, work and play here; and

**WHEREAS**, the Columbus County Water District IV will not install future water service to new development that requires larger than normal residential size tap to non-agricultural development proposed to occur on important surplus capacity water lines except for those previously designated as Growth Corridors. Those lines presently identified as having surplus capacity are those with a diameter larger than 8-inches located in Water District IV.

WHEREAS, a final decision on whether or not a property proposed to be developed qualifies as important farmland will be made by the local office of the Natural Resources Conservation Service. In future expansions of the water system, this restriction will apply to all 10-inch diameter and larger waterlines that are not in a designated growth corridor unless a hydraulic analysis indicates the line has no surplus capacity. Water taps larger than residential size may be installed at any location for agricultural purposes such as providing water for livestock facilities. Columbus County Water District IV also agrees to select future well, tank and treatment facility sites so as to minimize conversion of important farmland. The district further agrees that no such sites will be acquired for future phases of the water system without the prior concurrence of Rural Development.

WHEREAS, the Columbus County Board of Commissioners is giving high priority to the

planning of water supply systems for a better future for Columbus County and its citizens.

**NOW, THEREFORE, BE IT RESOLVED**, that the Columbus County Board of Commissioners hereby restricts the water tap size on waterlines larger than 8-inches in diameter located in Water District IV except in areas designated as growth corridors.

- 1. At the February 18, 2008 Commissioners Meeting, change orders for additional water lines were approved for Contracts 1 and 2;
