Agenda Items #1, #2 and #3: <u>MEETING CALLED to ORDER, INVOCATION, and PLEDGE of ALLEGIANCE</u>:

At 6:30 P.M., Chairman James E. Prevatte called the September 02, 2008 Columbus County Board of Commissioners Meeting to order. The invocation was delivered by Ricky Bullard, due to Commissioner Jacobs' absence. Everyone in attendance stood and pledged Allegiance to the Flag of the United States of America, which was led by Vice Chairman Bill Memory.

# **Agenda Item #4: BOARD MINUTES APPROVAL:**

Commissioner Norris made a motion to approve the August 18, 2008 Regular Session Board Meeting Minutes, seconded by Vice Chairman Memory. Chairman Prevatte stated that on Page 724, in the Draft minutes, under Agenda Item #17: Comments, B. Board of Commissioners, 2, it was incorrectly stated as follows: "...Columbus County Water and Sewer District I is purchasing one hundred thousand (100,000) gallons of water from the Town of Tabor City annually". This should read "...Columbus County Water and Sewer District I is purchasing one hundred thousand and 00/100 (\$100,000) dollars worth of water from the Town of Tabor City annually. Commissioner Norris amended his motion, and Vice Chairman Memory amended his second. The amended motion unanimously passed.

# Agenda Item #5: PUBLIC INPUT

No comment cards were received and no comments were rendered from the public.

Agenda Item #6: EMERGENCY SERVICES - APPROVAL of REVERSE 911 SYSTEM and ACCEPTANCE of GRANT FUNDING from COMMUNITY

**FOUNDATION for COLUMBUS COUNTY:** 

Kay Worley, Interim Emergency Services Director, requested Board approval of funding from the Community Foundation of Southeastern North Carolina for the Reverse 911 System. Ms. Worley stated the following:

- 1. The Community Foundation of Southeastern North Carolina created the Community Foundation's Riegelwood Disaster Relief and Recovery Fund to provide for the long-term recovery and disaster preparedness needs of the greater Riegelwood community;
- 2. I have met with Stephen Dillon, Executive Director of the Community Foundation of Southeastern North Carolina, and he is proposing the following:
  - A. The Community Foundation will provide 100% funding for the set-up and operation of a Reverse 911 System for Year 1 (estimated at approximately \$15,000);
  - B. In Year 2, the Community Foundation will fund 50% of the system's continued operation, and Columbus County government will provide the remaining 50% of funds;

- C. In Year 3, the Community Foundation will fund 25% of the system's continued operation, and Columbus County government will provide the remaining 75% of funds;
- D. In Year 4, Columbus County government will assume full financial responsibility for the system's continued operation;
- E. Foundation funding will be in the form of cost reimbursement, following the County governments' expenditure of funds fo pay for the system's operation;
- F. All applicable government policies, regulations, and procedures are adhered to regarding the set-up and continued operation of the system;
- F. The cumulative total amount of the grant from the Community Foundation can not exceed \$30,000; and
- G. In addition, the Community Foundation will fund directly a public awareness campaign to inform Columbus County residents about the Reverse 911 system and its purpose.
- 3. This will be an Emergency Notification System for Columbus County for any type disaster that should occur and can be isolated to a particular area or areas;
- 4. The cost to Columbus County will be \$15,000 per year;
- 5. The vendor I have chosen is Code Red which allows for fifty thousand (50,000) minutes for one thousand, five hundred, and 00100 (\$1,500.00) dollars, per year, and the calls are set up in six (6) second intervals;
- 6. If additional minutes are needed, you would have to purchase an additional fifty thousand (50,000) minutes for the cost of one thousand, five hundred, and 00/100 (\$1,500.00) dollars; and
- 7. If we use the system that is being proposed, it will have GIS capabilities.

Discussion was conducted relative to the following:

- 1. Lapse time being approximately ten (10) minutes from the initial emergency declaration and the time the citizens receive notification:
- 2. The additional cost of overrun minutes;
- 3. The advantages and disadvantages of the system;
- 4. The combination of the school systems' emergency notification system and one for the County; **and**
- 5. After three (3) years, if the system proves to be too costly, it could be cancelled.

# RECESS REGULAR SESSION and enter into a PUBLIC HEARING:

At 6:59 P.M., Vice Chairman Memory made a motion to recess Regular Session for a Public Hearing to be held, seconded by Commissioner Norris. The motion unanimously passed.

## 7:00 P.M.

**PUBLIC HEARING - Contracting to Make Cash Grant for Project Good:** the purpose of this Public Hearing is to receive comments from the public, either oral or written, on this incentive grant.

## **PUBLIC HEARING CALLED to ORDER:**

At 7:00 P.M., Chairman Prevatte called the Public Hearing to order, and stated the purpose of this Public Hearing is to receive comments, either written or oral, on Columbus County contracting to make cash grant for Project Good. Chairman Prevatte requested Steven Fowler, County Attorney, to explain how the Public Hearing would be conducted. Mr. Fowler read Rule 24 from the Rules of Procedure, in its entirety.

Justin Smith, Economic Development Director, stated the following:

- 1. This company will be utilizing the Sumitoma Building;
- 2. This is the due diligence period;
- 3. They will be manufacturing corn and flour tortillas;
- 4. This company will make an \$1 million investment;
- 5. This project will total thirty thousand, nine hundred seventy-one, and 00/100 (\$30,971.00) dollars; **and**
- 6. This will create twenty (20) new jobs within a minimum of five (5) years.

# **COMMENTS**:

No comments were received, either oral or written.

# **PUBLIC HEARING CLOSED:**

At 7:03 P.M., Vice Chairman Memory made a motion to close the Public Hearing, seconded by Commissioner McKenzie. The motion unanimously passed.

- 4. Columbus County has been re-certified as a Storm Ready County by the National Weather Service:

  - -Total Calls for January 01 August 31, 2008:

Fire - 2,492 EMS - 6,138 Law - 35,209;

- -Upgraded the Medical Priority Dispatch Codes to be in compliance with State Standards;

- -Meeting with vendors to discuss improving radio communications throughout the county;

# REQUEST for SUMMARY of ATTENDANCE of COMMISSIONERS' APPOINTEES at COMMITTEE/BOARD MEETINGS:

Chairman Prevatte stated that it has been brought to the attention of the County Commissioners that many of the Commissioners' appointees have not been attending the meetings of the committee/boards they have been appointed to serve on. Their absence, along with the absence of other members, has created situations where the committee/board could not carry out the tasks they have been assigned to do. Chairman Prevatte requested the Clerk to the Board to compile a summary of the attendance of the members serving on the committees/boards, with emphasis placed on the Commissioners' appointees.

Agenda Item #8: ECONOMIC DEVELOPMENT - ESTABLISHMENT OF PUBLIC HEARING DATE for APPROVAL of IDI GRANT for PROJECT CLEAN:

Justin Smith, Economic Development Director, requested the Board to establish October 06, 2008, as the date for the Public Hearing, for the IDI Incentive Grant for Project Clean. (The time needs to be set for this hearing.)

Vice Chairman Memory made a motion to establish October 06, 2008, at 6:30 P.M., as the date and time for the Public Hearing for the IDI Incentive Grant for Project Clean, seconded by Commissioner Norris. The motion unanimously passed.

Agenda Item #9: ECONOMIC DEVELOPMENT - REQUEST FOR LEGAL FEES TO DEVELOP A NON-PROFIT CORPORATION FOR THE TWO-COUNTY INDUSTRIAL PARK:

Justin Smith, Economic Development Director, requested Board approval of the necessary legal fees to develop a non-profit corporation for the Two-County Industrial Park. Mr. Smith stated the following:

- 1. The Two-County Industrial Park needs to establish a corporation;
- 2. I am recommending that we use Sanford Holshouser as the legal firm to handle the following paperwork:
  - A. Tax exempt status;
  - B. Negotiate the terms of the initial agreement; and
  - C. Negotiating and finalizing the documents necessary to make this agreement work smoothly;
- 3. This will be a multi-jurisdictional project and there is only four or five of these parks in the State of North Carolina;
- The Brunswick County Economic Development Director is requesting twenty thousand and 00/100 (\$20,000.00) dollars from his Board tonight;
- 5. We have fifteen thousand and 00/100 (\$15,000.00) dollars in the Economic Development Budget that can be used towards this amount; **and**
- 6. I am only requesting five thousand and 00/100 (\$5,000.00) dollars from the Board for this project.

Vice Chairman Memory made a motion to transfer the sum of five thousand and 00/100 (\$5,000.00) dollars of County funds for the legal fees to develop a non-profit corporation for the Two-County Industrial Park, seconded by Commissioner Gore. The motion unanimously passed.

# Agenda Item #10: ECONOMIC DEVELOPMENT - APPROVAL of INCENTIVE GRANT for PROJECT GOOD:

Justin Smith, Economic Development Director, requested Board approval of the incentive grant for Project Good. (The required Public Hearing was conducted at 7:00 P.M. on this date.)

Vice Chairman Memory made a motion to approve the IDI Incentive Grant for Project Good, seconded by Commissioner McKenzie. The motion unanimously passed.

# Agenda Item #11: GOVERNING BODY - APPROVAL of AMENDMENTS to RULES of PROCEDURE - RULES 8 and 10:

Chairman Prevatte requested Board approval of the following two (2) amendments to Rules #8 and #10 in the Rules of Procedure for the Columbus County Board of Commissioners which was adopted February 04, 2008.

## **RULE 8: PUBLIC ADDRESS TO THE BOARD**

There shall be a time set aside at each regular meeting of the Board of Commissioners for public comment. The meeting Agenda shall be followed as outlined in the Columbus County Commissioner's Board Package and as posted on the Public Agenda prior in the meeting room, unless modified by the Chairman, with the consent of the majority of the Board of Commissioners. The following procedure will be followed for public comment on any agenda or non-agenda items at meetings of the Board of Commissioners.

- 1. The Board shall allow public comment. The maximum amount of time set aside for public comment shall be thirty (30) minutes.
- 2. **Regardless of whether a topic is on or not on the Agenda**, anyone wishing to speak shall complete an index card supplied by the County, on which they will provide their name, address and telephone number. They shall identify the topic they wish to address, **indicate whether the topic is on or not on the Agenda**, and include all pertinent information. These cards are to be presented to the County Clerk, who will give each card a number in the order in which it is received.
- 3. When the Board reaches that portion of the meeting when public comments are permitted, the Chairman will recognize those wishing to speak in the numerical order shown on the cards. Individuals who are recognized will come to the podium and give their name and address. They will then be allowed three (3) minutes in which to present comments and the County Attorney will keep the time for that period. A person may only speak once during the period allotted for all comments. There shall be no yielding of time or allowance for one speaker to utilize another's time when addressing the Board of Commissioners. One must speak on his or her concern, or the concern of the general public as a whole. Only an attorney who represents that person may address the Board of Commissioners about a specific problem of another individual.
- 4. The Board is not required to comment on matters brought to the Board during this time, day may decline to take action on a request which is presented during the public comment portion of the meeting. Such request may instead be referred to the County Administrator, the County Attorney or other appropriate individual for investigation and action, or for a future report back to the Board.
- 5. Proper order will be maintained at all times during the meeting and the members of the audience shall be polite and courteous to all speakers at all times, regardless of their respective position. Only the speaker at the podium will be allowed to address the Board of Commissioners, or to make comments during the presentation.
- 6. The Chairman, at his/her discretion, may recognize persons to speak during the regular Agenda who did not speak or are not scheduled to speak during the Public Input portion of the Agenda. The Chairman shall make a reasonable effort to recognize reasonably perceived opponents and proponents of a particular measure, if applicable.

### **RULE 10: POWERS OF THE CHAIRPERSON**

The Chairman of the Board shall be elected annually for a term of one (1) year and shall not be removed from the office of chair unless he or she becomes disqualified to serve as a member of the Board.

The Chairperson shall preside at meetings of the Board. In the Chairperson's absence, the Vice-Chairperson shall preside and shall have all the powers specified herein. If the Chairman and Vice-Chairman are both absent from the meeting, the Columbus County Attorney shall convene the

meeting and the remaining members shall elect a Board member to preside for that meeting or until either the Chairperson or Vice-Chairperson appears. A member must be recognized by the Chairperson in order to address the Board. The Chairperson shall have the following powers:

- 1. To rule motions in or out of order, including the right to rule out of order any motion patently offered for obstructive or dilatory purposes;
- 2. To establish time restraints for discussion, except for matters requiring a quasi-judicial public hearing;
- 3. To determine whether a speaker has gone beyond reasonable standards of courtesy in his/her remarks and to entertain and rule on objections from other members on this ground;
- 4. To entertain or refer to the County Attorney questions of parliamentary law or procedure;
- 5. To call a brief recess when needed;
- 6. To adjourn in an emergency;
- 7. To conduct public hearings as otherwise provided for herein; and
- 8. To direct any person to leave the meeting when the person willfully interrupts, disturbs, or disrupts the meeting. Any person who fails to leave the meeting after being directed to do so by the Chairman shall be removed by the Sheriff and charged with a misdemeanor pursuant to applicable North Carolina law.
- 9. The Chairman, at his/her discretion, may recognize persons to speak during the regular Agenda who did not speak or are not scheduled to speak during the Public Input portion of the Agenda. The Chairman shall make a reasonable effort to recognize reasonably perceived opponents and proponents of a particular measure, if applicable.
