

The Honorable Board of County Commissioners met in regular session in the Commissioners' office on Monday, September 1, 1930. Members of the Board present were:

After the reading and approval of the minutes covering meetings held during the month of August, the Board transacted the following business:

Ordered: That the J. C. and J. R. Williamson tax judgment be extended sixty days from this date as to the portion of taxes due under the judgment by the Bank of Columbus in the amount of \$6,638.00 and J. C. and J. R. Williamson in the amount of \$2,723.00. The foregoing extension was allowed in consideration of a payment being made in the amount of \$1,000.00, said amount being applied only to the said J. C. and J. R. Williamson portion of the taxes. In the case of the Bank of Columbus, the extension was allowed for the purpose of giving the bank additional time in which to find a more profitable sale for its portion of the J. C. and J. R. Williamson property than is available at present, thereby affording the bank better opportunity of liquidating its assets and increasing the amount of dividends the County and other depositors <sup>will</sup> receive as reimbursement of funds deposited in said bank of Columbus at the time of its being closed.

The matter of a tax listing under the name of Mrs. Amanda Huffham in Ransom Township was taken up before the Board by Porter Huffham. After hearing Mr. Huffham's contention the County Commissioners ordered that a statement from R. C. Applewhite, list-taker for Ransom Township in that year, as to the error, be obtained, whereupon a refund voucher be issued on the 1928 tax in the amount of \$4.16; also that the Tax Collector refund on a \$200.00 valuation for the year 1929, reason for refund being that Mrs. Huffham owns one lot which was valued at \$50.00 but in some way the list-taker charged the one lot at \$250.00 and an additional \$350.00 for the erection of a small house, making a total valuation of \$600.00. The total valuation should be \$400.00 including the valuation placed on the property on account of erecting the house.

E. J. Grimsley and T. H. Williams, Chairman and Secretary respectively of Ransom Township Road Commission, asked the Board of County Commissioners for authority to issue a \$2500.00 note on Ransom Township for the purpose of taking care of a present overdraft in the ~~present~~ Township's bank account

and to make the cash payment of \$300.00 on a truck which will cost \$858.79. After hearing the request the Board ordered that a \$2500.00 note on Ransom Township be issued in anticipation of 1930 tax collections, payable to bearer at Waccamaw Bank and Trust Company, dated September 5, 1930, 60 days at 6%, and that the Ransom Township Board be authorized to make three notes to the Marks Implement Company as follows:

Note maturing 1/1/31, \$186.26

Note maturing 5/1/31, \$186.26

Note maturing 9/1/31, \$186.27.

Ordered: That the Tax Collector refund Lilly High on \$400.00 valuation in Whiteville Township for the year 1929 on account of all of the Peter High Estate property being charged against her when three others have listed their portions of said estate.

R. F. Benton, Chairman of Tatum Township Road Commission, asked the Board of Commissioners for authority to issue Tatum Township note in the amount of \$700.00 dated September 5, 1930, three months at 6%, payable to bearer at Waccamaw Bank and Trust Company. After hearing Mr. Benton's request, the Board of County Commissioners ordered that Tatum Township Road Commission be authorized to issue said note in anticipation of 1930 tax collections in order that a present overdraft in Tatum Township bank account may be funded.

The matter of a mortgage which the County holds against the K. Batten property in Bogue Township was brought to the attention of the Board of Commissioners. The following order was then passed: That said mortgage on the K. Batten property be delivered to the County Attorney for immediate foreclosure, and that the matter of renting said property to some tenant for the year 1931 be left to the discretion of J. C. Hooks, Sr., County Commissioner, and J. D. Lewis, County Attorney.

The Board of Education came before the Board of County Commissioners on this date in regard to securing a loan from the State Special Building Loan Fund in the amount of \$25,000.00 with which to erect a new school building in the Pireway district of Bug Hill Township. After some discussion the following resolution was offered by J. R. Blake and seconded by D. W. Merritt:

"Resolved by the Board of County Commissioners of Columbus County:

(1) That for properly maintaining a six months' school term in District No. 4, Bug Hill Township, Bug Hill School, white race, as required by Article IX, Section 3, of the Constitution of the State of North Carolina, it is necessary that certain improvements be made therein of the following character: (Here set out character of improvements as specified in application)-

New seven room brick building.

(2) That in order to provide said improvements it is necessary that the sum of Twenty-five Thousand Dollars (\$25,000.00) be obtained by borrowing the same, to be used by the County Board of Education of Columbus County for said purpose.

(3) That the Board of County Commissioners of Columbus County does hereby approve of and authorize the application for, and procurement of, a loan for said purpose from the Special Building Fund of the State of North Carolina, established under Chapter 81, Public Laws 1927, and said Board does hereby authorize and direct that all necessary steps be taken to procure said loan under the terms of said statutes and the rules and regulations of the State Board of Education governing the making of loans from said fund, and the Chairman and Secretary of this Board are hereby authorized, empowered and directed for and on behalf of this Board to join with the County Board of Education of Columbus County in making the necessary application therefor, and to take such action under this resolution and under said statutes, rules and regulations as may be necessary for said purpose."

The resolution was duly adopted by the following vote:

Whereupon the Chairman announced that said resolution was duly and properly adopted.

Ordered: That the 1929 tax receipt of Mrs. Doris (or J. N.) Newman in Chadbourn Township be cancelled on account of the same land covered by said tax receipt being part of the J. N. Newman land, on which returns were duly made.

Mrs. W. G. Perkins, representative of the Columbus County News, a newspaper published in the Town of Chadbourn, asked the Board to give to the said Columbus County News a portion of the advertising pertaining to both the notice of summons and the notice of foreclosure in the land suits for taxes for the year 1928 which must be filed in the Clerk of Court's office by December 1, 1930. The Board ordered that the said Columbus County News be given the advertising of both notice of summons and notice of foreclosure for all of Chadbourn Township suits.

It was ordered by the Board: That four wheelers be purchased for the Chain Gang and that County Commissioner H. G. Avant and the County Auditor be appointed as a committee to receive sealed bids from various

road equipment companies, and to make purchase of said wheelers.

Ordered: That the following land sale certificates now in the hands of the County Attorney for investigation be cancelled on account of reasons listed hereinbelow:
