The minutes of the January meetings were read and approved.

It was brought to the attention of the Board that no one had been appointed or reappointed to fill the expired terms of the three members of the Columbus County Planning Board, who's terms ended June 30, 1970. A motion was made by Commissioner Watts, seconded by Commissioner Burnsm and unanimously passed to appoint Mr. Alec Quick, Chadbourn, N. C. to replace Mr. Norman Peal. The other appointments will be made at the February 15th meeting. These terms will expire in five years on June 30th.

Ordered: that the renting of the county farm be transacted by Commissioner Watts.

Ordered: that a check for \$25.00 be given to Bill Callihan, Cerro Gordo, from the Out-Door-Poor Fund.

Ordered; that Chairman Williamson be authorized to have \$100,000. transferred from the JAIL CONSTRUCTION FUND to buy a Certificate of Deposit or have placed on the highest rate of interest available for a period of 90 days. This motion was made by Comm. Watts seconded by Comm. Gore, and unanimously passed.

Ordered: that the taxes listed in the name of Mrs. Ollie Hill White, Chadbourn Township, be cancelled for the year 1948 due to double listing.

Ordered: that the poll tax listed in the mame of Floyd Franklin Justice, Whiteville Township, be released for the year 1978. Mr. Justice is a non resident of Columbus County.

Ordered: that the taxes listed in the name of James Ira Floyd, Chadbourn Township, be cancelled for the year 1964 due to double listing.

Ordered that the taxes kisted in the name of Nolan Lee Chestnutt Bug Hill Township, be cancelled for the pears 1957, 1958, and 1959.Mr. Chest-

nutt was overseas during these years and his wife was residing in Robeson County. No property should have been listed in Columbus County.
