The meeting was called to order and the invocation was given by the Reverend Tommy Beaver, Christ the King Luthern Church, Whiteville, N. C.

The following business was transacted:

Ordered: that the minutes of the March 3rd meeting be approved as recorded.

Ordered: that the Library Board be allowed to have a feasibility study made of the practicalities and possibilities of adding to the present City of Whiteville Library or the possible abandonment of the City Library Building and the practicalities of adding to the present County Library Building. There is to be no financial obligation to the County. If, however, the project evolves and an Architect is employed it is agreed that Ballard, McKim and Sawyer be selected.

Ordered: that \$2,500. be included in the 1975-76 FY Budget for the Oratoria Society to match a grant available through the N. C. Council of Fine Arts.

The following Resolution was unanimously passed upon motion by Commissioner Brown, and seconded by Commissioner Buffkin:

WHEREAS, the County Police, Sheriff's Dept. and law enforcement are paramount in the minds of the citizens of Columbus County; and

WHEREAS, the Board of County Commissioners of Columbus County wish that the citizens of Columbus County be provided with the best law enforcement that the County can afford;

NOW, THEREFORE, BE IT RESOLVED that the ligislative delegation representing Columbus County - namely, Senator Edd Nye, Speaker of the House James C. Green, Representatives R. C. Soles, Jr. and Richard Wright- evaluate the law enforcement in Columbus County in relationship to cost and service, and to draft any legislation that they deem necessary for the best interest of law enforcement in Columbus County;

BE IT FURTHER RESOLVED that if said delegation feels that it would be best for the

citizens to vote on any proposals the Board would support same.
