Mr. Sam Stephenson, Secondary Roads Council Chairman, E. J. Butler, Division Engineer, D. L. Cooper, Asst. Division Engineer and B. A. Mills, District Engineer, met jointly with the Board to present a Secondary Roads Construction Program for FY 1975-76 in Columbus County. Representatives R. C. Soles, Jr. and Richard Wright along with several interested citizens were also present. There was a lengthy question and answer session concerning the condition of various roads in the County.
