# PROCLAMATION - BICENTENNIAL OF THE U.S. CONSTITUTION

WHEREAS, the Constitution enunciates the limitations on government, inalienable rights and the timeless principles of individual liberty and responsibility, and equality before the law for the people of the United States of America; and

WHEREAS, the Constitution has set an enduring example of representative democracy for the world; and

WHEREAS, maintenance of the common principles that stabilize our Republic depend upon a knowledge and understanding of their roots and origin; and

WHEREAS, Congress has established the Commission on the Bicentennial of the United States Constitution, chaired by Chief Justice Warren L. Burger, to foster among the people of the United States a just appreciation and a clearer understanding of their constitutional heritage.

WHEREAS, the General Assembly has established the North Carolina Commission on the Bicentennial of the United States Constitution, chaired by Lt. Governor Robert B. Jordan, III, to plan and carry out a timely celebration of the 200th anniversary of the Constitution.

WHEREAS, the success of the commemoration of the Bicentennial of the Constitution depends on the widespread and enthusiastic involvement of public and private sector groups and organizations to enlarge public understanding and appreciation of the Constitution.

NOW, THEREFORE, BE IT RESOLVED that the Columbus County Board of Commissioners hereby proclaims that a bicentennial committee of Columbus County is hereby established for the purpose of planning and carrying out a meaningful celebration of the Constitution of the United States and encourage all our citizens to participate and take notice of the many blessings of this great nation we call America.

#### RESOLUTION - SEPTIC TANK REGULATIONS

The Board reached a general concensus to adopt the following Resolution in reference to septic tank regulations.

### RESOLUTION

The Board of County Commissioners at their regular meeting on the 18th day of May, 1987, adopted the following Resolution:

WHEREAS, Columbus County as many coastal counties, has a high water level table, and has experienced in recent years increasing difficulty in permitting desirable housing sites for septic tanks; and

WHEREAS, the Columbus County Health Department Sanitarians are bound by law to enforce the sanitary regulations as passed by the North Carolina Commission of Health Services, and that these regulations have been carefully created after much research and applied science experience from the North Carolina Division of Health Services; and

WHEREAS, at the present time there needs to be a review of the practicality of these new septic tanks regulations which have been in effect since the late 1970's; and

WHEREAS, the Board of County Commissioners of Columbus County, North Carolina, are cognizant of the fact that review of the regulations is long overdue;

BE IT, THEREFORE, RESOLVED by the Board of County Commissioners of Columbus County, North Carolina, that a copy of this Resolution be forwarded to the North Carolina Commission of Health Services and the representatives of Columbus County to the North Carolina General Assembly; and

BE IT, FURTHER, RESOLVED by the Board of County Commissioners of Columbus County, North Carolina, that the said Commission does hereby recommend that a blue ribbon committee be instituted to study the problems consisting of scientists in environmental health, realtors, houseowners, health directors, members of health and county commissioners; and

BE IT, FURTHER, RESOLVED that the Board of County Commissioners of Columbus County do hereby request state funds specifically be set aside for the county's health departments to assist and help support the large staffs needed to fulfill all the environmental health regulations; and

BE IT, FURTHER, RESOLVED that financial support and aid is needed from the State to the Division of Health Services in order to support more regional consultants to provide additional designed innovative plans to convert more potential homes and small business sites from the unusable category to the provisionally suitable category for septic tanks; and

BE IT, FURTHER, RESOLVED that the Board of County Commissioners of Columbus County, North Carolina, do hereby request from the North Carolina Commission of Health services permission to charge user fees to restaurants and

institutions for the required sanitation inspections now being presently performed and required by law.

# RESOLUTION - IN SUPPORT OF HB 307 ADDITIONAL ONE CENT SALES TAX

A motion was made by Commissioner Koonce, seconded by Commissioner Dew and passed unanimously to adopt a Resolution in support of House Bill 307.

RESOLUTION

WHEREAS, Columbus County has needs for its public school facilities of over \$46,000.00 in order to assure a quality education for our community's children; and

WHEREAS, the funds for our public schools are needed before 1993 in order to provide adequate facilities for classrooms and for compliance with State law; and

WHEREAS, to raise over \$46,000,000 in Columbus County will require a substantial increase in our present tax rate if these school facilities are funded through a local bond issue, or through any type of State loan requiring repayment with interest; and

WHEREAS, Columbus County is dependent upon agriculture as its number one industry that is vitally important to our local economy, and at this time that economy is suffering due to the poor agricultural economy and the serious financial problems faced by farmers; and

WHEREAS, the citizens of our County cannot afford the substantial tax increase that would be required to finance the facility needs for our public schools and to meet needs for a quality education for our children due to our lack of an industrial base and our heavy dependency upon agriculture; and

WHEREAS, a sales tax is more equitable in the distribution of the tax burden than the ad valorem property tax while providing funding for public school construction at a lower cost than borrowing through a bond issue that would require repayment with interest.

NOW, THEREFORE, BE IT RESOLVED, that the Columbus County Board of Commissioners does hereby support an additional one-percent increase in the State Sales Tax with all revenues to be provided for public school facility needs as introduced in the 1987 General Assembly under House Bill 307, and further does hereby encourage and support the passage of this Legislation by the 1987 General Assembly.
