The meeting was called to order by the Chairman and the invocation was given by the Reverend Charles Cook, Tabor City United Methodist Church.

APPROVAL OF MINUTES

A motion was made by Commissioner Norris, seconded by Commissioner Dew and passed unanimously to approve the September 8, 1987 minutes, as recorded.

SOUTHEASTERN ORATORIO SOCIETY - FUNDING APPROVED

Mr. Jimmy Scott, Mr. Jack Council and Mrs. Jennie Wright requested the Board to consider funding the Southeastern Oratorio Society as their organization was deleted from the 1987-88 adopted County Budget and donations is their only source of funding.

A motion was made by Commissioner Dew, seconded by Commissioner Norris and passed unanimously to fund the Oratorio Society in the amount of \$2,500 (the same amount allocated in the 1986-87 budget) and approve a budget amendment by appropriating funds in the amount of \$2,500 from Non-Departmental - Contingencies (10-660-9999) to be expended in Special Appropriations - Arts/Oratorio Society (10-690-9506).

COLUMBUS COUNTY SENIOR CENTER - BIDS FOR VAN

Mr. Sam Jordan, Chairman of the Senior Citizen's Advisory Council presented the Board with four (4) van bids with prices ranging from \$17,275.80 to \$20,176.00.

A motion was made by Commissioner Koonce, seconded by Commissioner Dew and passed unanimously to take the vans under advisement and include with all other request and contribute to on an as needed basis when funds become available.

COLUMBUS COUNTY INTERAGENCY TRANSPORTATION - PRESENTATION

Paul Pope, representing the Columbus County Interagency Transportation Council, presented a summarized report on publicly supported transportation in Columbus County from 1977-1987.

RECREATION - PLAQUE AND PROCLAMATION PRESENTED

Mike Mobley and Bill Johnson, Coaches for the Dixie Youth Baseball Team presented the Board with a plaque from the Dixie Youth Baseball Team on their recent success in being Runner-up in the Dixie Youth World Series.

The Board presented the coaches a framed Proclamation commending and congratulating the Dixie Youth Baseball Team on their achievment. Proclamation is recorded in Minute Book 20, page 20.

HELP MISSION - SAM DEROSA

Mr. Sam DeRosa, representing the Help Mission, questioned Mr. Richard Green representing Four County Community Services, Inc., concerning the publication and notification of local agencies of the public hearing on providing services for Columbus County. Mr. Green stated that Four County advertised the public hearing, as required by law, and sent letters to county agencies.

A motion was made by Commissioner Dew, seconded by Commissioner Norris and passed unanimously to direct the County Attorney and Administrator to meet with all concerned agencies on providing community services for Columbus County and with Four County Community Services and report back to the Board on their investigation.

SOCIAL SERVICES - MEDICAID AND AFDC EXPANSION

The Chairman stated that the Social Services Medicaid and AFDC programs have been expanded in which three employees will be needed; two in the Medicaid program and one in AFDC. The salaries for these positions are \$10,884 each, plus fringe benefits which will be 100% state funded.

A motion was made by Commissioner Norris, seconded by Commissioner Dew and passed unanimously to approve the employment of three additional employees at the salary of \$10,884 each, as recommended by the state, contingent upon the state providing funds for these positions.

TOWN OF LAKE WACCAMAW - APPOINTMENT

A motion was made by Commissionr Dew, seconded by Commissioner Koonce and passed unanimously to reappoint Leon Dudley to serve on the Lake Waccamaw Town Board of Directors as an extra-territorial member.

ST. JAMES VOLUNTEER FIRE DEPARTMENT - RADIO REQUEST

A motion was made by Commissioner Norris, seconded by Commissioner Koonce and passed unanimously to table the request from Emergency Management to purchase a radio for the St. James Volunteer Fire Department.

CITY OF WHITEVILLE WATER TOWER ANTENNAS

A motion was made by Commissioner Dew, seconded by Commissioner Norris and passed unanimously to enter into contract and agreement with the City of Whiteville to assume liability on antennas which are property of Columbus County which are installed on the water tower only. Contract is on file at the office of Clerk to the Board.

RESOLUTION - OVERPASS 211 & 74-76

A motion was made by Commissioner Norris, seconded by Commissioner Koonce and passed unanimously to adopt the following resolution in support of an overpass at the intersection of NC 211 and US 74-76.

RESOLUTION

The Board of Columbus County Commissioners of Columbus County, North Carolina, at their regular meeting September 21, 1987, unanimously adopted the following resolution:

WHEREAS, the rapid growth of traffic at the NC 211 and US 7476 in Bolton has posed a serious problem for taffic in all four directions approaching the intersection; and

WHEREAS, massive traffic tie-ups on weekends and holidays which have plaqued the Bolton area for the past three springs and summers is sufficient evidence that an overpass is desperately needed at the intersection of NC 211 and US 74-76 in Bolton; and

WHEREAS, it has been necessary on holiday weekends, such as Easter, Memorial Day, July 4 and Labor Day, to have officers from the Columbus County Sheriff's Department directing traffic for up to five hours; and

WHEREAS, the right-of-way for an interchange for US 74-76 and NC 211 north of the Bolton town limits has been purchased by the state, but plans to construct an over pass for NC 211 over the four-laned coast to the piedmont artery, are just plans.

NOW, THEREFORE, BE IT RESOLVED that the Columbus County Board of Commissioners are very concerned with the safety of all motorists with increasing traffic on both roads which will lead to inevitable collisions which will leave scars of misery on humans involved.

BE IT FURTHER RESOLVED, that the Columbus County Board of Commissioners is requesting that a new public hearing be scheduled on the Bolton project in order for updated information to be brought to the attention of the North Carolina Department of Transportation.
