Wealthier still are the ethical hunters and anglers who share this treasure with a youngster, friend or relative. We would like to urge hunters and anglers in Columbus County to recognize this year's Hunting and Fishing Day observance by inviting a friend, family member or co-worker to experience the outdoor traditions together and to continue our important work in wildlife conservation.

Ms. Duncan stated the County's Livestock Ordinance does not regulate this type of operation but they are considering possible amendments to the County Ordinance that will have rules on the so-called "dry waste" systems used by chicken growers.


No official action was taken.
