#### COLUMBUS COUNTY BOARD OF COMMISSIONERS Monday, May 21, 2012 6:30 P.M.

The Honorable Columbus County Commissioners met on the above stated date and at the above stated time in the Dempsey B. Herring Courthouse Annex Building, located at 112 West Smith Street, Whiteville, North Carolina, for the purpose of conducting two (2) Public Hearings and their regularly scheduled meeting on the third Monday.

6:30 P.M. PUBLIC HEARING -

**Proposal by Evergreen Volunteer Fire Department to Dissolve Fire Fee District and Establish Fire Tax District:** the purpose of this Public Hearing is to receive public comments.

#### **PUBLIC HEARING OPENED:**

At 6:30 P.M., Chairman Amon E. McKenzie called the Public Hearing to order, and stated the purpose of the Public Hearing is to receive public comments on the proposal by Evergreen Volunteer Fire Department to dissolve the fire fee district and establish a fire tax district. Chairman McKenzie requested that Mike Stephens, County Attorney, orally read the Policy on Comments at Public Hearings. Mr. Stephens orally read the policy in its entirety.

#### **COMMENTS**:

Chairman McKenzie opened the floor for comments. The following spoke.

### **Tommy Williams, Chairman of Board of Directors, Evergreen Volunteer Fire Department:** stated the following:

- 1. We have been trying to get a tax base fire district for the past sixteen (16) years;
- 2. The operating costs have doubled;
- 3. The pants and coats we wear cost over one thousand and 00/100 (\$1,000.00) dollars per set and they have to be changed every eight (8) years, and now our eight (8) years are up;
- 4. We are asking the Board of Commissioners to help us get our district changed to our tax base district because we are one of two (2) departments in the county that is a fee district;
- 5. Our insurance is fixing to go up;
- 6. If we don't get this tax base, we are going to have to close our doors; and
- 7. When our trucks tear up, they require a professional to work on them, and we don't have the funds to do that with.

#### **Discussion**:

**Commissioner Bullard:** What is the income for Evergreen Volunteer Fire Department now? **Tommy Williams:** We are averaging about thirty-three thousand and 00/100 (\$33,000.00) dollars. **Commissioner Bullard:** With the tax base, what would the income be? **Tommy Williams:** It will probably double our income.

**Commissioner Prevatte:** Is the eight (\$ .08) cents the least amount you can get by with? **Tommy Williams:** We probably could, but we need it. Some departments are getting from eight (\$ .08) cents to twelve (\$ .12) cents. You will need to ask Scott Merritt, Fire Marshal, about that. **Scott Merritt:** The tax base for the departments range from six (\$ .06) cents to twelve (\$ .12) cents, and the reason we went with eight (\$ .08) cents was, we went with the neighboring departments that Evergreen and North Whiteville Fire Departments will be running mutual aid with, and we kept it within the same area and the same range. The average is eight (\$ .08) cents.

**Commissioner Prevatte:** Who is on the six (\$ .06) cents tax base?

**Scott Merritt:** The departments are Williams Township, St. James, Roseland, Hallsboro and Buckhead. The other departments range from seven (\$ .7) cents to twelve (\$ .12) cents.

**Commissioner Russ:** What is your fire rating now? **Tommy Williams:** It is a 9, and if we don't get this, the fire rating will go to a 10.

**Commissioner Prevatte:** The major concern that I have heard from the public about this, is the tax on open farm land. I have been discussing this with Richard Gore, Columbus County Tax Administrator, today, and Richard will you explain that to the public.

**Richard Gore:** Tax appraisal is less than the market value, if the farm land qualifies. If you are on the program, and have ten (10) acres or more, and produce one thousand and 00/100 (\$1,000.00) dollars of gross income, then you would qualify.

**Commissioner Bullard:** The ten (10) acres that you are talking about has to be open land.

#### **PUBLIC HEARING CLOSED:**

At 6:49 P.M., Commissioner Norris made a motion to close the Public Hearing, seconded by Commissioner Russ. The motion unanimously passed.

Chairman McKenzie stated there would be a ten (10) minute recess.

# 7:00 P.M. PUBLIC HEARING: Proposal by North Whiteville Volunteer Fire Department to Dissolve Fire Fee District and Establish Fire Tax District: the purpose of this Public Hearing is to receive public comments.

#### **PUBLIC HEARING CALLED to ORDER:**

At 7:00 P.M., Chairman McKenzie called the Public Hearing to order and stated the purpose of the Public Hearing was receive public comments on the proposal by North Whiteville Volunteer Fire Department to dissolve the fire fee district and establish the fire tax district. Chairman McKenzie stated the Policy on Comments at Public Hearings that was orally read at the previous public hearing would stand for this public hearing. Chairman McKenzie asked Mike Bartley, Fire Chief of the North Whiteville Volunteer Fire Department, to present information relative to this request.

Mike Bartley, Fire Chief: stated the following:

- 1. I have been with the fire department for thirty-two (32) years;
- 2. We do not have enough money to survive;
- 3. We have been on a fifty and 00/100 (\$50.00) dollars fee for sixteen (16) years, and we have not had an increase in sixteen (16) years;
- 4. We receive approximately seventy thousand and 00/100 (\$70,000.00) dollars per year, and with all of the operational costs that we have, that is not enough to survive on;
- 5. We need help, and if we do not receive additional income, we will have to close our doors;6. Our operational costs are exceeding our income, and we have borrowed as much as we can
- borrow;
- 7. Our equipment is wore out., and needs work;
- 8. We have received one-half million dollars in federal funds through D.O.I. Grants, FEMA grants and Rural Development grants which did not cost the County any money; **and**
- 9. If our revenue does not increase, we will be forced to close our doors, and then the fire rating will not be there, and will escalate the cost of insurance.

#### Commissioner Russ: What is your fire rating?

**Mike Bartley:** Our fire rating is a 9, and if we can get some help, we can bring it down, but it takes money to do that.

**Commissioner Bullard:** Can you charge the insurance company for fire calls like you do rescue calls?

**Mike Bartley:** You can, but it is not as easy, and I am really not sure. When we first started, we were running forty (40) calls per year, and now we are running two hundred forty (240) calls per year.

**Commissioner Prevatte:** In our discussions, there is one thing that you have not mentioned to the public, and that is about the trucks being service tested.

**Mike Bartley:** We are required to have our trucks service tested, and the cost for each truck is anywhere from six hundred and 00/100 (\$600.00) dollars to one thousand and 00/100 (\$1,000.00) dollars. We are behind in doing this because we don't have the money.

**Commissioner Bullard:** Mike, you stated you were receiving approximately seventy thousand and 00/100 (\$70,000.00) dollars per year at the present time. If you get the tax base, what will the income be?

**Mike Bartley:** They told us it would be in the neighborhood of one hundred twenty-five and 00/100 (\$125,000.00) dollars.

**Commissioner Prevatte:** I have those figures Mike. With the tax, you would be receiving \$138,593, and the County's gives you \$10,543.

Mike Bartley: We are only asking to be treated equally. We need a service district with a tax base.

#### COMMENTS:

- 1. Richard C. Walley, 240 Lavilin Drive: stated the following:
  - A. I am the Assistant Fire Chief, and have been working with North Whiteville Volunteer Fire Department for twenty-two (22) years;
  - B. All the fire departments in the County, except North Whiteville and Evergreen, are receiving the fire tax;
  - C. It is unfair to the people, and it is unfair to us;
  - D. I agree with everything that Mike has stated, and the only thing he did not mention was that we run mutual aid with Evergreen, Chadbourn, White Marsh, Welches Creek, Brunswick, and we go into Bladen County with two or three different departments;
  - E. It is getting to the point where we can not afford anything;
  - F. A set of turnout gear for one (1) firefighter is \$1,800.00 dollars;
  - G. The FDA states this gear needs to be replaced every 7-10 years, depending on the frequency it is used;
  - H. When the citizens have to pay the \$80.00, they will save an additional \$300.00; and
  - I. If this fire tax does not pass, then we can't operate without funds.
- 2. **Greg Spivey:** stated the following:
  - A. I am the Chief of Brunswick Fire Department;
  - B. I am here to support Evergreen and North Whiteville Fire Departments;
  - C. We sacrifice our time; and
  - D. This will not only help Evergreen and North Whiteville Fire Departments, but it will help the surrounding fire departments because we all work together.
- 3. **Josh Cribb:** stated the following:
  - A. I am the Assistant Fire Chief in Brunswick, but I actually stay in the North Whiteville Fire District;
  - B. If my house burns down, the average person could not run out and rebuild; **and**
  - C. What they are asking for is not that much, and I would appreciate it if you could help them.
- 4. Vickie B. Coleman, 3717 Union Valley Road, Whiteville, NC 28472: stated the following:
  - A. I am the secretary of the North Whiteville Fire Department, and have been for 22 years;
  - B. When we have to borrow money, my name is the one that goes on the document; **and**
  - C. We should come to the realization that if one district has to pay the tax, than all the districts should have to pay the tax.
- 5. Robert Adams, 233 Mt. Calvary Road, Clarkton, NC 28433: stated the following:
  - A. I live in North Whiteville Fire District;
  - B. I support the fee district, but I would like to see the fee increased;
  - C. I would suggest the following priorities:
    - 1. Increase the fee schedule;
    - 2. As a last resort, establish the tax district; **and**
  - D. I favor the fee schedule, but whatever you do, utilize the method that will give these

two (2) departments enough to survive on.

#### 6. Russell Keith Worley, 12041 Red Hill Road, Clarkton, NC 28433: stated the following:

- A. I am a former fire chief for Clarkton;
- B. There are three (3) issues that I would like to talk about;
- C. We got the letter and I am here because of the letter, and I had no idea of what the rate was going to be;
- D. In the State of North Carolina, this rate could go up to fifteen cents per \$100.00 property valuation, once this is established;
- E. We have not seen any expenses, any budgets, any long-range projections, any capital expenditures, and how do we know that it will stay \$ .08?;
- F. This will double their income;
- G. I applaud all the firefighters and what they do;
- H. We got to keep a ring around this and know what they are doing;
- I. We need to know what has been spent, what is being spent, and what will be spent in the future to keep these services up;
- J. The ISO rating is very important and is based on 1 10 rating, and for each point, there is a 10% decrease in the insurance rate;
- K. The County needs to put strong emphasis on the ISO rating because this affects everybody; **and**
- L. What I would suggest is that the County Commissioners table this until we can get some permanent numbers.

#### PUBLIC HEARING CLOSED:

At 7:33 P.M., Commissioner Norris made a motion to close the Public Hearing, seconded by Commissioner Russ. The motion unanimously passed.

## Agenda Items #1, #2 and #3:MEETING CALLED to ORDER, INVOCATION and<br/>PLEDGE of ALLEGIANCE:

At 7:33 P.M., Chairman Amon E. McKenzie called the May 21, 2012 Columbus County Board of Commissioners Regular Session Meeting to order. The invocation was delivered by Commissioner Ricky Bullard. Everyone in attendance stood and pledged Allegiance to the Flag of the United States of America which was led by Commissioner James E. Prevatte

#### Agenda Item #4: BOARD MINUTES APPROVAL:

Commissioner Bullard made a motion to approve the May 07, 2012 Regular Session Board Meeting Minutes, as recorded, seconded by Vice Chairman McDowell. The motion unanimously passed.

#### Agenda Item #5: <u>PUBLIC INPUT</u>:

Chairman McKenzie opened the floor for public input. No public input was received either orally or written.

#### Agenda Item #6: <u>PRESENTATION - PYROLYSIS PROJECT</u>:

Melvin Ezzell, Director of Business Development, Standard Oil International, delivered the following presentation on the Pyrolysis Project.

- Pyrolysis Processing Technology can assist Columbus County in achieving a broad range of long-term goals, including:
  - -Adding 10-15 jobs
  - -Adding additional tax revenue
  - -Significantly reducing tipping fees
  - -Significantly reducing the amount of material deposited into landfills

-Significantly reducing the fuel costs for county school system and potentially all county departments

- Pyrolysis Processing Technology converts all carbon-based (carbonaceous) material into two (2) main by-products
  - -Synthetic Fuel (highway diesel)
  - -Inorganic Residue (small volume of carbon black)
- The Standard Oil, Inc. Pyrolysis System is a proprietary technology far superior to any thermal processing technology in the market;
- A sterile and homogeneous feedstock must be properly prepared before entering the Pyrolysis Unit;
- Potential feedstock as provided by Columbus County -
  - -Used Tires
  - -Municipal waste
  - -Wood, yard debris
- Feedstock enters the Pyrolysis chamber (transformation chamber) where temperatures ranging from 900F 1150F facilitate the <u>exothermic conversion</u> of the feedstock and ultimately, the generation of producer gases and carbon black;
- Producer Gas These are volatile gases which are extracted from the homogenous feedstock during the Pyrolysis Processing stage. These gases are then drawn from the Pyrolysis chamber with the use of a gas blower;
- Gas Scrubbing and Cleaning The gas blower used to extract the producer gas from the pyrolysis chamber draws it through a gas filtration system which cleans the gas of any hazardous or carbon particles. Next, the gas passes through a sulfur-scrubbing process. The result being a high-BTU, low-sulfur, clean and dry **Synthesis Gas**.;
- Generating Synthetic Fuel: The high-BTU gas is then processed through a gas-toliquefaction system to be converted into synthetic fuels.
- Fuel Examples: Heating oil, diesel fuel (Primarily), jet fuel, premium petrol.
- This integrated system is capable of producing high volumes of <u>ASTM International</u> <u>approved fuel</u> which can be used onsite or blended with traditional fuel to be sold on the open market.
- Self Sustainable System Pyrolysis Technology is self sustained:
  - 1. Volatile Producer Gas also used to power the SPECIALLY DESIGNED super-low-NOx burners used to heat the homogenous feedstock, keeping most mechanical needs within the system;
  - These systems are also able to produce electricity from the Producer Gas.
    If one Pyrolysis Unit is set up onsite and to be connected with an electrical production system, such as a gas turbine, it would provide all the electrical needs to
    - maintain the system. -This would allow the system to function completely self-reliant of all outside energy sources.
- World's Most Efficient Burner:

-The Standard Oil Pyrolysis System utilizes a patented and proven super-low NOx burner that achieves the <u>lowest level of NOx in the world</u> (5 to 9-PPM) with cleaner emission levels than even the best low-NOx boilers.

-this burner produces the lowest level of emissions (CO2,NO2, and SO2) compared with any other rated burner in the world.

-These burners operate from the Producer Gases originating within the system and are only functioning when the Pyrolysis chamber drops below levels ideal for exothermic conversion. This allows these systems to become the most efficient of their kind.

There are many advantages of Pyrolysis over other thermal processing technology, including:

-"Closed-loop" system produces NO emissions from the waste being processed, with the only emissions coming from the super low NOx burners used to indirectly heat the pyrolysis unit

-Avoidance of exposure to air, oxygen, open flame and high temperatures during pyrolysis greatly reduces the formation of toxic products and increases the energy content of the raw "producer" gas

-Ability to concurrently process multiple waste streams

-Ability to produce synthetic gas for production equipment, burners and boilers

-Ability to use raw "producer" gas for electricity production

-Modular engineering design concept provides for built-in redundancy of key components, and common maintenance and replacement parts thereby limiting downtime and maintaining near 100% production capacity

-Ready system scalability, downward and upward

-Self-cleaning pyrolysis system with little or no downtime

-System design provides for self-sufficiency without a need for outside sources of energy

-Potential for transportable design

- -Ability to design, deploy and operate fully-integrated, cost-effective systems
- Modular systems arrive ready for assembly
- Proposed Columbus County Project Benefits:
  - -It is the intention of SOI to locate our facility on the grounds of Columbus County's landfill site:
    - -Minimal disruption in waste flow.
    - -Better utilization of available space.
    - -Volume of material going to landfill will be significantly reduced.
    - -Reduction of current tipping fees by as much as 50%.
- SOI requests a nominal fee lease on the landfill site, suggest \$1/year for 25 years. In return, SOI will sell high C-tane low sulphur diesel fuel at a 10% market discount to the county school system.
- Proposed Equipment and Investment:
  - -100-120 tons/day will be approximately 4-5 tons/hour.
  - -Total gross diesel produced will be approximately 105-115 gallons/hour.
  - -Total will be approximately 2,500 gallons/day.
    - Standard's investment for such project will be:Pre-conditioning equipment\$600,000.00Pyro system\$10,000,000.00Fischer Tropsch system\$20,000,000.00Installation, startup\$5,000,000.00Storage tanks\$100,000.00Estimated Total Project:\$35,700,000.00
- Standard Oil, Inc. has entered into a JV agreement with Gulf Capital which gives SOI the financial backing to develop waste to energy projects throughout the North American and European marketplace.
- Columbus County's Energy Requirements:

-It is estimated that the school bus fleet of Columbus County consumes approximately 550,000 gallons of diesel fuel annually. With rising fuel costs and decreasing school budgets fuel costs are a large portion of the annual education budget.

-SOI pyrolysis unit will produce low sulphur high C-tane diesel that will provide Columbus County School system (and other county departments where applicable) with their fuel requirements at a significant reduction in cost.

- Columbus County Proposal (Columbus County Benefits):
  - -A privately funded 35 +/- million dollar facility will be built
    - -Construction of plant will temporarily employ approximately 40 people
    - -The operational facility will create 10-15 new full-time positions
    - -The tipping fees for our facility will be approximately 50% of the current rate

-The proposed by-product of this facility will be a high grade ultra low sulphur highway use diesel. We propose to sell this product to the county (school system, etal...) at 10% below the market rate.

-Our facility will reduce the amount of MSW going into landfills by more that 80% and the residual "Char" is an inert material that poses no environmental threat whatsoever.

Columbus County will establish the benchmark in recycling and green technology for all other producers of MSW in our region and state.

Commissioner Prevatte made a motion to take the Letter of Intent under consideration and check into the air quality issue, seconded by Commissioner Byrd. The motion unanimously passed.

Ben Douglas, Member of Elder Abuse Prevention Network, requested Board approval and adoption of the following Elder Abuse Awareness Month Proclamation.

#### ELDER ABUSE AWARENESS MONTH Proclamation

WHEREAS, elder abuse is the broad term used to identify mistreatment of elderly and disabled adults; and

WHEREAS, abuse and neglect of elderly and disabled adults is one of the most under recognized

and under reported social problems in this country; and

**WHEREAS**, the magnitude of the problem is likely to increase for several reasons, especially with the anticipated rise in the number of elderly population; **and** 

**WHEREAS**, mistreatment can take many forms: physical abuse, emotional abuse, sexual abuse, neglect by a care giver, self neglect, exploitation, and financial exploitation; **and** 

**WHEREAS**, between five hundred thousand (500,000) to five million (5,000,000) people suffer elder abuse every year; **and** 

WHEREAS, it is estimated that approximately one (1) out of every fourteen (14) cases of elder abuse is reported; and

WHEREAS, abuse of the elderly is preventable.

**NOW, THEREFORE, BE IT PROCLAIMED,** by the Columbus County Board of Commissioners that June, 2012, be recognized as **"ELDER ABUSE AWARENESS MONTH"** in Columbus County, and that all residents and other jurisdictions are encouraged to become more aware of this problem and join in the prevention of elder abuse.

Chairman McKenzie opened the floor for comments. The following spoke.

#### A. **Public:**

Robert Adams: I rode by the building at the Department of Aging and saw three or four

local contractors working, and it would be nice if we could put them to work on other projects we got in the county and reduce the unemployment rate.

#### B. **Department Heads:**

#### 1. Edward Davis, Soil and Water Conservation Director:

- A. I would like to thank you for appointing the Beaver Management Committee;
- B. They have elected John Deans as the Chairman, and Lofton Cox as the Vice Chairman;
- C. The committee will meet again on June 11, 2012, at 7:00 P.M. at the Cooperative Extension Meeting Room; **and**
- D. They are discussing some ideas and will be bringing these ideas to the Board very soon.

John Deans: stated the following:

- 1. Thank you for recognizing that we do have a problem here in the County;
- 2. We have a USDA beaver trapper dedicated to our County, and he is working as hard as he can;
- 3. His first priority is D.O.T., and he can barely keep up with the D.O.T. projects;
- 4. We are trying to develop a plan and we will present that plan to you when we get finished;
- 5. My experience with this situation is that we have a major problem, and need to get started soon; **and**
- 6. You will not get rid of the beavers, you will have to manage the problem by placing this in the budget every year.

#### **MOTION**:

Commissioner Prevatte made a motion for William S. Clark, County Manager, to place \$30,000 in a contingency fund for the Beaver Management Program, seconded by Vice Chairman McDowell. The motion unanimously passed.

- 2. **Kip McClary, Public Utilities Director:** stated the following:
  - A. The M.I.S. Department has made some signs for the promotion of the reduced tap fee that will be placed at intersections on a rotation basis in the County;
  - B. We are still waiting on revised quotes from the News Reporter;
  - C. We are continuing to run this ad in the Tabor City Tribune;
  - D. It is on every radio station in the County as a public announcement, and it is on the Swap Shop;
  - E. There is a report in the Board Packet, in the Information section, on the scrap tires;
  - F. The County does not pay the rent on any of the containers for scrap tires, but we do pay the tonnage disposal on every container that is collected from the different tire dealers in the County;
  - G. There are eleven (11) of those trailers being utilized in the County at this time, eight (8) at tire dealers, and three (3) at County facilities one (1) at the Byrdville site and two (2) at the Landfill;
  - H. We do get reimbursed from the State sales tax on tires for our cost for operating the system, and it is not a 100% reimbursement at this time, but we are working on improving those numbers as well; **and**
  - I. To offset the cost of this program, we implemented a disposal tax of \$2.00.

#### C. Board of Commissioners:

- 1. **Commissioner Byrd:** I apologize for being late. I was involved in a vote recount, and I still have a twenty-six (26) vote lead, and that is where we are.
- 2. Vice Chairman McDowell: What system do we have in place if we were to experience the same problem with our water system that the City of Whiteville experienced? Kip McClary replied stating that we would utilize the same system, the reverse 9-1-1.

- 3. **Commissioner Prevatte:** stated the following:
  - A. I saw the signs up for the promotion of the reduced tap fees for the water district and I compliment you;
  - B. Mr. Clark, when will we be ready to go out to bid for the Courthouse?; and

William S. Clark, County Manager: replied stating the following:

-Right now, we are waiting on the Department of Insurance to give us the okay, with a stamp of approval on the plans;

-We have not resolved the issue with the parking with the City of Whiteville;

-Glen Ware would like to present an update to the Board before it goes out to bid;

- -If all of this comes together, hopefully it will go out to bid in early fall;
- C. I am ready to set the budget workshops.

#### **MOTION**:

Commissioner Byrd made a motion to set the budget workshops after the June 04, 2012 Board Meeting, and then set each budget workshop systematically after each meeting, seconded by Commissioner Norris. The motion unanimously passed.

- 4. **Commissioner Norris:** It is good to see the number of employees here tonight, and I want to thank you.
- 5. **Commissioner Russ:** With the Pyrolysis Project, we could reduce the amount that is charged to our citizens for trash pickup.
- 6. **Chairman McKenzie:** stated the following:
  - A. I checked nursing home inspections information, and they look good;
  - B. The building at the Aging Department is looking good;
  - C. The hospital lease will be on the next agenda; and
  - D. D.O.T. will do some work around our Courthouse.
- D. **County Manager (William S. Clark):** I would like to introduce and welcome Shawn Martin. Shawn is a Public Administration student at Appalachian University, and he is going to be interning with Columbus County this summer.
