Food and Nutrition Unit:

Onsite Support ended for Food and Nutrition on January 18, 2013; this was a very beneficial asset to the unit while they were here. We still remain behind with processing and input of information in the NCFAST system; however workers are still working diligently to get the work out to get families fed.

Caseworkers are discovering that cases that are being completed in NCFAST when checked the next day are learning that the benefits did not pay out; therefore making workers having to double check their work on the next day.

Software has been installed to help the State determine the hold up time and glitches in the NCFAST system.

Reports in NCFAST continue to show inaccurate data; however they assure us that once everyone is fully implemented into this new system, the report should be accurate.

Based on report information that has been provided to counties, it shows for January that Columbus County had 979 potential cases eligible for re-certification and our staff has only completed 298 of those re-certifications. So far, there is not a way to indicate how many of the potential cases actually returned their re-certification forms. In comparing data with the other counties, it is apparent that other counties are experiencing the same delays.

Child Support Unit:

Chalissse Neely is the new Child Support Supervisor. The unit still continues to have 2 vacancies, however we have interviewed and hope we have found 2 candidates for the agents positions that are open.

Family and Children's Medicaid Unit:

We still have 2 vacancies in the unit and will soon be interviewing for those positions. We participated in a Webinar training in January on the beginning of alignment of certification periods between cases in Medicaid and Food and Nutrition cases.

Adult Medicaid Unit:

- 1. The Adult Medicaid unit still has one (1) vacancy for an Income Maintenance Caseworker position. Interviews are being scheduled. The Adult Medicaid unit has one (1) six (6) month employee Income Maintenance Caseworker transferring to Family and Children Medicaid effective 2/18/2013.
- 2. January 02, 2013 one (1) local hearing was heard by Sandra Benton.
- 3. January 23, 2013 Adult Medicaid Supervisors participated in an alignment of Certification Period Webinar in preparation of NC FAST.
- 4. January 24, 2013 State Hearing Officer conducted seven (7) disability hearings.
- 5. January 24, 2013 Adult Medicaid Unit Staff Meeting.
- 6. January 29, 2013 Supervisor Darlene Jenkins attended the SHIP Meeting.

Interpreter:

There were approximately sixty (60) in-office interpretations and approximately one hundred twenty (120) phone interpretations, mostly concerning Food and Nutrition Benefits.

HUMAN SERVICES BOARD REPORT

Intake/Investigation/Assessment:

The Intake/Investigation/Assessment Unit is currently experiencing a shortage in staff due to the recent retirement of the Lead Social Worker and due to another Social Worker being on medical leave due to surgery. The In-Home Services and Foster Care/Adoptions Units are assisting.

In-Home Services:

The In-Home Services Unit has three (3) Social Workers that will be attending Legal Aspects training in February as a part of the required training for first year Social Workers in Children's Protective Services.

Foster Care/Adoptions:

The Foster Care/Adoptions Unit, in collaboration with Children's Home Society, will host a public meeting on February 21, at 6:00 P.M., at DSS for anyone interested in becoming a licensed foster parent.

Adult Services:

The Adult Services Unit is now fully staffed.

Work First Employment:

The Work First Employment Unit continues to be pleased with the Family Participation Rate of 37.04% and the Two Parent Participation rate of 100%.

Child Day Care:

The Day Care Unit is sad to be losing one of its Social Workers who will be leaving DSS to work with another county agency.

Program Integrity:

The Program Integrity Unit, along with Energy Program Temporary Staff and a few agency staff, completed 860 Crisis Intervention Program applications, with 819 approvals, and 184 Low Income Energy Assistance Program applications, with 153 approvals.

- 1. This is the first grant of this type that we have done;
- 2. We have been focusing very heavily with individuals and companies that are expanding or improving through grants that are available through our partners, North Carolina Rural Economic Development Center;
- 3. They have a program called the Rural Hope Grant Program, and it is there to help rural communities to build medical related facilities;
- 4. In this case, Community Support Agency is in the process of buying land and building a building that would involve approximately \$1.1 million dollars;
- 5. They would add approximately 40 jobs;
- 6. They provide behavioral support services intervention type counseling, more in the mental health and support type medical field in Columbus County and surrounding counties;
- 7. This new facility would be located in the Delco area;
- 8. They have asked for us to work with them in putting in a grant application to the North Carolina Rural Hope Grant;
- 9. In order to do that, we need the support of the Commissioners before we can do that;
- 10. This will be a \$200,000.00 grant with a 5% match, and I have made it clear that the match has not been budgeted; **and**
- 11. The Rural Center has instructed me as to how the 5% match can be handled with no cost to the County

Commissioner Prevatte stated there may be some problems with the services being provided by the Community Support Agency, and he needed time to check into this matter.

MEMORANDUM OF UNDERSTANDING between COLUMBUS COUNTY and RIEGELWOOD SANITARY DISTRICT regarding the TEMPORARY SUPPLY of POTABLE WATER to RIEGELWOOD SANITARY DISTRICT

Whereas Columbus County has developed water districts throughout the county for the purpose of providing safe drinking water to its citizens and businesses, and

Whereas Riegelwood Sanitary District previously constructed an emergency interconnect with the Columbus County water system which has been kept closed except for periods of emergency use, and

Whereas the quality of water supplied to Riegelwood Sanitary District by other entities is no longer desirable to the citizens it serves, and

Whereas Riegelwood Sanitary District is offering to purchase potable water in an amount not to exceed 150,000 gallons per day from Columbus County at an interim rate of \$2.50 per thousand gallons that is subject to be changed upon completion of a "County Wide Engineering Study", and

Whereas Columbus County presently has surplus capacity that is obligated to its present customers but desires to provide the Riegelwood Sanitary District an emergency supply on an interim basis, and

Whereas the Engineering Study will evaluate and determine the required improvements necessary

Whereas Riegelwood Sanitary District agrees it will hold Columbus County harmless of all loss, claims, judgments or penalties resulting from the interruption of service, quality of water and/or lack of available supply, and

Whereas Riegelwood Sanitary District agrees that should current studies being performed by Columbus County determine that it is unfeasible for Columbus County to continue with supplying the above volume of water at the above rate it will release Columbus County from this Agreement without recourse or action.

NORTH CAROLINA COLUMBUS COUNTY

This **LEASE AGREEMENT** (hereinafter referred to as "Lease"), is made this _____day of _____, 2013, between COLUMBUS COUNTY FARM BUREAU, INC., a nonprofit corporation hereinafter referred to as "Lessor" and COLUMBUS COUNTY, a North Carolina body politic, hereinafter referred to as "Lessee".

WITNESSETH:

THAT the Lessor, for and in consideration of the mutual agreements, covenants, stipulations, and forbearance herein, lets and leases to the Lessee, and the Lessee does hereby accept as tenant of the Lessor, the following-described two tracts of land:

Tract One: That certain tract of land having an identifying property number of 6212 and being in Whiteville Township, Columbus County, North Carolina. Said tract is further described in Deed Book 945 Page 79 of the Columbus County Registry.

Tract Two: That certain tract of land having an identifying property number of 2631 and being in Whiteville Township, Columbus County, North Carolina. Said tract is further described in Deed Book 945 Page 81 of the Columbus County Registry.

THAT the Lessor and Lessee agree to the following terms, responsibilities and stipulations:

1. The term of the Lease is for two (2) years, renewable for a one (1) year period. Either party may terminate the lease by giving (60) sixty days notice.

- 2. The Lessor will receive an annual payment on or before September 1 of each year in advance of the year of use. The Lessee will pay an amount of nine hundred and sixty nine (\$969.00) dollars annually as lease payment for as long as this Lease is in effect. The lease payment shall be prorated on a daily basis should the Lease be terminated.
- 3. The Lessee will be responsible for insurance covering the leased premises. Lessee shall indemnify and hold Lessor, its agents and employees, harmless against any loss and all claims, demands, causes of actions, or other liability, including attorney fees, on account of property damages arising out of or relating to the leased property, resulting from the negligence of or the willful act or omission of Lessee, its agents, employees and assigns.
- 4. The Lessee will use the specified leased property only for parking as an auxiliary use of the Courthouse and Administrative Complex. No other use is permitted except by mutual agreement set forth in an amendment to this Lease. The Lessee will keep the premises in a neat and orderly appearance. Lessee shall rope off the designated leased area used for parking and mark the area with appropriate parking signs. With termination of this Lease, the Lessee will restore the property to its original appearance.
- 5. Failure of the Lessee to meet the performance requirements under the terms of this Lease and, if unresolved through mediation, rescinds this Lease, returning the Property to the Lessor.
- 6. This Lease contains the entire agreement of the parties hereto as to their subject matter and may not be altered, amended or modified except by a writing signed by both parties.
- 7. This Lease shall be governed by the laws of the State of North Carolina and any action or proceeding relating hereto shall only be brought in the Superior Court of Columbus County, North Carolina.
