Herring Courthouse Annex Building, located at 112 West Smith Street, Whiteville, North Carolina, for the purpose of conducting Budget Workshop #2 on the Proposed Columbus County 2013 - 2014 Operating Budget.

WORKSHOP CALLED to ORDER:

At 5:00 P.M., Chairman Charles T. McDowell called the June 03, 2013 Proposed Columbus County 2013 - 2014 Operating Budget Workshop #2 to order.

WORKSHOP MEETINGS DEFINED:

- **First:** the workshop meeting is to inform the Board and permit discussion no final action is taken; **and**
- Second: the procedures are less formal that at a regular meeting, but such meetings are part of the decision-making process, deliberations are going on, and therefore, they constitute "official meetings".

CORRECTIONS/CLARIFICATION:

Bobbie Faircloth: I have handed out some corrections to the Senior Centers. I have transferred the Retirees Health Insurance cost from the Chadbourn Senior Center to the Whiteville Senior Center. Through the upcoming year, we will apply this expense to the applicable Senior Center.

Questions were asked as to the varying expense items for the senior centers listed in the budget. Bobbie Faircloth provided the following information on the expenses for the senior centers.

Expense Equatability of Senior Centers:

Discussion was conducted relative to the information for rent and utilities that is listed in the

budget and the information in the actual agreements and discrepancies were discovered.

William S. Clark, County Manager, stated these discrepancies needed to be checked into to determine the correct amount.

After additional discussion was conducted, it was the general consensus of the Board that a fair and equitable system needed to be developed for the senior center sites.

DISCUSSION/QUESTIONS/COMMENTS:

Chairman McDowell stated, on behalf of the Board, we appreciate the work that you did and the thought that went into the process. Chairman McDowell stated we will take turns in the discussion, and opened the floor for discussion/comments/questions.

Vice Chairman Bullard: stated the following:

- 1. I would like for the three (3) school systems to get more money for security purposes;
- 2. I would suggest that we pull \$250,000.00 and divide this equally between the three (3) school systems; **and**
- 3. I am not in favor of adding more Resource Officers to the schools.

Discussion:

- -The different needs for each school;
- -How to monitor the funds if given to the school systems;
- -The method of prorating the amount given to each school system;
- -Earmarking the money given for security purposes only;

-This being a one-time only appropriation; and

-The school systems providing invoices for the purchase of security items.

Commissioner Russ: On Page 63, Soil and Water Conservation, Edward Davis needs a vehicle that has not been budgeted. His board has authorized \$5,000 to be used out of the No-Till Drill funds to be used towards this purchase.

Discussion:

- -The poor condition of the present vehicle;
- -The moving of the no-till-drill from place to place;
- -Not having to pull the no-till-drill;
- -The need for a new vehicle or an used vehicle.
- -The type of vehicle to purchase; and

-Allocating \$12,000 and utilizing the \$5,000 from the No-Till Drill funds.

Commissioner Byrd: We are looking at allocating \$262,000.00 of additional funds, and if one (\$0.01) cent tax generates \$300,000.00, then that will equate to 8/10 of 1%. We need to look at this budget closely.

Commissioner Prevatte: stated the following:

1. Page 31: What is the Contracted Services?

Bobbie Faircloth: this covers a lot of different areas. It covers the exterminating services, and it may cover the contract cleaning the yard.

William S. Clark: here is the breakdown of the \$10,890:

Bakers Bug (exterminating)	\$960
Bakers Bug (termite)	\$150
Nance Cleaning	\$8,280
McQueens Nursery	\$1,500

- 2. Page 32: Salaries and Wages Regular, who are the people?
- Tony Soles: one (1) maintenance person and four (4) housekeepers.
- Page 46: Salaries and Wages Regular, you are recommending \$719,544.00.
 Bobbie Faircloth: That is a figure she did not give me when we were inputting the information for the herdest. Thereaster the hereaster of \$720,000 months of calculate. This is
 - information for the budget. They actually have around \$720,000 worth of salaries. This is not correct.
- 4. Page 93: Public Assistance Programs, what is LEIAP?Bobbie Faircloth: That is energy assistance that comes from the State.
- 5. Page 121: Tourism Development Authority, are we still paying \$3,240.00 in rent for

someone working half time for Tourism and half time for Whiteville Chamber of Commerce. **William S. Clark:** it is my understanding that this arrangement is temporary, and in December, it could change.

6. Page 128: Fire Department revenues - the projected amount is much less than the recommended amount. Why is that?

Bobbie Faircloth: this is based on the information that I receive from the Tax Department on their assessed value, and on a 96% collection rate.

7. Page 141: Water District II: Lease Agreement CSX - why are we having to pay this? **Kip McClary:** this is for rights-of-way.

Commissioner Burroughs: stated the following:

- 1. We have discussed many things that we need to do inclusive of implementing Phase II of the pay Plan;
- 2. The one thing we have not talked about is we don't know what the State will do;
- 3. We don't know what kind of mandates that will be implemented and what funds will be cut; and
- 4. We need to be very prudent on how we look at this tax verses spending with this budget.

Commissioner McKenzie: stated the following:

- 1. I applaud the County Manager in having the insight on where we need to be;
- 2. We have an awesome task ahead of us;
- 3. Our goal and objective needs to be to try and raise the Fund Balance;
- 4. We are proposing to go against the grain;
- 5. Cutting taxes and not giving our employees an increase is not favorable;
- 6. We need to be consistent with what we do;
- 7. I will support the budget, but I would like to see fairness; and
- 8. This budget needs to be adopted exactly like it is with the necessary adjustments.

Vice Chairman Bullard: I still think we need to give funds to the school systems to be used for security.

Commissioner Russ: stated the following:

- 1. We spent money for a Pay Plan Study and we have implemented Phase I of that study;
- 2. We have employees who have been with the County for many years and it is not right for new employees to come on board making more money than the ones that have been here many years; **and**
- 3. I am all for helping our children in any way we can.

Commissioner Byrd: stated the following:

- 1. We know what our revenue will be at the present tax rate;
- 2. I am all for the schools and their security needs;
- 3. We have talked about an additional \$262,000 increase;
- 4. If the proposed tax cut happens, we will be losing \$300,000
- 5. I think we should take the budget as it has been presented;
- 6. We don't need to play games with our constituents;
- 7. If we continue to spend and have tax cuts, we could be facing a 5-6 cents tax increase in a few years;
- 8. I think we have a good budget; **and**
- 9. We don't know what the State will do.

Commissioner Prevatte: stated the following:

- 1. Eight (8) years ago, we were spending more money that we were taking in;
- 2. We were constantly going into the Fund Balance, and received a letter stating that we were below the required percentage;
- 3. We have worked hard not to let the expenditures exceed the revenue;
- 4. If you don't stay at revenue neutral, you will have a tax increase;
- 5. Take out a one-time amount of \$250,000 for the school systems for security and a \$12,000 amount for the Soil and Water Program; **and**
- 6. I still encourage to consider going down one (\$0.01) cent in the tax rate for a revenue neutral.

Chairman McDowell: stated the following:

1. I do support the one-time expenditure for the school systems;

- 2. I still support the \$12,000 expenditure for the truck for Soil and Water;
- 3. I do support the revenue neutral;
- 4. My understanding is that a one (\$0.01) cent tax decrease will still turn a profit for the County;
- 5. The money came from the taxpayers, they paid it, we took it, we saved it and made money and it is in the bank; **and**
- 6. I support the one (\$0.01) cent tax reduction.

WORKSHOP CLOSED:

At 6:23 P.M., Commissioner Prevatte made a motion to close Budget Workshop #2, seconded by Vice Chairman Bullard. The motion unanimously passed.

Prevatte.

Commissioner Prevatte made a motion to adjust the June 17, 2013 Agenda by adding the following Agenda Add-on to be Agenda Item #21C, seconded by Commissioner McKenzie. The motion unanimously passed.

Agenda Item #4: <u>BOARD MINUTES APPROVAL</u>:

Commissioner Burroughs made a motion to approve the June 03, 2013 Budget Workshop Minutes, as recorded, and the June 03, 2013 Regular Session Board Meeting Minutes, as recorded, seconded by Commissioner Russ. The motion unanimously passed.

Agenda Item #5: <u>PUBLIC INPUT</u>:

Chairman McDowell opened the floor for public input. No public input was received either orally or written.

Agenda Item #6: <u>COURTHOUSE - UPDATE on HISTORIC COLUMBUS COUNTY</u> <u>COURTHOUSE</u>:

Paul Bonsall, Ware, Bonsall Architects, delivered the following update on the historic Columbus County Courthouse.

1. I met with the Courthouse Design Committee last week to show them plans of the renovated historic Courthouse that we came up with;

- 2. A number of changes were brought up and members of the Committee thought it should be brought before the Board so we could have a look at them;
- 3. A number of items that came up were a little bit of a change;

First Floor:

- 4. The original program for the building indicated that the District Court Judges were to be included in the historic Courthouse, then we got some feedback that perhaps it would be better for the District Court Judges to stay where they are;
- 5. Another comment that came up was perhaps that instead of two (2) non-jury courtrooms, that the County would better utilize one (1) large courtroom to be used for juries;
- 6. I have been asked to come to this meeting to present the new plans to you to see if this is amendable to you;
- 7. This is the Schematic Design Phase and is very preliminary;
- 8. We are looking at maintaining most of the historic character of the building;
- 9. We are looking at putting the District Attorney's Office on the First Floor,
- 10. A small area will be the Magistrate's Office and we are looking at increasing the size of the bathrooms;
- 11. We are trying to maintain the corridors and reduce the entrances to one (1) public entry for security reasons;

Second Floor:

- 12. The original plan was to have two (2) courtrooms, and a large interest was expressed to change that to one (1) large jury courtroom took back to the original courtroom that would accommodate four hundred (400) people;
- 13. We would be putting in some restrooms, the Superior Court Judges Suite, and a fairly large Jury Deliberation Area;
- 14. It maintains the offices of the Superior Court Judge;
- 15. That is about all we could fit into the 18,000 square foot building;
- 16. It was originally thought the building had 26,000 square feet, and when re-measured it is showing 18,000 square feet.

Agenda Item #7: <u>COURTHOUSE - SECURITY CONCERNS</u>:

Sheriff Christopher L. Batten requested that Judge Doug Sasser address the Board concerning security at the Columbus County Courthouse. Judge Sasser stated the following:

- 1. In my traveling across the State, I have seen security systems in old and new courthouses;
- 2. One of the complaints that we are getting here are safety concerns;
- 3. Ladies that frequent the Courthouse are bringing large handbags with them, a policy was put into place prohibiting large handbags being brought into the Courthouse, and then problems were presented as to what a large handbag is;
- 4. What I have seen in most counties is an x-ray scanner which is very fast;
- 5. In my conversations with the Sheriff and Major Hatcher, our recommendation will be for the x-ray scanners in the new Courthouse Annex and the historic Courthouse;
- 6. Our plan is to keep the metal detectors also; **and**
- 7. We need to have point-of-entry security.

Discussion:

-X-ray scanner is the most effective and economical method to use;

-Historic Courthouse has two (2) entrances;

-Need to make the East and West doors at the Historic Courthouse secure;

-Use Metal detector at existing Courthouse Annex;

-Purchase two (2) x-ray scanners that are already included in the plans for the new Courthouse Annex;

-Use two (2) x-ray scanners at the Historic Courthouse now, then move one (1) to the new Courthouse Annex when completed, put one (1) x-ray scanner in storage until the renovation has been completed, and then move one (1) back to the Historic Courthouse; **and**

-Need to have a plan to make all locations where court is being held secure.

It was the general consensus of the Board to purchase two (2) x-ray scanners that are already included in the construction plans for the new Courthouse Annex to be used at the Historic Courthouse, then move one (1) to the new Courthouse Annex when completed, put one (1) x-ray scanner in storage until the renovation has been completed, and then move one (1) back to the Historic Courthouse.

Sheriff Batten stated the following:

- 1. It has come to a point where we feel like Southern Health Care is not providing the services at the cost they initially showed us in the beginning approximately two (2) years ago;
- 2. After the first year, we incurred some additional costs and we tried to re-negotiate with Southern Health Care;
- 3. I discussed this with Mr. Clark and he encouraged me to stay with them for one (1) more year;
- 4. This year different issues have come up, and it appears there could be some more issues;
- 5. The five (5) sheriffs in the surrounding counties have a meeting once a month to compare ideas and keep each other updated;
- 6. Sheriff Ingram in Brunswick County has gone with Transform Health Care who is with us tonight;
- 7. Laura Busbin with Transform Health Care is with us tonight to explain and answer questions that you may have;
- 8. I am recommending that we change to another health care provider to see if they can keep more in line with the price and cost that we originally agreed to; **and**
- 9. They are going to stay a shade below the cost that we originally agreed to in our first contract.

Laura Busbin, Transform Health Care, stated the following;

- 1. What we are bringing to the table that you are currently missing is the case management model, which is everything that your private insurance has;
- 2. This is what you are missing within your jail managing your inmates at this time, and this is the area where we have seen huge success in all of our other facilities;
- 3. We have been in this business for about ten (10) years and we are a Georgia based company; and
- 4. What we have seen repeatedly when we implement our case management models, is that we can better control the cost, better manage your inmates' healthcare and give them better healthcare.

After discussion was conducted relative to the contract not being made available to the Board members and the County Attorney, Commissioner Burroughs made a motion to table this Agenda Item until the July 01, 2013 Board Meeting, seconded by Commissioner Prevatte. The motion unanimously passed.

Algernon McKenzie, Social Services Director, delivered the following Administrative Update.

Columbus County DSS Monthly Administrative Update For Service Month May 2013 June 17, 2013

Monthly agency staff meetings continue to be held with staff and supervisors. During the last meeting, staff was reminded of the agency protocol in handling issues. (Supervisor, Program Manager and then the Director.)

On May 9, 2013, I attended the Director's Executive Board Meeting in Raleigh. We received updates on new policy for Work First and NCFAST. We also learned the State will continue with a coordinated system for Medicaid Transportation; at least for this fiscal year. They have determined the cost of a statewide system is about the same as it is with the present system.

A Department Head Meeting was held on May 15, 2013. We continued with agency updates and the budget was discussed by Mr. Clark.

I attended some local committee meetings this month. They were; Columbus County Transportation Advisory, Four County Board Job Link Leadership Team and I met with a representative from Telemon.

On May 30th and 31st, I attended the Eastern Regional Director's Meeting at Atlantic Beach, NC. I participated in a panel discussion about agency consolidation. Ms. Deana Hatcher and Mrs. Cyndi Hammonds attended the Fiscal part of this meeting. In our joint sessions, we were given updates on NCFAST Phase 2. There are changes to the screens in the system and the State is still working on issues noted by counties. The dates for the pilot counties have been pushed up from June 17th to June 24, 2013. We also learned the drug testing for Work First recipients is probably going to happen.

We are still waiting to see what the State's budget will look like. We could possibly see 37 million dollars in funding cuts.

During our session, we also learned NCFAST is still working with the Feds on implementing the Affordable Care Act requirements for medical insurance and how it will affect local agencies. Columbus County could see about 675 projected Medicaid seekers by 2014; which is a 1.16% increase in traffic or inquiries for medical insurance.

Food and Nutrition Unit

The Food and Nutrition Department continues in their ability to maneuver and adapt to the NCFAST system; however the state still has glitches within the system that causes delays but the staff

continues to strive to meet deadlines in a timely manner. They have participated in webinars that is preparing Medicaid staff for NCFAST. These webinars have been a training tool for what is changing with the Food and Nutrition Department in NCFAST. The Food and Nutrition Department was represented at the Columbus County Senior Picnic that was held at the Fair Grounds on May 14th. Program information was available as well as door prizes and free items for seniors. Due to the temporary absences of 2 staff members, they have to reorganize the work to ensure that clients are served as quickly as possible. They met their Emergency processing deadlines and strive to keep their 30 day timely deadlines met.

Family and Children's Medicaid

Family and Children's Medicaid has attended webinars in preparation of NCFAST; these webinars have informed them of reports that will be generated to help "clean up" anything that may cause problems when the NCFAST system is launched for Columbus County. These reports include aligning caseheads between the units; example if the Mom is the casehead in Medicaid and the Dad is the casehead in Food and Nutrition, they must make the same person the casehead in both cases. These reports will have to be worked along with the workers daily assignments. We are also preparing for each worker having to complete a 20 hour web based training prior to their 2 $\frac{1}{2}$ day classroom training that is a requirement for NCFAST. Family and Children's Medicaid passed all their monthly compliance scores at 100%.

Work First Family Assistance/Cash//Medicaid Transportation & Supportive Services

Work First passed all of their monthly compliance scores and continue to attend webinars in preparation for NCFAST. Medicaid Transportation is still maintaining at the same level of proficiency and still awaiting the decision from the State Office as to whether they will keep this service at the local level. WorkFirst met their compliance rates for May at 100%.

Medicaid for the Aged, Blind and Disabled/Rest Home and Nursing Home/CAP

The Adult Medicaid Unit still has one vacancy in the unit. Adult Medicaid was also represented at the Senior Picnic on May 14th and program information was available and questions were answered for seniors about the program. They participated in webinars that are preparing them for NCFAST. Adult Medicaid met all their compliance scores for May.

Child Support

Sally McDonald, our State Child Support Representative made her monthly visit on May 8th and reviewed updates to Child Support policy and completed 2nd party reviews on randomly pulled cases. Child Support has 2 agents that are still in training and the paralegal position is vacant. The unit prepared 220 cases for court. They passed all their compliance scores for the month of May in Establishment and Enforcement.

Kip McClary stated the following:

- 1. On May 22, 2013, we received bids for this project which came in significantly over budget;
- 2. I informed you that we would need some additional funding;
- 3. After working with Bobbie Faircloth, Finance Director, and William S. Clark, County Manager, we think we have come up with a solution;
- 4. It is going to require that we ask of you tonight for nine hundred thirty thousand and 00/100 (\$930,000.00) dollars to be borrowed from the General Fund;
