Agenda Items #1, #2 and #3: <u>MEETING CALLED to ORDER, INVOCATION and PLEDGE of ALLEGIANCE:</u>

At 6:30 P.M., Chairman P. Edwin Russ called the October 20, 2014 Columbus County Board of Commissioners Regular Session Meeting to order. The invocation was delivered by Commissioner James E. Prevatte. Everyone in attendance stood and pledged Allegiance to the Flag of the United States of America which was led by Commissioner Amon E. McKenzie.

Chairman Russ stated he needed a motion and a second to approve the following Agenda Add-on to be Agenda Item #12A.

Resolution - Resolution in Total Opposition of Ruling on "Same-Sex Marriage": Commissioner Ricky Bullard is requesting Board approval and adoption.

(Commissioner Bullard will be present to explain and answer any questions the Commissioners may have.)

Commissioner McKenzie stated opposition to the Agenda Add-on. After a brief discussion was conducted, Commissioner Bullard made a motion to approve the Agenda Add-on, and for it to be Agenda Item #12A, seconded by Commissioner Prevatte.

Agenda Item #5: BOARD MINUTES APPROVAL:

Commissioner Bullard made a motion to approve the October 06, 2014 Regular Session Board Meeting Minutes, as recorded, seconded by Commissioner Byrd. The motion unanimously passed.

Agenda Item #6: <u>PUBLIC INPUT</u>:

Chairman Russ opened the floor for public input. No public input was received either orally or written.

Agenda Item #7: MONARCH MENTAL HEALTH and HUMAN SERVICES - ESTABLISHMENT of DATE and TIME for PUBLIC HEARING:

Laurie Weaver, Director of Grants and Foundation Relations, requested the Board to establish November 03, 2014 as the date for a Public Hearing on a 5310 Transportation Grant. (A time needs to be established.)

Commissioner Byrd made a motion to establish November 03, 2014, at 7:00 P.M., as the date and time to conduct a Public Hearing on the 5310 Transportation Grant for Monarch Mental Health and Human Services, seconded by Commissioner McDowell. The motion unanimously passed.

Agenda Item #8: PUBLIC TRANSPORTATION - ESTABLISHMENT of DATE and TIME for PUBLIC HEARING:

Charles Patton, Public Transportation Director, requested the Board to establish November 03, 2014, at 6:30 P.M., as the date and time for a public hearing on the North Carolina's Public Transportation funding.

Commissioner McKenzie made a motion to establish November 03, 2014, at 6:30 P.M., as the date and time to conduct a Public Hearing on the North Carolina's Public Transportation funding, seconded by Commissioner Prevatte. The motion unanimously passed.

Agenda Item #9: DEPARTMENTAL UPDATE - COOPERATIVE EXTENSION:

Dalton Dockery, Cooperative Extension Director, delivered the following departmental update to the Board.

- 1. The staff is doing fine, and we are going through a Strategic Plan;
- 2. I will discuss the impacts that Cooperative Extension has on people;
- 3. Fighting Foodbourne illness (Family and Consumer Science):

Problem: Foodbourne illness cost the United States billions of dollars each year in lost productivity, hospitalizations, long-term disability, and even death. Foodbourne illness is nearly 100% preventable if safe food handling practices are applied from the time food is received until it is served.

Solution: NC Cooperative Extension Program, Meleah Collier, Family and Consumer Science Agent, provided a ServSafe course to 27 participants from various food service establishments. 21 Participants passed the exam and will be given 2 points credit toward their health inspection for having food safety training.

Impact: The estimated cost savings for preventing one foodbourne illness in the 27 food establishments is over \$100,000.00.

4. Farmers are looking for savings (Agriculture):

Problem: Farm cost and production continue to rise on a yearly basis. Combines cost almost as much as a house.

Solution: Cooperative Extension has encouraged farmers to use no-till as a production practice on at least part of their crop acres. Field days and demonstrations have taught the benefits of no-till practices.

Impact: Approximately 40% of the corn acreage was grown on no-till, this is the largest amount of no-till by far. The amount of no-till represents a sizable saving in the equipment, fuel and labor expense in preparing acres for planting a crop. There are also the environmental benefits of reduced soil erosion, compaction, an increase of organic matter and improvements in soil structure.

5. Columbus County Deer (Livestock):

Problem: Columbus County has a huge deer population and each year thousands of acres are damaged because of deer feeding in commercial agricultural crops.

Solution: Cooperative Extension, Columbus County Tourism, Wildlife Actions and a group of concerned farmers partnered to develop a cooperative hunting initiative called the "Farmers Managed Deer Hunt Program". Over 15 farmers are currently participating in the program and 1,100 acres are actively used in the fee for the hunting program.

Impact: This program has provided farmers a way to reduce the damage to their crops

while at the same time increasing farm profitability as an alternative income source.

6. Entrepreneurship (4-H):

Problem: There is a strong need for youth to develop entrepreneurial skills and the Cape Fear Young Adult Conference committee approached Extension about conducting a workshop to promote education, employment and entrepreneurship to underserved and limited resource youth and young adults.

Solution: Nakoma Simmons, 4-H Agent, and Meleah Collier, Family and Consumer Science Agent, worked with 81 participants between the ages of 16-24. They held a workshop that introduced basic entrepreneurial concepts and provided resources to youth interested in following an entrepreneurial path.

Impact: Based on evaluation results 91% increased their knowledge and 50% of the participants were willing to make the necessary changes in their lives to become entrepreneurs. Examples of what they have and are doing were writing a business plan and developing a network to help support their business venture.

7. Downeast Connect (Agriculture):

Problem: Small farmers are always searching for new means of marketing and selling their product.

Solution: Downeast Connect helps farmers sell specialty crops and other locally sourced foods to the Wilmington, NC area by providing them with a website based farmers market. **Impact:** 900 registered customers across 12 different buying clubs that are serviced by over 80 registered farmers and food-related businesses and over \$130,000 in sales since the inception of Downeast Connect.

Agenda Item #10: SOCIAL SERVICES - MONTHLY ADMINISTRATIVE UPDATE:

Algernon McKenzie, Social Services Director, delivered the following Monthly Administrative update.

On September 11, 2014, I attended our Executive Board Meeting for County Directors. During this meeting, we were given updates on the Medicaid and FNS backlog. The Feds are continuing to monitor processing times in North Carolina. We were encouraged to continue to work applications and re-certifications as quickly as possible. Also, to continue to look at the use of overtime, comp time and temporary staff. Wayne Black, our DHHS Director, stated; "counties need to be able to sustain its efforts to get benefits processed in a timely manner; and overtime and comp time has helped, but is not a sustainable plan to keep work current". He encouraged us to use the 75% reimbursement that has been approved for counties to employ more staff, if possible. Columbus County continues to make some progress, but is still slow; and we continue to get more applications and have NCFAST issues. We were also informed open enrollment for Medicaid will re-open on November 15, 2014; which will produce even more applications for the Affordable Care Act. I continue to talk to our Supervisors and workers about issues and the added workload. I am concerned about the effect NCFAST is having on our agency and our ability to get benefits to citizens timely. I have contacted and met with our State Support Representative about these concerns.

The State will provide some NCFAST management training for Income Maintenance Supervisors at the Social Services Institute, which will be held October 22 – 24, 2014; in Hickory, NC. We plan to send some of our Supervisors and staff.

We were fortunate in September, to get an on-site support worker from the State. The worker is assigned to help us trouble shoot cases for about two weeks.

I have met with Melinda Lane, who oversees CIP and LIEAP. We are in the process of getting vendor agreements signed, staff in place for training; and flyers are ready to go out to the community. We are planning to begin taking applications for CIP on October 27, 2014. At this point, we have \$279,722.70.

Other meetings attended in September were the Columbus County Transportation Advisory Board, Department Managers, Job Link Leadership Team; and Four County Family Empowerment Self-Sufficiency meetings.

Vacancies/Updates/News for September 2014

Intake/Investigation/Assessment:

The Intake/Investigation/Assessment Unit continues to have a Social Worker on limited duty, although this Unit is currently fully staffed. Referrals and caseload numbers continue to be slightly higher than average.

In-Home Services:

The In-Home Services Unit continues to be short-staffed due to a Social Worker being on maternity leave. Their clerical support person is also on maternity leave. Their newest member is currently completing Pre-Service training and will not be able to begin with a caseload until completion.

Foster Care/Adoptions:

Although the Foster Care/Adoptions Unit is currently fully staffed, their newest member is currently completing Pre-Service training and will not be able to have the responsibility of a caseload until afterwards.

Adult Services:

The Adult Services Unit continues to be fully staffed. The Supervisor recently conducted a refresher for her staff regarding Adult Protective Services processes, procedures, and paperwork. Caseload numbers continue to be higher than average.

Work First Employment:

The Work First Employment Unit appears to be experiencing a smooth transition with its new Supervisor. Interviews have been completed for the vacant position within this Unit and a recommendation has been made for hire.

Child Day Care:

The Child Day Care Unit appears to be experiencing a smooth transition with its new Supervisor. This Unit is working on preparing for new policy changes that will affect fees and eligibility effective October 1. A spreadsheet will be utilized to track how families will be affected by these changes.

Program Integrity:

Program Integrity continues to diligently process fraud cases as it prepares for Energy Assistance season later in the fall. Preparation is currently underway to begin the Crisis Intervention Program in late October. Qualifications for this program are being carefully reviewed and will be strictly enforced. Since these same staff greatly assist with Energy Assistance, their time with Program Integrity will be affected when applications for energy assistance begin. Fortunately, temporary staff along with work experience staff will be utilized to attempt to alleviate some of the load on full-time staff.

News/Updates/Vacancies

<u>Universal Intake, Triage and Processing/Adult Medicaid, Family and Children's Medicaid and</u> Food and Nutrition

The Intake teams continue to struggle with disposing applications. We continue to have 237

overdue Medicaid applications and 50 overdue Food Stamp applications due to staff shortage. We are currently under corrective action with the State from our last monitoring due to applications not being processed timely. We have had On Site support for 2 weeks from the NC FAST team; which was a wonderful help. When workers had applications or recertifications that the system would not take; On Site Support was here to help solve some of the problems with the system. Some issues still had to be forwarded to the help desk. NC FAST currently houses an automated system called Asset Verification System where workers key in a client's social security number and it will search the majority of banks and send back a response to notify us if a client has a bank account and how much is in that account. As soon as all banks are signed up to participate, it will search all banks. This will help prevent some of our fraud referrals. Adult Medicaid has been taking applications in NC FAST for 2 months; they currently have 197 applications in the system. The workers along with the supervisor compiled some times it took to process (taking the application not included) applications; the average time it took to process an Adult Medicaid application was 3 to 3 ½ hours. The system requires a tremendous amount of data to be entered. We currently have three vacancies on the Intake team and 1 applicant has been recommended for hire and we are awaiting the final steps of the hiring procedures.

The Triage team assisted 629 walk-in clients. This team has one vacancy; we have interviewed and are waiting for the final steps of the hiring procedures.

Food and Nutrition/Adult Medicaid/Family and Children's Medicaid/Review Team

The Food and Nutrition Team is still working diligently to try to process as many overdue recertifications as possible. They had 3 vacancies and just hired an experienced worker who was able to go in and take a caseload without any training. We have recommended 2 other applicants for the openings on that team and they are in the final steps of the hiring process. This will leave the team with one open position.

The Adult and Family and Children's Medicaid Review teams continue to "clean up" reports preparing for Hard Launch on November 8th. The Family and Children's review team just received preliminary results from their 2014 Corrective Action Review. Quality Control with the Division of Medical Assistance reviewed 10 cases. All cases were correctly processed; however there were minor errors that had to be corrected. Examples of these errors were workers were not using the original certification period; not verifying gross income; earned income not calculated correctly and not verifying a cash contribution. After verifying everything there was no ineligible cases. Quality Control stated our narratives were easy to follow and records were neat and information was easy to locate. Training has been completed with the review staff from these oversights. There is one vacancy in the Family and Children's review team.

Work First Family Assistance/Cash//Medicaid Transportation & Supportive Services

Work First/Cash workers continue to key all applications in NCFAST and it is a slow process. They are also preparing their review cases for Hard Launch on November 8th.

We remain constantly busy scheduling clients for transportation to their medical providers.

Child Support/Paralegal

Child Support prepared 280 cases for court. They continue to pass all self assessment and incentive goals.

Our paralegal completed 228 Orders and 151 Certificates of Service for Child Support Court and reviewed 64 Orders and 105 Certificates of Service that were completed by the Attorney.

Marriage": Commissioner Ricky Bullard requested Board approval and adoption of the following Resolution in Total <u>Opposition</u> of ruling on <u>"Same-Sex Marriage"</u>.

RESOLUTION in TOTAL OPPOSITION of RULING on "SAME-SEX MARRIAGE"

WHEREAS, in May 2012, the voters of Columbus County and North Carolina voted victoriously to amend the North Carolina Constitution protecting marriage; **and**

WHEREAS, prior to the rulings by Judge Cogburn and Judge Osteen, the word "marriage" meant only a legal union between one (1) man and one (1) women as husband and wife, and the word "spouse" referred only to a person of the opposite sex who is a husband or a wife"; **and**

WHEREAS, on Friday, October 10, 2014, United States District Court Judge Max Cogburn ruled that Article XIV, Section 6 of the North Carolina Constitution (Amendment One), North Carolina General Statute § 51-1, which defines marriage as being between a man and a woman, § 51-1.2, which prohibits recognition of same-sex marriage in other states, and all sources of state law that prohibit same-sex marriage or its recognition are unconstitutional under the Due Process and Equal Protection Clauses of the 14th amendment to the United States Constitution.; and

WHEREAS, on Tuesday, October 14, 2014, United States District Court Judge William Osteen ruled that Article IV, Section 6 of the North Carolina Constitution (Amendment One), North Carolina General Statutes §§ 51-1 and 51-2 are unconstitutional under the Due Process and Equal Protection Clauses of the 14th amendment to the United States Constitution; **and**

WHEREAS, this ruling will have a negative impact on our churches, businesses, charity organizations, government offices, society and our educational process.

NOW, THEREFORE, BE IT RESOLVED that we, the Columbus County Board of Commissioners strongly **opposes** the ruling that Article XIV, Section 6 of the North Carolina Constitution (Amendment One), North Carolina General Statute § 51-1, which defines marriage as being between a man and a woman, § 51-1.2, which prohibits recognition of same-sex marriage in other states, and all sources of state law that prohibit same-sex marriage or its recognition are unconstitutional under the Due Process and Equal Protection Clauses of the 14th amendment to the United States Constitution; **and**

BE IT FURTHER RESOLVED that the Columbus County Board of Commissioners strongly <u>request</u> that this ruling be reviewed and reconsidered to protect the foundation that America was established on; **and**

BE IT FURTHER RESOLVED that the Columbus County Board of Commissioners strongly <u>urge</u> everyone in opposition of this decision to let their voices be heard, and encourages everyone to recognize "Marriage between one (1) man and one (1) woman is the only domestic legal union that shall be valid or recognized in this state. This section does not prohibit a private party from entering into contracts with another private party; nor does this section prohibit courts from adjudicating the rights of private parties pursuant to such contracts".

Chairman Russ opened the floor for comments. The following spoke.

B. **Board of Commissioners:**

1. **Commissioner Byrd:** stated the following:

- A. I have received many requests from the residents in the Buckhead area for the speed limit to be reduced from the existing fifty-five (55) miles per hour to forty-five (45) miles per hour, due to the density of houses, businesses and traffic;
- B. This three (3) mile stretch is from Highway 211 East of the Buckhead Community and goes 2/10 mile past New Hope Church; and
- C. At the Board of Elections, the faucet in the men's restroom needs improvement.

Representative Ken Waddell stated he is working with Gene Burns and Bobbie Lewis with the North Carolina Department of Transportation on reducing the speed limit in the referenced three (3) mile stretch in the Buckhead Community.

2. **Commissioner McDowell:** stated the following:

- A. Commissioner Prevatte and I attended the Public Education Steering Committee Meeting on October 07, 2014, and several issues were discussed:
- B. The obvious concern was Lottery Funds and the money being returned not only to the budget, but allow the money that was taken out to be put back into the education budget;
- C. From Columbus County, we had the pleasure of introducing the thought of having a Statewide Bond Referendum for construction in rural areas that need it, and we had other counties with the same idea;
- D. This will be voted on in January, 2015;
- E. On October 10-11, 2014, I attended the State Board of Directors Meeting, and the financial report was given;
- F. The NCACC was debt free with a \$1.8 million balance;
- G. After lively discussion, it was decided to instruct our Director to return at least one-half million dollars to the counties with a fair distribution;
- H. David Thompson, our Director, resigned and Kevin Leonard will replace him; and

- I. Early voting begins Thursday and I encourage everyone to vote.
- 3. **Vice Chairman Burroughs:** stated the following:
 - A. I attended the General Government Steering Committee Meeting;
 - B. We reviewed over thirty (30) government-related goals, and submitted thirteen (13) to move forward, and these will be voted on in January, 2015; and
 - C. I invite everyone to attend the Yam Festival activities in Tabor City this week.
- 4. **Commissioner Bullard:** stated the following:
 - A. I appreciate Representative Waddell being present tonight, and he has agreed to hand deliver the Resolution that the Board has adopted;
 - B. Mr. Davis, have you found anything about the beaver request from Porter Swamp?;
 - Edward Davis, Soil and Water Conservation Director, replied stating I have not heard anything from Butch, but Josh was at our meeting last Monday night, and he said they are working on getting permission from the landowner.
 - C. We spend \$60,000 for a part-time person to trap beavers in Columbus County, and this is a waste of money; **and**
 - D. At budget time, I am going to ask that we withdraw the \$60,000.
- 5. **Commissioner McKenzie:** stated the following:
 - A. Last Friday, I attended a Health and Human Services Steering Committee Meeting;
 - B. No one likes NC FAST; and
 - C. I would like to state the reason for my vote on the Resolution tonight is due to my belief in upholding the law of the land.
- 6. **Chairman Russ:** stated the following:
 - A. At 12:00 Noon, I attended a Retirement Luncheon at Homehealth for an employee who had been with the county for thirty-eight (38) years;
 - B. I met Dr. Cynthia Taylor who is the County dentist; and
 - C. I was at a place of business and was told that the work for the lights and the radio equipment for the new vehicles for the Sheriff's Department is being done out of the county.

BE IT RESOLVED by the Board of Commissioners for the County of Columbus, North Carolina, as the governing body of the Columbus County Water and Sewer District IV, in Columbus County, North Carolina:

- Section 1. The Board of Commissioners for the County of Columbus, North Carolina, as the governing body of the Columbus County Water and Sewer District IV, in Columbus County, North Carolina (the "District"), has determined and does hereby find, declare and represent:
- (a) That, pursuant to The State and Local Government Revenue Bond Act, as amended (the "Act"), the Board of Commissioners for the County of Columbus, North Carolina, as the governing body of the District (the "Board"), adopted on October 20, 2014 a bond order authorizing the issuance of not exceeding \$1,337,000 water system revenue bonds of the District (the "Initial Bonds") and providing for certain related matters, which order (the "Bond Order") is in force and effect.
- (b) That the Bond Order authorizes the District to issue revenue bond anticipation notes in anticipation of the receipt of the proceeds of the sale of the Initial Bonds.
- (c) That the Board desires to provide for the issuance of the Note (as defined below) in anticipation of the receipt of the proceeds of the sale of a like amount of the Initial Bonds.

- (h) That the Commission approved the issuance and private sale of the Note under the provisions of Article 9 of Chapter 159 of the General Statutes of North Carolina, as amended, at its meeting on October 7, 2014.
- Section 2. In anticipation of the receipt of the proceeds of the sale of a like amount of the Initial Bonds, the issuance and sale, pursuant to the Act and Article 9 of Chapter 159 of the General Statutes of North Carolina, as amended, of an \$1,337,000 revenue bond anticipation note of the District is hereby authorized, which note (the "Note") shall be designated "Water System Revenue Bond Anticipation Note", shall be numbered R 1, shall be dated October 30, 2014, shall mature on October 29, 2015, without option of prior payment, and shall bear interest at the rate of .69% per annum, which interest shall be payable at the maturity of the Note on the basis of a 360-day year, consisting of twelve 30-day months. No interest coupons shall be attached to the Note. Both the principal of and the interest on the Note shall be paid by check mailed to the registered owner of the Note (the "Owner") and shall be payable in any coin or currency of the United States of America which at the time of payment is legal tender for the payment of public and private debts.

The proceeds of the Note shall be deposited to the credit of the Columbus County Water and Sewer District IV Water System Construction Fund (the "Construction Fund") created by Section 4.01 of the Bond Order for the purpose of paying a portion of the cost of the Project, including interest on the Note to its maturity and expenses of issuing the Note in such amounts as shall be determined by the Finance Director (as defined in the Bond Order). Branch Banking and Trust Company is hereby designated as the depositary of the proceeds of the Note to be deposited to the credit of the Construction Fund. The provisions of Article IV of the Bond Order shall apply to the proceeds of the Note deposited to the credit of the Construction Fund and the payment or withdrawal of such proceeds from the Construction Fund insofar as such provisions may be applicable. In addition, the proceeds of the Note deposited to the credit of the Construction Fund for the purpose of paying the interest on the Note shall be applied to such purpose in a timely manner.
- Section 5. The District covenants that it will undertake punctually all steps required to issue and deliver the Initial Bonds in an amount sufficient, together with any other moneys that may be available therefor, to pay the principal of the Note as the same becomes due.
- Section 6. The District covenants that, to the extent permitted by the Constitution and laws of the State of North Carolina, it will comply with the requirements of the Internal Revenue Code of 1986, as amended (the "Code"), and any Treasury Regulations promulgated thereunder relating to the issuance of the Note to the extent necessary so that interest on the Note will not be includable in the gross income of the Owner for purposes of federal income taxation.
- Section 7. The District hereby further finds, declares and represents that (a) it reasonably expects that it, all subordinate entities thereof and all entities which issue obligations on behalf of the District (all within the meaning of Section 265(b)(3)(E) of the Code) will not issue in the aggregate more than \$10,000,000 of tax-exempt obligations (not counting certain current refunding obligations and private-activity bonds except for qualified 501(c)(3) bonds as defined in the Code) during calendar year 2014 and (b) no entity has been or will be formed or availed of to avoid the limits described above. In addition, the District hereby designates the Note as a "qualified tax-exempt obligation" for the purposes of Section 265(b)(3) of the Code.

- Section 8. The actions of the County Manager, the Finance Director and the County Attorney of the County of Columbus, North Carolina (the "County"), in their capacities as officers of the District, in applying to the Commission to approve the Note and sell the Note at private sale are hereby approved, ratified and confirmed, and the award of the Note by the Commission at private sale to the Bank upon the terms set forth in this resolution is hereby approved.
- Section 9. The County Manager, the Finance Director and the County Attorney of the County, in their capacities as officers of the District, and their designees are hereby authorized and directed to take such other actions and to execute and deliver such other documents, certificates, undertakings, agreements or other instruments as may be necessary or appropriate to effectuate the issuance of the Note.
- Section 10. The officers, agents and employees of the District are hereby authorized and directed to do all acts and things required of them by the provisions of the Note and this resolution for the full, punctual and complete performance of the terms, covenants, provisions and agreements therein and herein.
 - Section 11. This resolution shall take effect upon its passage.

Commissioner Prevatte made a motion to approve the Bond Order and the Resolution Providing for the Issuance of an \$1,337,000 Water System Revenue Bond Anticipation Note, seconded by Commissioner Byrd. The motion unanimously passed.
