Chairman Burroughs stated the main purpose of us meeting is the following:

1. To take a look and see what your needs are and to take a look at your capital outlay needs;

## **Agenda Item #5: RECOMMENDED PROCEDURE:**

Chairman Burroughs stated that we would hear comments and input from the members present. The following spoke.

## Commissioner Prevatte: stated the following:

- 1. We all know that we don't allocate everything that is needed because we don't have the funds;
- 2. We need a strategic plan; and
- 3. We are interested in knowing what your long-range plan is and what your plans are for next year.

#### **Commissioner Russ:** stated the following:

- 1. Chairman Burroughs, Commissioner McDowell and myself went to a strategic workshop;
- 2. We had Commissioners, County Managers and Clerks there from the east of I-95 and Outer Banks; and
- 3. We had eleven (11) topics to discuss and the top three (3) topics that we all had on our minds were education, schools, and how do you build these schools.

## Commissioner McDowell: stated the following:

- 1. We did go to the strategic workshop in Wallace;
- 2. We had County Commissioners, County and City Managers and Planning Directors there;
- 3. The theme was that we know what we need, but we can't figure out how do we get it;
- 4. Some counties represented there were re-districting their school districts in lieu of building more schools;
- 5. At our Education Steering Committee Meeting, we are advocating to restore lottery money;
- 6. Wake County is building seventeen (17) schools, and we are having a divide there, and it is an urban to rural division;
- 7. We all realize that we have a problem and we need to decide what we are going to do about it; and
- 8. We are going on April 02, 2015, to Chapel Hill and they are going to give us choices about school funding, and we would like some of your members to attend.

## Commissioner McKenzie: stated the following:

- 1. It is a good idea to get together like this;
- 2. We all know that there is no large amounts of funds;
- 3. When one of us has a problem, it will become a problem for all;
- 4. With new schools, kids tend to do better; and
- 5. It is our responsibility to educate our children the best we can and prepare them for the future years.

# **Commissioner Bullard:** stated the following:

- 1. We had a good meeting with Columbus County Schools; and
- 2. We need to have good relationships with the school boards and work together.

#### Kenny Garland, Superintendent: stated the following:

- 1. This information that is being handed out is basically a summary of what is being requested for year 1, but our power point presentation is our 5-year plan, as well as what our needs are in the present year 2015-2016;
- 2. I want to thank you for allowing us to come to this meeting and present information;
- 3. It is very important that we have a good working relationship; and
- 4. All of our goals is for the betterment of our students.

#### Whiteville City Schools Strategic Plan

Goal 1: Every student in the NC Public School System graduates from high school prepared

for work, further education and citizenship.

**Goal 2:** Every student has a personalized education.

**Goal 3:** Every student, every day has excellent educators.

**Goal 5:** every student is healthy, safe and responsible.

Kenny Garland presented the following Spring 2015 Formal Presentation.

- -Mission Statement "Everyone Committed to the Success of ALL Students".
- **-Vision Statement** "Empowering All Students to Reach Their Maximum Potential for Lifelong Learning and Productive Citizenship".
- **-College and Career Readiness**: Fall 2014, 40 classes successfully completed Spring 2015, 88 classes in progress. Potential Cost Avoidance to families: \$22,547.00, based upon SCC tuition and rate fees.
- **-Career & Technical Education**: offered programs: Agricultural, Business, Early Childhood Development, Culinary Arts, Health Occupations, Automotive Technologies, Construction Technologies. 48 Students qualified for articulated college credit during the Fall 2014 semester.
- -Strategic Planning:
  - -Developed a 12 point strategic plan for continuous improvement; and
  - -K-12 Plan focuses on creating a learning environment which fosters College <u>AND</u> Career Readiness.

## School Year 2015-2016: Capital Outlay and Current Expense:

#### Capital Outlay Request -

- -Last year, Columbus County commissioners approved \$130,997 in funding for Whiteville City School capital outlay needs
- -This year, Whiteville City Schools request an additional \$82,749 in funding for capital outlay needs
- -We anticipate sales tax revenue will be \$436,161 (2% increase)
- -We anticipate NC Education Lottery funds will be \$120,000 (consistent with previous years allocations)

#### Whiteville Primary:

- -Access Control
- -Additional security cameras
- -Miscellaneous safety improvements

#### **Edgewood Elementary:**

- -Miscellaneous safety improvements
- -Security cameras
- -Window repair (small project)

# Central Middle and North Whiteville Academy:

- -8<sup>th</sup> Grade Windows
- -Current: single pane glass, fiberglass bottom
- -Additional cameras

#### Whiteville High School:

Security - more cameras - large campus requires more cameras

# WHS Legion Athletic Facilities:

#### Parking:

- -Major safety issue
- -Approximately 105,000 SF of available parking
- -Maximum of around 350 cars can park now
- -1,200 Average attendance during football season

### **Lease Agreement with Columbus County Schools:**

- -5 Year agreement
- -\$2,000 Annually
- -Whiteville City Schools will improve lighting, parking surface and provide fencing
- -210-250 Additional parking spaces will be added with this lease agreement

#### **Current Expense Request**

- 1. Last Year, Columbus County Commissioners approved \$1,957,770 in funding for Whiteville City Schools current expense needs.
- 2. This year, Whiteville City Schools request an additional \$175,199 in funding for current expense needs.
- 3. Whiteville City Schools will designate \$393,598 out of fund balance to meet current expense needs.

4. We anticipate fines and forfeitures collected by the district to be \$30,000.

## **Primary Focus of Current Expense Request Increase:**

- 1. Five (5) additional teacher assistants for K-1;
- 2. Increased expenses to the charter school appropriation; and
- 3. Increased commitment to at-risk students.

## Agenda Item #6: <u>DISCUSSION</u>:

**Commissioner Prevatte:** In the past, Whiteville City Schools made up approximately 25% of the student population, and the county schools made up approximately 75%, and the charter schools came in and reeked havoc. What percentage of the public schools do go to Whiteville City Schools now?

**Superintendent Garland:** replied stating that next year is showing 2,241, which is 27% of the public school population.

#### **Commissioner McDowell:** stated the following

- 1. I commend you and everyone else on the presentation that was delivered tonight; and
- 2. I would like to know if the roofs have been changed to save money.

**Vice Chairman Bullard:** What is your current Fund Balance? Mr. Garland replied stating it is plus \$1 million.

# Commissioner Prevatte: stated the following:

- 1. What percent is the teachers supplement? Mr. Garland replied stating the certified teachers receive 5% and the non-certified teachers receive  $2\frac{1}{2}\%$ .
- 2. Are you looking into the current facilities?
- 3. We think we should help fund the facility study.

**Commissioner McDowell:** I would like to know what vocational items are being offered? Mr. Garland replied stating at this time, it was Environmental Natural Resources, Bio-Med Tech and Culinary.

**Commissioner McKenzie:** Do you have a plan to hire minority teachers? Mr.Garland replied stating no.

**Vice Chairman Bullard:** The two (2) systems should get together to see where they could save money in what they need to do, especially for the two (2) systems to have a combined study done.

**Commissioner McDowell:** Are the facility grounds land locked or do they have room for growth if it is needed? Mr.Garland replied stating basically all the facilities are presently land locked.

**Carlton Prince:** I would like for one of our members to state the vocational items that Whiteville High School offers in addition to what was listed earlier.

**Anthony Martin:** the vocational items that are being offered at Whiteville High School are as follows: Automotive, Culinary, Health Occupations, Game of Business, Early Childhood, Agriculture, Building and Nursing.
