# COLUMBUS COUNTY BOARD OF COMMISSIONERS BUDGET WORKSHOP

Tuesday, June 02, 2015 5:30 P.M.

The Honorable Columbus County Commissioners met on the above stated date and at the above stated time in the Dempsey B. Herring Courthouse Annex Building, located at 112 West Smith Street, Whiteville, North Carolina, for the purpose of conducting a Budget Workshop.

#### **WORKSHOP CALLED to ORDER:**

At 5:31 P.M., Chairman Burroughs called the Budget Workshop to order. Chairman Burroughs stated he would let William S. Clark, County Manager, tell us about the budget. Bobbie Faircloth, Finance Director, has handed out some revisions about the budget since we released the original budget, as follows:

- 1. We included a paging system for the County which is through EMS, and the estimated cost is about \$150,000. We had \$36,000 that was in a fund that could be used for a pager system, and we lowered that cost to \$114,000;
- 2. We removed the roof on the Library;
- 3. There is \$5,000 for each depot;
- 4. We reduced the amount given back to the Tax-Revaluation Fund by \$5,000;
- 5. We added in the Rope Rescue for consideration for \$10,000;
- 6. We added back the Fund Balance for Cooperative Extension for \$17,000;
- 7. We added in the budget for the Governor's Highway Patrol (Page 37) \$12,707, and that is grant money;
- 8. We decreased the Home Health budget by \$288,851 and that is the deficit that we are projecting;
- 9. We got two (2) new positions for EMS;
- 10. We got one (1) new position for Parks and Recreation;
- 11. We have got a contract part-time worker in Economic Development, a code enforcer;
- 12. We have got \$5,000 for each depot;
- 13. We have got \$10,000 for the Science Museum;
- 14. We have a Fund Balance Appropriation of approximately \$1.9 million;
- 15. We recommended that we pay off the vehicle leases that we have (\$600,000);
- 16. The pager project and the schools came to \$408,000;
- 17. The salary increases come to \$460,000; and
- 18. We had \$250,000 for the Healthcare Reimbursements accounts.

# **CHANGES to BUDGET PRESENTED:**

- 1. Added the cost of the pager project of \$113,997, Page 109
- 2. Removed roof repair for Library of \$40,000, Page 31;
- 3. Added Tabor City Depot Center allocation of \$5,000, Page 108;
- 4. Corrected the amount given to the Tax Revaluation account fund 25 reduced by \$5,000
- 5. Added in the Rope Rescue allocation of \$10,000 for consideration;
- 6. Added back in the fund balance appropriation for Cooperative Extension special program in the amount of \$17,652, Page 55, Page 9;
- 7. Added the budget for GHSP, Pages 36 and 37, and
- 8. Decreased Home Health's budget by \$288,851.

# **QUESTIONS/COMMENTS/DISCUSSION:**

**Commissioner Prevatte:** I think we should go page by page in the budget until we get our questions answered and then we will not have to flip from page to page. Commissioner McDowell has a few questions on the Special Appropriations, Page 108.

## Commissioner McDowell: stated the following:

- 1. On the Veterans Park, I need clarification on the \$25,00;
- 2. On the Forest Service Special Appropriation of \$197,190, I would like to know what this is used for; **and**
- . Mr. Clark replied stating that the County has to fund part of their budget, and this is used for salaries and some capital equipment.
- 3. On education, would it be on this page, and if we make a special appropriation, would it fall into this category?
  - Mr. Clark responded stating that it had not in the past, it is always under education.

**Commissioner McKenzie:** Kimberly Smith, is there any sickle cell in the county. I don't think it has been funded for the last three (3) years.

Kimberly Smith replied stating we do.

**Commissioner Byrd:** The paperwork we have is saying Friends of the NC Museum of Forestry, and it is no longer this.

#### Commissioner McDowell: Page Number: 88 - Education

- 1. Our three (3) education systems have got more problems than they have money;
- 2. At the present time, we have a Fund Balance of \$23 million;
- 3. We need to allocate enough money to each school system to make a difference in their efforts of repairing the schools until a better method is determined; **and**
- 4. I would like to recommend that we allocate \$1 million to the County Schools, \$333,000 to the Whiteville School System and \$333,000 to Southeastern Community College, and this amount will be up and above the suggested allocation.

#### **MOTION:**

Commissioner McDowell made a motion to allocate \$1 million to the County School System, \$333,000 to the Whiteville City School System and \$333,000 to Southeastern Community College, up and above the suggested allocation, seconded by Vice Chairman Bullard.

In-depth discussion was conducted regarding the allocation to be used for capital outlay only, and making use of the money until a more suitable manner could transpire for the betterment of our schools.

#### **AMENDED MOTION:**

Commissioner McDowell made an amended motion to allocate \$1 million to the County School System, \$333,000 to the Whiteville City School System and \$333,000 to Southeastern Community College, up and above the suggested allocation, with stipulations placed on the allocation for capital outlay, seconded by Vice Chairman Bullard. The motion unanimously passed.

## Commissioner Prevatte: stated the following:

- 1. With our school systems, we have from four (4) campuses to seventeen (17) campuses; and
- 2. Eleven (11) years ago, we were down to \$8 million and now we are at twenty-three (23) million.
