Agenda Item #1, #2 and #3: MEETING CALLED to ORDER, INVOCATION and PLEDGE of ALLEGIANCE:

At 6:30 P.M., Chairman Giles E. Byrd called the January 19, 2016 Columbus County Board of Commissioners Regular Session Meeting to order. The invocation was delivered by Commissioner Amon E. McKenzie. Everyone in attendance stood and pledged Allegiance to the Flag of the United States of America which was led by Commissioner Ricky Bullard.

Agenda Item #4: BOARD MINUTES APPROVAL:

Commissioner Russ made a motion to approve the January 04, 2016 Regular Session Board Meeting Minutes, as recorded, seconded by Commissioner McKenzie. The motion unanimously passed.

Agenda Item #5: <u>PUBLIC INPUT</u>:

Chairman Byrd opened the floor for Public Input. No public input was received, either orally or written.

Agenda Item #6: SOCIAL SERVICES - MONTHLY ADMINISTRATIVE UPDATE:

Algernon Mackenzie, Social Services Director, delivered the following Monthly Administrative Update to the Board.

On December 1, 2015, I traveled to Wake Medical Center in Cary, North Carolina to sign consents and meet with the doctors who were going to perform surgery on one of my Adult Wards. This was major surgery, and as his legal guardian, I was required to be there.

On December 8, 2015, I attended the Family Empowerment Self-Sufficiency Board meeting with Southeastern Community and Family Services, Inc., formerly Four County Community Services. We shared information about services offered and changes in agency policy that may affect our citizens.

Also, December 8, 2015, I met with Wilbur Smith of the Columbus County Partnership for Children to sign our 2015-2016 MOU (memorandum of understanding), for our Smart Start funding. We have received \$237,749.00 to serve children 0-5 years of age and will begin spending funds for the current month. This process is completed later than usual due to program changes.

On December 10, 2015, I attended the Director's Executive Board meeting in Raleigh, North Carolina. During this meeting, we received updates from the division staff on the upcoming

implementation of Project 3, which is moving child day care into NCFAST. Day Care workers and providers will have to learn this new way of completing applications and payments. The statewide roll out date for this new system is scheduled for September and October 2016. Staff will have to enter all current records into NCFAST during this time. There will be no automatic conversion of cases. We also learned the General Assembly changed the allocation formula this year, which affected the funding for some counties.

We had a presentation from the North Carolina Adult Day Services Association. We also met Dee Jones, who is the Director of the Division of Health Benefits, which is a new division created by the General Assembly as a part of Medicaid reform.

On December 15, 2015, we held our agency Christmas Luncheon. It was well attended and enjoyed by all. The agency was closed from 12 noon until 2pm.

On December 16, 2015, I met with my Administrative Staff to give them some updates and discuss any concerns they had. Also, on the 16th, I attended the Partnership for Children Board meeting at our local office.

Our agency continues to see an increase in individuals coming in to apply for various services and assistance. We continue to work on our processing deadlines to increase our timeliness, however, it is a struggle with staff being on medical leave and the limitations now put on temporary and contract workers by the USDA.

Vacancies/Updates/News for December 2015

Intake/Investigation/Assessment:

The Intake/Investigation/Assessment Unit continues to be fully staffed with all Social Workers carrying heavier than usual caseloads. The additional Social Worker position has proven to be much needed and valued recently. The Supervisor states his Unit has been "slammed" with multiple referrals. This Unit has been busy with more severe cases involving sexual abuse and physical abuse.

In-Home Services:

The In-Home Services Unit continues to is fully staffed with the return of their clerical support worker who was on maternity leave. The Supervisor continues to assist her staff by making courtesy contacts and other needed contacts, although this is decreasing due to staff being in place. This Unit has seen an increase in the need for court involvement in cases which has increased the number of foster children in custody.

Foster Care/Adoptions:

The Foster Care/Adoptions Unit is fully staffed, although one worker continues to be on limited duty due to medical restrictions. The number of children in foster care is climbing due to the increased need for court involvement in cases currently being worked with in other areas of Child Protective Services. This Unit had a very successful and enjoyable Christmas for the Foster Children which included a Christmas get together along with an abundance of gifts.

Adult Services:

The Adult Services Unit has a position available due to a worker already in the Unit transferring into the vacate position. Previous interviewees are being looked at for possibly filling this position. This Unit assisted the DHSR with the survey and closure of Robin's Nest Family Care

Home located in Columbus County. Placement assistance was provided for four residents.

Work First Employment:

The Work First Employment Unit continues to attempt to work within the NCFast system. Some training, mainly on-line training, and shadowing is becoming available for staff as this Unit prepares to transition into the NCFast system.

Child Day Care:

The Child Day Care Unit will soon begin training as they become one of the next to transition into the NCFast system. Limited training and information and state support continues to be an obstacle for all services that are becoming a part of the system.

Program Integrity:

Program Integrity continues to do limited program integrity work due to working with Energy Assistance. However, they are beginning to work several fraud cases that are part of a larger store disqualification in the county. This will require much paperwork and hearings to cover all of the clients involved.

The Crisis Intervention Program (CIP) 384 applications during the month of December, bringing the total of CIP applications to 1383 and a total of \$327,307.24 CIP funds allocated to county citizens to assist with their heating source.

The Low Income Energy Assistance Program (LIEAP) began December 1st for those households with citizens 60 years of age and older or those households that have a person receiving SSI/SSA/VA and services through the Division of Aging and Adult Services. Columbus County has been allocated \$324,301.00 for LIEAP. Beginning January 1, the remaining funds will be made available to those households that did not apply in December.

Reporting Month: December 2015 News/Updates/Vacancies

<u>Intake and Processing Team for Adult Medicaid, Family and Children's Medicaid and Food and Nutrition:</u>

December was an extremely busy month for Adult Medicaid due to receiving additional applications from open enrollment from the Federal Marketplace and Low Income Subsidy applications. Open enrollment ended for Low Income Subsidy applications on December 7th and the open enrollment for the Marketplace will end January 31st. We had an additional 57 applications due to the both of these open enrollments. Family and Children's Medicaid continues to keep their applications timely. Food and Nutrition continues to be overwhelmed with applications. We continue to have 2 staff members that are out on leave. Clients that are coming in for the CIP and LIEAP programs that do not receive Food and Nutrition benefits are applying while they are here. The review department has helped a great deal with processing the overwhelming number of applications.

Review Team for Adult Medicaid, Family and Children's Medicaid and Food and Nutrition:

Our clients on Social Security, VA and SSI benefits will not be getting a cost of living increase this year. We have 206 clients on the MQB/E program; which is a limited Medicaid program and only pays for their Medicare Part B premium; \$104.00 and \$121.00 monthly. All of these clients has a one-time recertification that comes due every December. We are still having problems with NC FAST for our clients that receive SSI. NC FAST can make updates periodically and this will cause our SSI client's Medicaid to suspend and then workers have to go in and reassess the whole case to get their benefits to resume. In the old system, we did not ever have to touch these cases which is approximately 5,500 cases. Family and Children's Medicaid and Food and Nutrition continue to keep their reviews timely.

Work First Family Assistance/Cash//Medicaid Transportation/Interpreter & Supportive Services:

Workers continue to apply the new rules of drug testing to Work First clients; however we had none to refer for drug testing in December.

Medicaid Transportation remains busy. A work experience participant from Two Hawk is helping this department purge old files; set up new files and gain experience with some other clerical duties. Columbus County Transportation had computer problems for December and was unable to get all their bills to us before we had to send our report to the State Office; so you will see a very low number for reimbursement on the numbers report. Their bills will get calculated in January which in turn will make January look like it had a larger amount than usual.

Faith Aquino, our new agency interpreter was hired on December 7th and is still learning and getting familiar with each program that the agency has.

Housekeeping and maintenance has remained very busy with the added number of clients applying for the energy programs. This is the time of year we have to have "extra" for paper products.

Child Support/Paralegal:

Child Support Court gets very interesting at times when some of the "unusuals" happen. We had four court dates in December, one of them was a push to try to get money for Christmas to the client. We prepared 349 cases for court; this includes establishment and enforcement cases.

Our paralegal completed 203 Orders and reviewed 45 that the attorney prepared.

- Kenwood Corporation is continuing to perform upgrades on the county emergency communications radio system. Technicians have been on site almost every week and when not in the county working, have been working on "behind the scenes programming, etc".

Overall Summary of work left to be performed:

Nakina site – County owned tower site

All other activities at this site are on hold until construction of new tower

Behind the scenes work is being performed on this site by NC Hwy Patrol and Motorola, such as FAA study, FCC coordination, environmental studies completed, tower design and Public Notice has been submitted which takes 4-5 week for advertisement. Once time frame for public notice issued and all other work is completed then installation may begin. Installation may take up to 3 months (concrete has to cure for 30 days).

Remainder Sites

Antennas – Allow radios to talk to the sites Microwave – Gives connectivity to the sites

- All microwave and line work connectivity should be completed within next 2 weeks. Next step will be re-aiming the microwave to each of the correct sites, another 2 weeks. Then new routers/switches will be installed and transition to the new microwave system, another 2 weeks. This should be completed in about 6-8 weeks.
- Reprogramming of all the responder radios takes place.

- Control stations from Chadbourn will be relocated to the 911 center, during the time of the reprogramming of the radios.
- Kenwood technician has been in the county working. Hope to have project completed in the time frame of May/June 2016.

Keep in mind when work is performed at each site it takes a lot of planning and coordination to keep radio communications on the air*

• Emergency Responder radios are being programmed and reprogrammed by our department on a day to day basis.
