Public Comments

Peggy Gerald of 374 Cedar Grove Church Rd Cerro Gordo, NC 28430, asked if their where a minimum number of poll worker that could work at a precinct on election day and could we provide more training for poll workers. The board answered the minimum number people is 4 at a polling location and with the other question they informed her that they would be going over surveys filled out on election day from the judge and that could give her the answer she is looking for.

Doris Strickland of 105 Forest Edge Circle apt 1A Tabor City, NC 28463, wanted to know how many of the board members had worked at a polling place on election day.

Bonnie Inman of 242 Brookside Rd Whiteville, NC 28472, her concern was with having runner on election day and being she is a chief judge and knows that the flashing drive and the tape is a responsibility of the chief judge to know up with she did not feel comfortable giving it to a runner to deliver to BOE on election night while they were closing up precinct and packing up equipment to get back to the BOE. The board explained that they have not voted on anything at this time they were just reviewing possible options.

Surveys from Judges

After reviewing surveys completed by election day judges. Mr. McPherson made a motion for the board to have a workshop meeting for the board member to discuss improvements to make election day go better and staying within the statutes of the law. Mr. Ward seconded, Mrs. Horne, Mrs. Ebron and Mrs. Blakney concurred.

Location change for Williams 1

Mr. Mitchell Cartrette Chairman of Board of Directors at Roseland VFD sent a letter requesting the voting location be moved due to the small space and parking and understanding that Beaverdam OFWB church had agreed to hold voting at their location. Mr. Ward made a motion to move to voting location Mr. McPherson seconded, Mrs. Blakney, Mrs. Ebron and Mrs. Horne concurred.

Director's Report

Interim Director, Ms. Collins reviewed the director's report and informed the board members that there will be a summer conference coming up on August 30 and 31st.

Ms. Collins gave a copy of the budget to all board member that was approved for 2022-2023 year.

Ms. Collins informed the board about the county school board of education and their map of their districts for running candidates as of right now they do not have the district maps drawn up and the attorney for the school board is currently working on this but the next meeting to the board of education is the 17th of July where they will get a draft of the map. Also we spoke with Parker Holland with the state explaining the situation to him he spoke the state attorney that informed him to inform us that anyone that come in for candidacy to let them know that the district maps have not been drawn at this time and that once it was finished that there is an possibility they make have to amend their candidacy if it falls in the wrong district that they applied for.

Also Ms. Collins gave the board a NC petition request for Randy Williams he was wanting to be a write in candidate for county commissioner District 1. The board reviewed request. Mr. Ward

made a motion to accept petition for him being a write in candidate in November election, Mr. McPherson seconded, Mrs. Horne, Mrs. Ebron, and Mrs. Blakney concurred.
