#### Agenda Item #5: Board Agenda Approval

#### Agenda Item #6: Approval of Minutes

#### Agenda Item #7: Public Comments

## Agenda Item #8: Director's Report

This includes The Board of Election, Chadbourn, Cherry Bluff, Tabor City and Ransom.

Mrs. Brooks was cancel due to not living in the district The only way the candidate filing could have been reopened is if Mrs. Brooks lived in District 4 when she started running for candidacy, then moved out of the district. Then she would have been disqualified. However, since she never lived in the district this would not be the reason she was cancelled.
