Ms. Collins also advised that the address for the location was updated on google and county website. Ms. Collins showed the board members the new TV that was brought for the election results to be shown on election night. Ms. Collins brought to the attention of the board members the name tags that poll workers wear during the election that someone made a mistake on one. At that time Mr. McPherson made a motion that the worker wear the name tag fills their own out, Mrs. Horne seconded, Mrs. Ebron and Mrs. Blakney concurred. Ms. Collins notified board members a copy of Numbered Memo 2022-12: Maintaining Order at the Polls. Ms. Collins notified board members on October 27 at 1:00 pm that homeland security will be doing a SAFE Assessment on election office. Ms. Collins gave a copy of all the poll observers that had been sent in.
