Ordered: that G.T. Hargrove be appointed as Constable of Ransom township in place of M. C. Potter who resigned.

Ordered: that D. L. Wright's acres of land be changed from sixty acres to thirty two acres.

Ordered: that bill of Dwight McEwen, court stenographer, for Civil term of court set to begin on May 8th 1933, be disapproved and not paid, the opinion of the Board being that no services were rendered. Court did not convene on said May 8th, or at any time during said week.

Ordered: that G. G. Carmichael be appointed as Tax Supervisor for the season June 1st¹⁹³³ to November 1st¹⁹³³ at a salary of seventy-five dollars per month.

Ordered: that all helpers on tax books be paid a salary of two dollars per day.

Ordered: that the office of Home Demonstration Agent be abolished, to be effective June 30th 1933, both white and colored.

Ordered: that the office of Farm Demonstration Agent be abolished, to be effective June 30th 1933.

Ordered: that I. T. Newton JR. be appointed Welfare Officer to be effective July 1st 1933.

Ordered: that no appropriation be made in 1933 Budget for Fire Protection on account of financial condition of county,

Ordered: that no appropriation be made for school supervisor, either white or colored, out of 1933 Budget.

Ordered: that Dr. W. N. Williams M. D. be appointed Health Officer for Columbus County, to be effective July 1st 1933.

Ordered: that Jackson Greer be appointed County Attorney, to be effective July 1st 1933, at fifty dollars per month.
