Ordered: that a letter be sent to the Senator and Representative that it will be agreeable with the present Board of County Commissioners for two more members to be appointed as County Commissioners.

Ordered: that Dorcas Gore allowance be increased to \$4.00 per month.

Whereas, certain citizens of Columbus County have requested the Board of County Commissioners to recommend the building of a bridge across the Waccamaw River at or near Old Reaves Ferry, in Columbus County;

Whereas, it appears that the said bridge which is desired by said citizens, will benefit the general public and as the road and bridge can be more economically constructed at this point than any where else in this section:

Now, therefore, Be It Resolved by the Board of Commissioners of Columbus County that the State Highway Commission be and it is hereby requested that said bridge and road be added to the State Highway System and maintained; and,

Be it further resolved that a copy of this resolution be sent to the State Highway Commission in Raleigh and a copy recorded on the Minutes of this Board.
