The following business was transacted.

Ordered: that check for \$500.00 from Admx. of J. C. Heyer Estate be accepted and the valuation be reduced to \$5000.00 on said tracts of land in Ransom Township for taxes due from 1929 to 1936 inclusive, and if the \$500.00 does not pay said taxes and cost, the time will be extended until November 1, 1937, if such extension is desired.

On motion of W. M. Stephens, seconded by W. L. Hobbs, it is ordered that the Tax Supervisor appoint two appraisers for each Township for re-valuation of property for taxation.

Ordered: that the Register of Deeds be authorized to charge Waccamaw Bank and Trust Company and the Loris Agricultural Credit Corporation same as he charges Columbus County Agricultural Credit Corporation for recording same papers.

Ordered: that the securities held by the County to protect P. W. A. Funds in Waccamaw Bank and Trust Co. be released as soon as funds are reduced to \$5000.00 or less.

Ordered: that A. M. Gappins Estate Taxes in Chadbourn Township be separated so Mr. Johnson may taxes on one lot.

Ordered: that 21 acres of land in Ransom Township listed in the name of C. J. Creech Estate and Fred Creech be separated so Mr. Woolard may pay taxes due.

Ordered: that B. V. Martin be charged with tax on 10 acres of land in Tatum Township at \$300 for eight years at 1936 tax rate and Mrs. E. K. Brown be refunded tax on \$2400. valuation which she has paid and Mrs. Brown's valuation for 1937 be fixed at \$800.00.

Ordered: that the Luther Gore tract of land be sold to M. Formy-Duval for \$45.00.
