RESOLUTION

Whereas, certain citizens of Columbus County have petitioned the Honorable Board of Commissioners to recommend the re-classification of a certain road in said County by the State Highway & Public Works Commission, said road leading from Route #130 at the point known as the Lewis place, extending by way of Nakina to Reaves Ferry; and,

Whereas, said road is supposedly on the Highway System now but has never been numbered; and,

Whereas, said road is widely used and it is the desire of the entire public that special attention and consideration be given this road, that it be classified and numbered like other Highways maintained by the State Highway Commission:
