

The Honorable Board of County Commissioners met in their said office February 4th, 1935, it being first Monday. Members of the Board present:

Minutes of the last meeting being read and approved, the following business was transacted.

Ordered: that A. M. Hinson be allowed \$2.00 present relief.

Ordered: that S. M. Hardee be allowed \$2.00 present relief.

Ordered: that Strong Lee out door poor voucher be increased \$1.00 per month.

Ordered: that the Register of Deeds be instructed to charge the Whiteville Production Credit Association 75¢ for recording their crop liens and the Clerk of Superior Court be instructed to charge 10¢ for ordering said crop liens recorded.

Ordered: that L. A. Byrd Estate land be sold to Blake D. Applewhite for \$2,100.00, he to pay \$100.00 this date and \$300.00 when deed is delivered, and mortgage and notes to be given for \$1,700.00 to be due and payable \$300.00 on the 15th day of February 1936-1937-1938-1939-1940, and \$200.00 on February 15th 1941, notes to bear interest at 6% per annum, interest payable annually. Timber is not to be moved on said land until \$1,000.00 of purchase price is paid.

Ordered: that Penny Rhodes be allowed \$2.00 present relief.

Ordered: that Arch Hammond be admitted to County Home.

Ordered: that Buck Clewis be allowed \$2.00 present relief.

Ordered: that \$5.00 per week be paid to a sanatorium for treatment of Elmo Lewis, not exceeding six months time, and providing the mother of said Elmo Lewis is taken care of by his brother.

Ordered: that the Co-operative Health vouchers be countersigned.

Ordered: that \$55,000.00 Columbus County Notes now in Wilmington Savings and Trust Company made payable to BEARER at Waccamaw Bank and Trust Company and held by Wilmington Savings and Trust Company placed there by Waccamaw Bank and Trust Company as security for deposits in said Waccamaw Bank and Trust Company be released, and in lieu thereof, renewal note in the sum of \$55,000.00 be placed with said Wilmington Savings and Trust Company in place of the said sum of \$55,000.00 in notes, said note dated December 23, 1934, due March 22, 1935.

Whereas, certain citizens of Tatum Township have petitioned the Honorable Board of County Commissioners to recommend that a certain road in said Township be taken over and maintained by the State Highway Commission; and,

Whereas, said road which it is desired by said citizens that the State Highway Commission take over and maintain is known as the Silver Spoon Road leading from Highway #20 to Wooten's store:

Now, therefore, be it resolved by the Board of County Commissioners of Columbus County that the State Highway Commission take over and maintain said road; and,

Be it further resolved that a copy of this resolution be sent to the State Highway Commission in Raleigh and a copy be recorded on the Minutes of this Board.

Whereas, certain citizens of Chadbourn Township have petitioned the Honorable Board of County Commissioners to recommend that the State Highway Commission take over and maintain a certain road in said Township; and,

Whereas, said road intersects the Peacock public road at V. P. Seller's place North of Beaver Dam Swamp, leads from Ward's Station public road at a point near Tommie Nobles' place near Pine Level School House, a distance of about one mile:

Now, therefore, be it resolved by the Board of County Commissioners that the State Highway Commission take over and maintain said road; and,

Be it further resolved that a copy of this resolution be sent to the State Highway Commission in Raleigh and a copy be recorded on the Minutes of this Board.

Ordered: that Simpson Jernigan's taxes be separated so J. W. Wilson may pay taxes on property heretofore closed.
