Minutes of the last meeting being read and approved, the following business was transacted.

Ordered: that Mr. H. B. Jenrette's taxes due be separated so heirs may pay their part of taxes.

Ordered: that J. I. Williamson be allowed \$1.00 present relief.

Ordered: that Adelaide Green be allowed \$8.00 present relief and \$3.00 per month.

Ordered: that James Lee Cloniger, Boardman, be allowed \$3.00 present relief and \$3.00 per month.

Ordered: that Redman Smith be allowed \$3.00 present relief.

Ordered: that the Tax Collector refund O. F. Lewis in Lees Township, \$3.00 on 1934 court cost.

Ordered: that Henry Suggs, Delco, be allowed \$5.00 present relief and \$3.00 per month.

Ordered: that Mrs. Mary A. Beckwith be allowed to pay 1932, 1933 and 1934 taxes at par and \$3.00 court cost.

Ordered: that Rhody Kirksey's 1935, 1936 and 1937 taxes in Bolton Township be refunded on account of land being sold by Columbus County for back taxes.

Ordered: that Mrs. Nettie Nobles be allowed \$2.00 present relief and \$2.00 for 3 months.

Ordered: that Lucia Duncan, Chadbourn, be allowed \$2.00 present relief and \$2.00 per month.

Ordered: that Ed Brown Estate in Bolton Township be separated so Moses Brown may pay tax on his part which is 3/4 of the tax.

Ordered: that \$25.00 be appropriated for memorial tablet for World War Veterans of Columbus County who died during 1917 and 1918, said tablet to be erected in the hall of the Columbus County Courthouse.

Ordered: that Odis Inman be allowed \$3.00 present relief and \$3.00 per month.

Ordered: that contract be signed with D. N. Blue and Co. for county audit at his bid of \$700.00.

Ordered: that T. S. Memory and wife be allowed to pay \$116.67 cash and make new mortgage in the sum of \$300.00 due and payable \$100.00 each year March 14th, 1939, 1940 and 1941, in palce of mortgage now held by Columbus County given by said Memory as one of Bank of Columbus Bondsmen. The Chairman is authorized to cancel old mortgage when advised by Jackson Greer, Atty. as to title.

Ordered: that Chairman and Clerk sign deed of release for I. C. Jordan property in Chadbourn Township.

Ordered: that S. G. Sarvis be allowed to pay taxes due Columbus County at par and \$3.00 court cost.

Ordered: that J. B. Elliott and Elliott Motor Co. be allowed to pay taxes due at par and no court cost.

#### RESOLUTION

ORDERED: that the following resolution be recorded relative to borrowing TWENTY FIVE THOUSAND (\$25,000.00) DOLLARS for General County purposes, same being renewal note.

Be it ordered by the Board of County Commissioners of Columbus County that one note of the County of Columbus for General County purposes be executed in the sum of TWENTY FIVE THOUSAND (\$25,000.00) DOLLARS, dated April 20th, 1938, maturing July 20th, 1938.

The above note bearing interest at the rate of  $3\frac{1}{4}$  percent per annum, interest payable at maturity; both principal and interest of said note payable of Fair Bluff, N. C. at the Farmers and Merchants Bank to Farmers and Merchants Bank/in Fair Bluff, N. C. in anticipation of 1937 taxes, and that said note be sold or hypothecated and the proceeds thereof turned into the General Fund of said County of Columbus.

Be it further ordered: that the full faith and credit of the County of Columbus be pledged to the punctual payment of the principal and interest of said note at maturity.

On July 20th, 1938, the County of Columbus, for value received, promises to pay to the order of the Farmers and Merchants Bank of Fair Bluff, N. C., the sum of Twenty Five Thousand (\$25,000.00) Dollars with interest from date at  $3\frac{1}{4}$  per-cent per annum.

This note is issued in pursuance of a Resolution duly adopted by the Board of Commissioners of County of Columbus on the 4th day of April, 1938, and duly signed by Chairman and Clerk of said Board as required by law.

It is hereby certified and recited that each and every act, condition, and thing required to be done, to have happened and to be performed precedent to and in the issuance of this note, has been done, has happened, and has been performed in full and strict compliance with the Constitution and laws of the State of North Carolina, and that this note is within every debt and other limit prescribed by law, and the faith and credit of County of Columbus are hereby irrevocably pledged to the punctual payment of the Principal and Interest of this note, according to its terms.

In witness, whereof, the County of Columbus has caused its corporate name to be signed hereto by Chairman, Board of Commissioners, and the Corporate seal to be hereunto affixed and attested by Clerk to Board of Commissioners, this the 4th day of April, 1938.

#### RESOLUTION

Whereas, certain citizens of Cerro Gordo and Fair Bluff townships have petitioned the Honorable Board of County Commissioners to recommend the taking over and maintaining of a certain road in said townships by the State Highway and Public Works Commission; and,

Whereas, said road is described as follows: Beginning at a point half-way between the residence of John Huneycutt and C. W. Harrelson on the Cerro Gordo and Cherry Grove Road and runs Southwest course about three and one-half miles to an intersection of the Fair Bluff and Clarendon Road at the Jesse Hammond farm; and,

Whereas, said road is now in such a deplorable condition that it is impossible for motor vehicles to travel it; and,

Whereas, said road is a school bus route and Church Road:

Now, therefore, be it resolved by the Board of County Commissioners of Columbus County that the State Highway and Public Works Commission be and it is hereby requested to take over and maintain said road; and,

Be it further resolved that a copy of this resolution be sent to the State Highway Commission in Raleigh and a copy be recorded on the minutes of this Board.
