Ordered: that the appropriation of the Sheriff's Department be revised to allow the Sheriff only two full time paid deputies due to the fact that the proposed deputies of the sheriff's department all come from within approximately a seven mile radius of the town of Whiteville, and that the additional paid deputies had heretofore been added for the purpose of giving protection and representation to the various areas of the county and the proposed deputies of the sheriff do not in the opinion of this board give such representation and protection, and that this order shall take effect on the first Monday in December, 1954.
