The following business was transacted:

Ordered: That the Waccamaw Bank and Trust Company, Whiteville, North Carolina be named depository for all school funds and that the First National Bank of Whiteville be named depository for other County Funds .

Ordered: That D. D. Barfield be appointed Township Constable for Chadbourn Township.

Ordered: That the resignation of Jenny Lind Johnson, Asst. Home Dem. Agent be accepted. This is to become effective July 15, 1960.

Ordered: That Betsy Weldon be employed as Asst. Home Dem. Agent effective July 15, 1960. She is to replace Jenny Lind Johnson and will be paid the same salary

Ordered: That Taxes listed in the name of Madeline Shipman, Welches Creek Township be cancelled for the years 1937 and 1939. This was double listed.

Ordered: That Clayton Shipman be given a refund of \$25.40 being interest on Taxes of W. P. Yapp for the years 1929 through 1942 in Bogue Township paid through error as order should have provided for cancellation of this item.
