The following business was transacted:

The chairman was authorized to execute a lease in behalf of the Columbus County Board of Commissioners with Frank Tolar for the Tolar or Harrell Building in the town of Whiteville, according to the terms of the present lease in existence between the Farmers' Cooperative Exchange and Frank Tolar. The new lease is to begin at the termination of the present lease.

Ordered: that a check from the out door poor fund in the amount of \$25.00 be given to James Crumley, nephew of Sandy Marks, to help defray the funeral expense of Sandy Marks.

Ordered: that a check from the out door poor fund in the amount of \$5.72 be made to New Columbus Hotel to reimburse for room and meals furnished a transient welfare recipient.
