Luther C. Rich, commissioner appointed to fill the unexpired term of Commissioner A. O. Burns, was duly sworn in by the Clerk of Court, after which the following business was transacted:

Ordered: that a check in the amount of \$20.00 from the Out Door Poor Fund be given to Leatha McDaniel.

Ordered: that the 1963-1964 Cooperative Health Budget be amended to include certain salary raises as required by the State Merit System.

Ordered: that the General County Budget for the fiscal year 1963-1964 be amended to appropriate \$2,000 out of surplus for the salary of a secretary in the sheriff's department.

S. Preston Douglas, CPA of Lumberton, presented the annual audit report of Columbus County funds for the fiscal year ended June 30, 1963, and it was ordered that this report be accepted as presented. It was further ordered that S. Preston Douglas & Associates be awarded the contract to audit the county funds for the fiscal year 1963-1964 at a rate of \$40.00 per day, said rate to include all expenses.

Ordered: that Carol Watts, South Williams Township, be given a refund of \$48.75 on a \$2500.00 valuation for the year 1962. Through error a \$2500.00 valuation was twice added to his listing.

Ordered: that taxes listed in the name of Carol Watts, South Williams Township, be reduced in valuation by \$2500.00 for the year 1963, and that three lots now valued at \$5260.00 be reduced to \$2760.00 for the year 1964.

Ordered: that taxes listed in the name of Mary E. Adams Heirs, Ransom Township, be cancelled for the years 1950, and 1952 through 1963. This property was listed to Mary E. Adams Heirs, also to Herbert Scull for the above years.

Ordered: that taxes listed in the name of Mrs. W. F. Smith, Chadbourn Township, be cancelled for the year 1963. This tax was on a \$4200.00 lot. Through error, one lot valued at \$3,000.00 was taken off Dr. W. F. Smith Heirs listing and was listed to James McRale Jackson, when the \$4200.00 lot should have been taken off the listing of Mrs. W. F. Smith.

Ordered: that the chairman and clerk be authorized to sign Bond, Interest, and Redemption Fund voucher in the amount of \$2,326.25 to pay the following debt service due September 1, 1963:
