The following business was transacted:

Commissioner L. P. Ward was nominated and duly elected to serve as Chairman of the Board for 1964.

Commissioner W. B. Buffkin was nominated and duly elected to serve as Vice Chairman of the Board for 1964.

Ordered: That all county employees who are presently employed be re-appointed for the year 1964, and that the surety bonds of the various employees be approved as recorded in the office of the Register of Deeds and the Clerk of Court.

Ordered: that a contribution of \$10.00 be made to Caswell Training School, Kinston, N. C. to help defray the cost of a Christmas Party.

Ordered: that all county offices be closed December 24th, 25th, and 26th for the Christmas Holidays; that work be resumed on December 27th, and that a previous order of November 25th regarding Christmas Holidays be rescinded.

Ordered: that the salary of Joe W. Brown, Solicitor of Recorder's Court, be increased in the amount of \$500.00 per year effective December 1, 1963.

Ordered: that \$150.00 be appropriated for the beautification of the Columbus County Library grounds.

Ordered: that the tax collector be given a release of \$4,000 on a valuation of \$5,050 on taxes listed in the name of James Ira Floyd, Chadbourn Township, for the year 1963. This correction is due to an error in listing.

Ordered: that taxes listed in the name of Mrs. E. A. Rambonnet, Chadbourn Township, be reduced in value by \$1,000 for each of the following years: 1961, 1962, and 1963. This was due to an error in listing a house which had burned.

Ordered: that taxes listed in the name of Sinclair Refining Company for the year 1963 be segregated so that Sinclair Refining Company may be permitted to pay tax on a personal property valuation of \$400.00.
