The following business was transacted:

Jerry Nelson of Southern Appraisal Company was present to discuss the revaluation program underway in Columbus County and to answer any questions regarding this program.

The following motion was made by Commissioner Johnson, seconded by Commissioner Gore and unanimously passed:

WHEREAS the farmers of our county are now facing a great economic loss because of already announced cuts in allotments, and because of the uncertainty of value that might be given to any allotment, I therefore move that the \$1,000 valuation heretofore used as appraisal value per acre of tobacco allotment be stricken and not used in the equalization program.

Ordered: that Southern Appraisal Company be employed to correct appraisal cards commensurate to motion heretofore made.

A motion was made by Commissioner Thompson, seconded by Commissioner Rich, and unanimously passed, to set the property valuation for the purpose of tax assessment at 60% of the appraisal or true value, and that Southern Appraisal Company be authorized to transfer values in accordance with said action.

County Attorney Sankey W. Robinson was instructed to draw an appropriate resolution requesting that a Highway Commissioner be appointed from Columbus County for our Highway District.
