Ordered: that Mrs. Howard Singletary and Mrs. Graham Walton be appointed to serve on a voluntary basis as Community Service Consultants until such time as a full time consultant is employed. It was further ordered that they be reimbursed for any expenses incurred in connection with this service.

A delegation from the Tabor City Fire & Rescue Squad appeared before the Board to request permission to use certain obsolete equipment in the possession of the Sheriff's Department. It was ordered that three obsolete radio transceivers now in the possession of Sheriff Ben Duke be given to the Tabor City Rescue Squad, Inc.
